Emergency Medical Services Fire Commission Report – June 1 to June 30, 2019 ADC Sandra Tong

General Activities

- Assist Chief Nicholson with EMS related support information during budget preparation process.
- Extensive work completed by Station 49 personnel, including RC Gordon, PM Palmer, and other TMD members to stock and prepare new ambulances for EMSA inspection and permitting. 15 new Leader ambulances are now operational and in the field.
- Interviews are currently being conducted for the H3L1 EMT Academy, tentatively scheduled for August.
- Meetings with EMSA staff to discuss a more collaborative relationship to achieve common goals to improve the system. There will be meeting in the near future to work on training, research, and quality improvement areas.
- Formed a Station 49 Scheduling Subcommittee to develop a collaborative process to devise an ambulance schedule that meets both the needs of the Department and its members. Station 49 members and RC Gordon met with Jesus Mora and Acting Captain Rob Neuneker and were educated on the current processes used to create a schedule that addresses the system demands and SFFD supply. Although the next schedule to be bid will not change significantly in order to implement it quickly, the goal is that future schedule designs will be researched and vetted through a joint process.

Citywide Heat Emergency

- The Citywide Heat Emergency on June 10th and 11th, taxed the 911 system, especially EMS. The EMSA approved putting BLS ambulances into the system in the early afternoon, and shortly after, ordered an Ambulance Strike Team (5 ambulances and 1 Ambulance Strike Team Leader from out of county) via the Mutual Aid System to assist with high call volume.
- On a normal day, the 911 system averages 350 calls. On that Monday, June 10th, we ran over 500.
- When the Strike Team arrived in the city, they reported to Station 49 where radios were distributed, and crews were given an orientation to radio operations, hospital locations, and other instructions. Capt. Nick Brady did an excellent job briefing the crews.
- There have been a number of after-action discussions on a city wide level which the Department has participated in. Overall, the EMS system was taxed, but the addition of BLS resources and the Strike Team helped address the surge in call volume. Kudos also to the staff at DEC who managed to efficiently distribute the calls based on need and limited resources.

- Assisted with Pride 2019 EAP preparation with ADC Cochrane and Capt Zanoff. Capt.
 Zanoff has graciously agreed to continue to assist with event EAPS, which is a major help since preparing these documents are very detailed and time consuming.
- EMS is currently collecting all the data to determine the call volume and resource usage during the event. Initial reports were that the call volume was a little higher than previous years, but not excessive, and resources were sufficient.

Noteworthy Incidents Since Previous Report

- 06-06-19 Successful rescue of a person trapped underneath a Bart Train at Embarcadero Station.
- 06-10-19 Northbound 280 at San Jose Avenue, mid-day shooting with two people shot. One critical, one stable.
- 06-10-19 14 year-old boy was pulled from the water at Crissy field after about an hour. He was pronounced dead at CPMC Van Ness Medical Center.
- 06-23-19 Hit and run occurred at Third Ave./Paul St. leaving two people deceased and two injured.
- 06-24-19 Vehicle collision at California/Presidio left one person dead and two injured.

EMS6 Target Population:

- Individuals that utilize emergency medical services 4 or more times in a 30 day period
- Individuals that utilize emergency medical services 2 or more times in a 24 hour period
- Individuals that utilize emergency medical services 10 or more times in a 365 day period

Total number of frequent 911 callers that meet reporting criteria: 603 Total number of calls generated from high frequency callers: 1023 To date, there are 1,084 known high frequency callers in the EMS6 database.

Encounters:

- Total number of encounters in operational period: 240
- Average number of encounters per day: 8
- Total number of unique individuals engaged: 92
- Among the total encounters, 214 encounters (89%) were with high frequency callers.
- 10 of the top 10 (100%) callers were seen by EMS6
- 20 of the top 20 (100%) callers were seen by EMS6
- 66 of the top 603 (11%) callers were seen by EMS6
- 73 of 92 (79%) of encountered individuals self-identify as homeless
- 49 of 66 (74%) of encountered high frequency users self-identify as homeless

Challenges:

• The EMS6 team attended 19 various planning meetings, task force and case conferences, as well as participating in HSIP and Tenderloin Outreach Program operations this month. Administrative tasks and meetings continue to increase, stretching resources and time.

Highlights:

- Captain Pang is working with ESO on real time notification of transport of our Whole Person Care (WPC) clients, which should increase our effectiveness.
- EMS6 was recognized by the BOS, Senate, Assembly and SFPD's Crisis Intervention Team (CIT) for our service and dedication, at an SFPD awards ceremony. Captain Chatham accepted the awards on behalf of the team.

Success Stories:

- EMS6 rapidly identified that one of its previous stable, conserved patients was decompensating and resuming using EMS frequently. With help from the Street Medicine Team EMS6 was able to contact the conservator and arrange transport to PES for psychiatric stabilization. He has returned to his home and is now stable again.
- EMS6 has been working closely with a patient that was previously resistant to staying in shelter. HOT obtained a Navigation bed for him and EMS6 was able to connect him to primary care. Patient is now medically stable and EMS6 continues to assist him with his chronic medical conditions. He was recently offered housing and EMS6 has been instrumental in obtaining the necessary documents. He is expected to move into

an SRO in the next few weeks and then will be connected to traditional case management services.
