16	Be it ordained by the People of the City and County of San Francisco:	
17		
18	Section 1. Environmental Findings.	
19	The Planning Department has determined that the actions contemplated in this	
20	ordinance comply with the California Environmental Quality Act (California Public Resources	
21	Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of	
22	Supervisors in File No and is incorporated herein by reference. The Board affirms this	
23	determination.	
24		
25	Section 2. General Background: Repealing and Replacing the Fire Code.	

The State of California adopts a new California Fire Code every three years. The
California Fire Code consists of a model code, the International Fire Code, with amendments
made by various State agencies with jurisdiction over the California Fire Code. The California
Building Standards Commission issues the California Fire Code.

The California Building Standards Commission recently issued the the new California Fire Code (the "2019 California Fire Code"), which is based on the 2018 International Fire Code, and which will go into effect on January 1, 2020. A copy of the 2019 California Fire Code is on file with the Clerk of the Board of Supervisors in File No. ____ and is incorporated herein by reference.

Local jurisdictions are required to enforce the California Fire Code, but may enact more restrictive building standards than those set in the California Fire Code where those more restrictive standards are reasonably necessary due to local conditions caused by climate, geology, or topography. Such local amendments to building standards are not effective until the required findings are locally adopted and sent to the California Building Standards Commission.

As in past three-year code cycles, this ordinance repeals San Francisco's existing Fire Code (the "2016 San Francisco Fire Code") and enacts a new Fire Code (the "2019 San Francisco Fire Code"). The 2016 San Francisco Fire Code incorporated by reference the 2016 California Fire Code (Title 24, California Code of Regulations, Part 9), including appendices adopted by the State. In addition, the 2016 San Francisco Fire Code incorporated by reference, except as expressly deleted, modified, or amended, those portions of the 2015 International Fire Code that were not adopted by the California Building Standards Commission in the 2016 California Fire Code. The 2016 San Francisco Fire Code also included amendments specific to San Francisco, some enacted when the 2016 San Francisco Fire Code was enacted, and some enacted later.

The 2019 San Francisco Fire Code incorporates by reference, except as expressly deleted, modified, or amended herein, the 2019 California Fire Code (Title 24, California Code of Regulations, Part 9), including appendices adopted by the State. In addition, the 2019 San Francisco Fire Code incorporates by reference, except as expressly deleted, modified, or amended herein, those portions of the 2018 International Fire Code that were not adopted by the California Building Standards Commission in the 2019 California Fire Code. The 2019 San Francisco Fire Code also includes amendments specific to San Francisco.

Section 3. Findings Regarding Local Conditions.

The City and County of San Francisco (the "City") is unique among California communities with respect to local climatic, geological, topographical, and other conditions. Among other things, (1) certain buildings/occupancies in San Francisco are at increased risk for earthquake-induced structural failure and consequent fire due to local hazardous microzones, slide areas, and local liquefaction hazards; (2) certain buildings/occupancies in San Francisco are at increased risk of fire due to high density of buildings on very small lots, with many buildings built up to the property lines; (3) the topography of San Francisco has led to development of a high density of buildings on small lots, necessitating special provisions for exiting, fire separation, or fire-resistive construction; (4) many buildings are built on steep hills and narrow streets, requiring special safety considerations; (5) additional fire, structural, and other protection is required due to high building density and crowded occupancy; and (6) the City is experiencing a surge in high-rise and super-high-rise development, requiring special safety considerations. Because of the great density of buildings, occupants, and pedestrians in San Francisco, fires in San Francisco can be especially devastating.

California Health and Safety Code sections 17958 and 17958.5 allow the City to change or modify requirements contained in the provisions published in the California Building

Standards Code, including the California Fire Code, when the City determines that those changes or modifications are reasonably necessary because of local climatic, geological, or topographical conditions. California Health and Safety Code section 17958.7 provides that before making any such changes or modifications, the locality's governing body must make an express finding that such changes or modifications are reasonably necessary because of specified local conditions, and those findings shall be filed with the California Building Standards Commission. A list of the "Standard Findings for San Francisco Fire Code Amendments" and "2019 San Francisco Fire Code Findings," providing a section-by-section statement of the reasons for each deviation from the 2019 California Fire Code, are included in "Exhibit A" to this ordinance, which is on file with the Clerk of the Board of Supervisors in File No. _______, and which is hereby declared to be a part of this ordinance as if set forth fully herein.

Pursuant to the applicable California Health and Safety Code sections, the Board of Supervisors hereby finds and determines that the local climatic, geological, and topographical conditions described above constitute a general summary of the most significant local conditions compelling variance from the California Fire Code. Further, the Board of Supervisors hereby finds and determines that, as set forth in Exhibit A, the proposed variances are reasonably necessary based on these local conditions, and that these conditions justify more restrictive standards applicable to buildings and occupancies in San Francisco.

Section 4. Repeal of 2016 San Francisco Fire Code; Adoption of 2019 San Francisco Fire Code.

(a) The 2016 San Francisco Fire Code is hereby repealed in its entirety. The 2016 San Francisco Fire Code being repealed consists of Ordinance 234-16, as amended by

1	Ordinances 164-17, 174-17, and 192-19. These ordinances are available on the website of
2	the Board of Supervisors, and in Board File Nos. 161082, 170626, 170682, and 190627,
3	respectively.

- (b) The 2016 San Francisco Fire Code is hereby replaced with the 2019 San Francisco Fire Code. The 2019 San Francisco Fire Code incorporates by reference Title 24, California Code of Regulations, Part 9, including appendices adopted by the State (the "2019 California Fire Code"), except as expressly deleted, modified, or amended herein. In addition, the 2019 San Francisco Fire Code incorporates by reference, except as expressly deleted, modified, or amended herein, those portions of the 2018 International Fire Code that were not adopted by the California Building Standards Commission in the California Fire Code, including but not limited to Section 503, Section D105 of Appendix D as amended but not adopted by the California Building Standards Commission, and Appendix I in its entirety.
- (c) The following provisions supplement, modify, amend, or delete specified provisions of the 2019 California Fire Code and the 2018 International Fire Code. The prefix "[For SF]" denotes a 2019 San Francisco Fire Code provision that replaces all or part of a corresponding section from the 2019 California Fire Code or 2018 International Fire Code. Where a 2019 San Francisco Fire Code provision has no analog in the 2019 California Fire Code or 2018 International Fire Code, it does not appear with a "[For SF]" prefix.

1	These regulations shall be known as the 2019 San Francisco Fire Code, may be cited as such,

14	to any person who claims that such breach proximately caused injury.	
15	1.1.8.3. Adoption of New Code.	
16	The Chief of the San Francisco Fire Department (hereinafter "Fire Department" or "SFFD")	
17	shall review all adoptions of the California Fire Code by the California Building Standards	
18	Commission. Within 180 days of publication of such adoptions, the Chief shall recommend to the Board	
19	of Supervisors, through the Fire Commission, more restrictive standards as are reasonably necessary

15	SECTION 104. – GENERAL AUTHORITY AND RESPONSIBILITIES.
16	104.1.1. Administrative Bulletins.
17	The Fire Department is authorized to issue Administrative Bulletins that establish or clarify
18	requirements under this code, provide interpretations of this code, and set policies and procedures of
19	the Bureau of Fire Prevention. These bulletins shall be posted on the Fire Department's website.
20	104.1.2. New Administrative Bulletins; Revisions to Existing Administrative Bulletins.
21	When the fire code official determines that it is appropriate to develop or revise an
22	Administrative Bulletin ("Bulletin"), the Fire Department shall post the proposed new or revised
23	Bulletin on its website for 30 days, and provide notice of that Bulletin to parties who have registered to
24	receive notice on the Department's website. The posting shall include instructions for providing written
25	comments on the proposed Bulletin and notice of a public hearing regarding the proposed Bulletin. The

1	fire code official shall conduct a public hearing on the proposed Bulletin to obtain public comment. The	
2	hearing shall be held after the 30-day posting period. The Fire Commission shall approve any

10	The fire code official is authorized to take photographs during fire investigations as deemed	
11	appropriate by the fire code official.	
12	<u>104.10.3. Reward.</u>	
13	The Mayor is authorized to offer a reward for the arrest and conviction of any person found	
14	guilty of arson or attempted arson according to the California Penal Code.	
15		
16	<u>SECTION 105. – PERMITS.</u>	
17	The following San Francisco Fire Code section replaces the corresponding California Fire

19	105.1.1. [For SF] Permits Required.	
20	Any person who engages in an activity for which an operational permit is required under	
21	Section 105.6 shall obtain the appropriate permit from the fire code official prior to engaging in the

23	under Section 105.7 shall obtain a building permit from the San Francisco Department of Building	
24	Inspection prior to the start of work. Any person applying for a permit shall pay permit fees, as	
25	required by Section 106, and any fees required by other departments as applicable, prior to the	

1	applicable Department issuing the permit. The permit holder shall keep the permit on the premises	
2	designated therein at all times and shall make the permit readily available for inspection by the fire	
3	<u>code official.</u>	
4		
5	The following San Francisco Fire Code section replaces the corresponding California Fire

7	105.1.3. [For SF] Multiple Permits for the Same Location.	
8	When more than one Fire Department permit is required for the same location, the fire code	
9	official may consolidate the permits into a single permit at the time of issuance. The applicant shall pay	
10	a fee for permit consolidation as specified in Section 106.2.1.	
11		
12	The following San Francisco Fire Code section replaces the corresponding International Fire	
13	Code section:	
14	105.2.3. [For SF] Time Limitation of Application.	
15	The fire code official is authorized to cancel a permit application when the applicant fails to	
16	make corrections or to provide additional information required by the fire code official within 180 days	
17	after filing the application.	
18		
19	105.2.5. Hearing for Certain Permits.	
20	Certain permit applications are subject to hearings in accordance with San Francisco Business	
21	and Tax Regulation Code, Article 1, Section 22.	
22		
23	The following San Francisco Fire Code section replaces the corresponding International Fire	
24	Code section:	
25	105.3.1. [For SF] Expiration.	

1	An operational permit shall remain in effect until re-issued, renewed, or revoked, or for such a
2	period of time as specified in the permit. Construction permits shall be administered through the San
3	Francisco building permit process in accordance with the San Francisco Building Code. Permits are
4	not transferable, and a new permit is required for any change in occupancy, operation, tenancy, or
5	ownership.
6	
7	<u>105.3.9. License.</u>
8	When San Francisco Business and Tax Regulation Code, Article 1, Section 23, requires a
9	license in conjunction with the issuance of a permit, the fire code official shall forward an approved
10	permit to the Tax Collector for issuance.

4	105.6.23. [For SF] Hot Work Operations.
5	An operational permit is required for hot work including, but not limited to:
6	1. Public exhibitions and demonstrations where hot work is conducted.

8	Exception: Work that is conducted under a construction permit.
9	3. Fixed-site hot work equipment such as welding booths.
10	4. Hot work conducted within a wildfire risk area.

13	6. When approved, the fire code official shall issue a permit to carry out a hot work program.

8	\$130 for each hour. The Fire Department shall not issue a permit until the fees are paid.

10	The fee for consolidation of operational permits is \$95.00 for each activity added to the original

17	Permit fees for vendors at street fairs involving temporary street closures are set in the San

19	106.3. [For SF] Construction Permit Fees.
20	The Central Permit Bureau at the Department of Building Inspection collects construction
21	permit (building permit) fees in accordance with the San Francisco Building Code. When the Fire
22	Department conducts plan review for buildings or portions of buildings under its authority, the
23	Department will assess plan review fees in accordance with Section 106.4. When the Fire Department
24	conducts inspections for buildings or portions of buildings under its authority, the Department will
25	assess inspection fees in accordance with Section 106.5.

1	106.4. [For SF] Plan Review Fees.
2	Upon application for a permit for t

Upon application for a permit for the erection of a new building or for alteration work for which plans are required by the Department of Building Inspection, the Central Permit Bureau shall charge and collect a fee to compensate the Fire Department for its costs of reviewing plans submitted with building permit applications for compliance with fire safety regulations. The fee shall be based on the valuation of the work as determined by the Department of Building Inspection. The fee for each permit is set in Table 106-B. The Fire Department shall assess a fee in the amount of \$130 per hour to review revisions to any previously approved plans. The Central Permit Bureau shall collect the fee before issuing the permit.

106.5. [For SF] Field Inspection Fees.

When the Fire Department determines a field inspection is required to verify that building construction is in compliance with fire safety regulations and this code, it shall notate the application accordingly to provide notice to the Central Permit Bureau. The Central Permit Bureau shall collect the inspection fee due, before issuing a building permit. The fee for each permit is set in Table 106-C.

Initial field inspection fees will be charged for inspections of new fire alarm, sprinkler, and gaseous suppression systems per the notation in Table 106-C.

After building permit issuance, when the fire code official notifies the applicant that additional inspection time is required over the amount of time set in Table 106-C, the applicant shall purchase additional inspection time before the inspector schedules additional inspections. The Fire Department shall collect a fee of \$130 per hour for the cost of providing the inspection service.

106.6. [For SF] Pre-Application Plan Review.

When an applicant wishes to discuss specific design issues or submit preliminary designs for review and comment by the Fire Department before the applicant submits a formal application for permit, the Fire Department shall assess a fee of \$390. This fee provides the applicant with up to three hours for research and meeting with Fire Department personnel. When the time spent by the Fire

1	Department exceeds three hours, the Department shall assess additional fees at the rate of \$130 per
2	<u>hour.</u>
3	106.7. [For SF] Re-Inspection of Violation Fees.
4	If the fire code official issues a notice of violation under this code, the notice of violation may
5	set a period of time that is reasonable to remedy the violation, and the fire code official may re-inspect
6	the property to verify that the person responsible has made the required correction. The Fire
7	Department shall collect a fee in the amount of \$260 for re-inspections. If the time required for the re-
8	inspection exceeds one hour, the Fire Department shall assess an additional fee at the rate of \$130 per
9	<u>hour.</u>
10	106.8. [For SF] High-Rise Inspection Fees.
11	For inspections of high-rise structures pursuant to Section 13217 of the California Health and
12	Safety Code, the owner of the structure shall pay a fee to cover the Fire Department's costs of
13	inspection. The Department shall calculate the fee on the basis of \$13.50 per 1000 square feet of gross
14	<u>floor area.</u>
15	106.8.1. [For SF] Gross Floor Area.
16	For purposes of this section, the term "gross floor area" is defined as the entire area of each
17	floor, attic, basement or shaft of a building included within the exterior walls of a building, including
18	any portion not included within the exterior walls that is under the horizontal projection of the roof or
19	floor above.
20	106.9. [For SF] Referral Fees.
21	If a government agency requests a preliminary site inspection or survey of a premise for
22	compliance with this code or other regulatory codes enforced by the Fire Department, the Fire
23	Department shall collect a service fee of \$130 per hour for the on-site inspections and consultations.
24	When the referral inspection is requested by another San Francisco agency, the requesting agency
25	shall transfer the fee to the Fire Department through electronic transfer. The requesting agency shall

1	pay the fee before scheduling the inspection or consultation. Fees referenced in the California Health
2	and Safety Code take precedence over this fee.
3	106.10. [For SF] Overtime Fee.
4	If a person requests an inspection or other service that requires the assigned Fire Department
5	employee to work outside of the employee's normal working schedule, the Department will charge an
6	overtime fee of \$143.00 per hour. The person requesting the services shall pay the fee before the
7	inspection or other service is performed. The minimum compensation is four hours.
8	106.11. [For SF] Collection of Other Fees.
9	The fire code official may collect fees as required by other portions of the San Francisco
10	Municipal Code for services by other City departments pertinent to the issuance of permits required by
11	this code.
12	106.12. [For SF] Water Flow Request Fee.
13	Upon a request from a person for water flow information, the Department will charge a water
14	flow fee of \$130. If the information requested requires that Fire Department employees perform an on-
15	site water flow test, the Department will charge a fee of \$250.

17	The Fire Department shall charge a service fee of \$250 for each false fire alarm to which the

15	valves, outlets and related equipment designed to provide water at specified pressures and installed

17	Class I is a standpipe system equipped with 3-inch (76.2 mm) outlets.
18	Class II is a standpipe system directly connected to a water supply and equipped with 1½-inch
19	(38.1 mm) outlets and hose.
20	Class III is a standpipe system directly connected to a water supply and equipped with 3- inch
21	(76.2 mm) outlets or 3-inch (76.2 mm) and 1½-inch (38.1 mm) outlets when a 1½-inch (38.1 mm) hose
22	is required. Hose connections for Class III systems may be made through 3-inch (76.2 mm) hose valves
23	with easily removable 3-inch by 10-inch (76.2 mm by 38.1 mm) reducers.

25	CHAPTER 3. – GENERAL PRECAUTIONS AGAINST FIRE.

1	<u>SECTION 308. – OPEN FLAMES.</u>
2	The following San Francisco Fire Code section replaces the corresponding International Fire
3	Code section:
4	308.1.3. [For SF] Torches for Removing Paint.
5	The use of torches or other flame-producing devices to remove paint is prohibited.
6	
7	The following San Francisco Fire Code section replaces the corresponding International Fire
8	Code section:
9	308.1.6.2. [For SF] Portable Fueled Open-Flame Devices.
10	Portable open-flame devices fueled by flammable or combustible gases or liquids shall be
11	enclosed or installed in such a manner as to prevent the flame from contacting combustible material.
12	Exceptions:
13	1. LP-gas-fueled devices used for sweating pipe joints in accordance with Chapter 61.
14	2. Hot work and cutting and welding operations in accordance with Chapter 35.
15	3. Candles and open-flame decorative devices in accordance with Section 308.3.
16	
17	Section 308.2 of the International Fire Code is deleted.
18	
19	SECTION 316. – HAZARDS TO FIREFIGHTERS.
20	316.3.1. Barbed or Razor Wire.
21	Barbed or razor wire shall not be on or attached to any fire escape, dry standpipe or other fire
22	extinguishing facility, fence, parapet, roof surface, or any other place on a building or structure where
23	it might hinder or obstruct firefighters in performing their duties. Where barbed or razor wire is on or
24	attached to any location, structure or surface specified in this section, it shall be removed.

1	Exception: Barbed or razor wire may be installed on fences provided it does not obstruct or
2	hinder egress, rescue operations, or access to hazardous areas, as determined by the fire code official,
3	in the event of fire or other emergency.
4	316.7. Signage for Buildings with Certain Types of Construction.
5	If a building has roofs or floors of composite wood joist or truss construction, the owner shall
6	post a sign specifying this type of construction. The sign shall be located adjacent to the main entrance
7	door or in a location(s) as required by the fire code official. The sign shall comply with San Francisco
8	Fire Department Administrative Bulletin 5.05.
9	
10	CHAPTER 4. – EMERGENCY PLANNING AND PREPAREDNESS.
11	SECTION 403.
12	Sections 403.1 through 403.11 of the International Fire Code and California Fire Code are
13	<u>deleted.</u>
14	
15	SECTION 404.
16	Sections 404.1 through 404.4.1 of the International Fire Code and California Fire Code are
17	<u>deleted.</u>
18	
19	The following three San Francisco sections replace the corresponding International Fire Code
20	sections:
21	404.1. [For SF] State of California Requirements.
22	Emergency plans and preparedness shall be provided in accordance with Title 19, California
23	Code of Regulations, and California Health and Safety Code, Section 13220.
24	404.2. [For SF] Fire Safety Director.
25	

1	Owners of buildings having floors used for human occupancy located more than 75 feet above
2	the lowest level of Fire Department access are responsible to provide or employ a fire safety director.
3	The fire safety director shall possess a current and valid certificate of completion of an approved fire
4	safety director training program. A certificate of completion shall be valid for not more than five years
5	404.3. [For SF] Emergency Procedures Information.
6	Emergency procedures information required by the California Code of Regulations, Title 19,
7	Section 3.09, shall comply with San Francisco Fire Department Administrative Bulletin 2.11.
8	
9	SECTION 405. – [DELETED].
10	Section 405 of the International Fire Code is deleted.
11	
12	SECTION 406. – [DELETED].
13	Section 406 of the International Fire Code is deleted.
14	
15	SECTION 408. – [RESERVED].
16	Section 408 is not found in either the California Fire Code or the International Fire Code.
17	
18	SECTION 409. – FIRE SAFETY INFORMATION DISCLOSURE.
19	<u>409.1. Purpose.</u>
20	It is the purpose of Section 409 to reduce the risk of fires to residents by requiring owners of
21	buildings with three or more dwelling units to disclose fire safety information to new residents on or
22	before they begin to live in the building and once a year thereafter.
23	409.2. Disclosure Requirements.
24	(a) The following information (the "Disclosure Information") shall be disclosed in writing to
25	each resident of an Apartment House as defined in the Housing Code:

1	1. The location of all fire extinguishers on the resident's floor, and the dates of last
2	servicing;
3	2. The location of all emergency exits on the resident's floor, and a statement that
4	they must remain unobstructed;
5	3. The location of all fire escapes on the resident's floor (if applicable), and the
6	dates of last inspection;
7	4. The location of the building fire alarm control panel and all manual pull stations
8	on the resident's floor (if applicable);
9	5. The date when the building fire alarm system was last inspected and tested as
10	required by Section 907.8.5 of this Code, and confirmation that the building fire alarm
11	system is UL certificated under Section 907.7.4 of this Code, if applicable;
12	6. Instructions on how to confirm that the smoke alarms are in working condition,
13	and a statement of when the smoke alarms were last replaced;
14	7. Instructions on how to confirm that the carbon monoxide detectors are in
15	working condition, and a statement of when the carbon monoxide detectors were last
16	replaced; and
17	8. The phone number of the appropriate contact within the Fire Department for
18	reporting suspected violations of Section 409.
19	9. Instructions and website link to access the fire safety training video that the Fire
20	department shall post and maintain on the Internet; and
21	10. Instructions in English, Spanish, Chinese, and Filipino directing persons who
22	wish to view general fire safety guidance in any of these languages to do so on the Fire
23	Department's official website and providing a link to this website. The Fire Department
24	shall post such general fire safety guidance on its official website not only in English but
25	also in Spanish, Chinese, and Filipino. Further, to assist owners with providing the

1	required instruction in their Disclosure Information, the Fire Department shall post on
2	its website sample instructions in Spanish, Chinese, and Filipino, that owners may copy
3	and include in their Disclosure Information.
4	The Disclosure Information may also include any other information that would assist a resident
5	to escape or prevent a fire in the building.
6	(b) The owner of the Apartment House or the owner's agent shall provide an oral explanation
7	of the Disclosure Information to new residents before the new residents commence occupancy in the
8	building, a written copy of the Disclosure Information to new residents on or before the commencement
9	of occupancy, and a written copy, updated as appropriate, to all building residents on or before
10	January 31 of each year.
11	(c) The owner of the Apartment House shall maintain a record of its compliance with this
12	Section 409.2 by retaining a copy of the Disclosure Information for at least two years. An owner's
13	failure to maintain such records shall create a rebuttable presumption that the owner has violated this
14	<u>Section 409.2.</u>
15	409.3. Posting Requirements.
16	(a) A sign or sticker shall be affixed at the main point of entry to the Apartment House, or at
17	such other location that the Fire Marshal approves in writing, that contains the phone number of the
18	owner, property manager, or other person who can give the Fire Department or other building
19	inspector prompt access to the building to conduct safety inspections.
20	(b) The Department of Building Inspection shall enforce this Section 409.3 pursuant to periodic
21	health and safety inspections required by code.
22	409.4. Printing Requirements.
23	The Disclosure Information [Section 409.2] shall be provided in writing. If provided in hard
24	copy, it shall be printed on white paper, 8.5" x 11" (216mm x 279mm), or larger, in no smaller that 10-
25	point font.

1	409.5. Penalties and Enforcement.
2	The Chief of the Fire Department (which includes, for purposes of this Section 409.5, the
3	Chief's designee) shall be responsible for enforcement of the provisions of Section 409.
4	(a) The Fire Chief shall issue a written notice of violation to an owner the Chief determines is
5	in violation of Section 409. Violators shall have 30 days from the date of such warnings to correct
6	violation(s).
7	(b) Where a violation has not been corrected after 30 days from the date of issuance of a
8	warning, the Fire Chief may assess and collect administrative penalties from the owner for any
9	violation of Section 409 in accordance with Administrative Code Chapter 100, "Procedures Governing
10	the Imposition of Administrative Fines," as may be amended from time to time. Chapter 100, which is
11	incorporated herein in its entirety, shall govern the amount of fees and the procedures for imposition,
12	enforcement, collection, and administrative review of administrative citations. Each violation of a
13	provision of Section 409 shall constitute a separate violation for purposes of Chapter 100.
14	
15	CHAPTER 5. – FIRE SERVICE FEATURES.
16	SECTION 503. – FIRE APPARATUS ACCESS ROADS.
17	Section 503 of the International Fire Code is adopted.
18	
19	SECTION 504. – ACCESS TO BUILDING OPENINGS AND ROOFS.
20	504.2.1. Breakable Window Marking.
21	Red reflectors shall be installed to indicate the location of existing breakable, tempered glass
22	windows required under previous codes. Reflectors inside buildings shall be at least 1½ inches (381
23	mm) in the least dimension. They shall be on the glass and within 6 inches (1524 mm) of a lower corner
24	of the pane. Reflectors outside buildings shall be at least 3 inches (762 mm) in the least dimension.

1	They shall be placed on the wall below the lowest window in each vertical line of windows containing
2	tempered glass. A 24-inch (609 mm) clear space shall be maintained around the reflectors.
3	504.3.1. Access to Roofs with Doors and Hatches.
4	Doors and hatches to a roof must be able to be opened from the inside without the use of a key,
5	<u>code or any special knowledge.</u>
6	Exceptions:
7	1. Doors that can be unlocked upon a signal from a central control station or other unlocking
8	system approved by the fire code official. Upon failure of electrical power, the locking mechanisms
9	shall retract to the unlocked position.
10	2. Doors may be locked when approved by the fire code official.
11	504.5. Identification on Steel Doors.
12	When rolling steel shutters or similar steel doors are located on any building or structure and
13	there is no easily accessible opening giving access to the building or structure within 25 feet (7620 mm
14	of the shutter or door, an approved marking shall be affixed on the shutter or door designating or
15	outlining an area which, when removed by burning or cutting, will give access to locking devices,
16	hoisting chains or other devices that control the operation of the shutter or door.
17	
18	SECTION 506. – KEY BOXES.
19	506.2.1. Key Box Installation and Maintenance.
20	Key boxes shall be installed and maintained in accordance with San Francisco Fire Departmen
21	Administrative Bulletin 5.09.
22	
23	SECTION 507. – FIRE PROTECTION WATER SUPPLIES.
24	The following San Francisco Fire Code section replaces the corresponding California Fire
25	Code section:

1	507.4. [For SF] Water Flow and Supply Information.
2	The Fire Department will provide water flow and supply information when requested by the
3	applicant. The Department shall assess fees for this service as stated in Section 106.12.
4	
5	507.5.3.1. Clear space around underground emergency water supply tanks.
6	A 5-foot (1524 mm) clear space shall be maintained around the circumference of cistern
7	openings, except as otherwise required or approved. Access openings shall be on the same surface leve
8	of cistern.
9	
10	The following San Francisco Fire Code section replaces the corresponding California Fire
11	Code section:
12	507.5.5. [For SF] Clear space around hydrants
13	A 5-foot (1524 mm) clear space shall be maintained around the circumference of fire hydrants,
14	except as otherwise required or approved.
15	
16	507.6. Other Water Supplies.
17	Water tanks or pools within, on or about any building premises shall be connected with
18	approved 6-inch (152 mm) pipe leading from the bottom of the tank to a point designated by the fire
19	code official. Piping for tanks located at or below grade shall be designed and installed for drafting by
20	Fire Department apparatus.
21	Exceptions:
22	1. Industrial process water tanks.
23	2. Tanks or pools with a capacity of less than 75,000 gallons (94.6 m3).
24	3. Tanks or pools used to supply automatic fire sprinkler systems.
25	4. Water tanks or pools installed in R3 Occupancies.

1	507.7. Auxiliary Water Supply System.
2	The requirements for the installation and modification of the Auxiliary Water Supply System
3	shall comply with the San Francisco Subdivision Code and any requirements of the San Francisco
4	Public Utilities Commission.
5	
6	SECTION 508. – FIRE COMMAND CENTER.
7	The following San Francisco Fire Code section replaces the corresponding California Fire
8	Code section:
9	508.1.2. [For SF] Separation.
10	The fire command center shall be separated from the remainder of the building by not less than
11	a 2-hour fire barrier constructed in accordance with Section 707 of the California Building Code or
12	horizontal assembly constructed in accordance with Section 711 of the California Building Code, or
13	both.
14	
15	508.1.6.1. Local Additional Features.
16	The fire command center shall contain the following additional features:
17	1. The stock of spare sprinklers required by NFPA 13 (2016).
18	2. Permanent signage with the name and telephone number of the applicable elevator service
19	<u>company.</u>
20	3. Building contact phone numbers.
21	4. Utility shut-off location map.
22	5. Public address system instructions.
23	6. Smoke control system procedures.
24	7. Sprinkler shut-off valve and standpipe isolation valve locations.
25	

1	8. Emergency evacuation/relocation procedures, location of tenant areas of refuge, and
2	location of any tenants requiring evacuation assistance.
3	9. Hazardous materials inventory statement and management plan, when required by the fire
4	<u>code official.</u>
5	10. Approved fire alarm operational matrix.
6	508.1.8. Water Protection
7	The fire command center shall have watertight construction to prevent water intrusion from fire
8	sprinkler discharge and/or firefighting water on floors above the fire command center.
9	
10	SECTION 510. – EMERGENCY RESPONDER RADIO COVERAGE.
11	510.1.1. Local Standard for Emergency Responder Radio Coverage.
12	The applicable standard for the design, installation, testing, maintenance and use of Emergency
13	Responders Radio Converge systems shall be NFPA 1221-2016 Sections 5.10 and 9.6 and SFFD
14	Administrative Bulletin 2.01.
15	
16	SECTION 511. – LOCAL FIRE SAFETY FEATURE REQUIREMENTS.
17	511.1. Local Standards for High-Rise Buildings and Tunnels.
18	Except as stated in the next paragraph, an approved air replenishment system shall be installed
19	in all buildings having floors used for human occupancy located more than 75 feet (22 860 mm) above
20	the lowest level of Fire Department vehicle access. This requirement shall apply for all buildings
21	meeting this definition when the building permit application for construction was made after March 30,
22	<u>2004.</u>
23	Exception: All buildings that are covered by this section but that are equipped with a fire
24	service access elevator (FSAE) pursuant to California Building Code Section 3007 are not required to
25	install an air replenishment system.

1	The air replenishment system will provide a means for firefighters to refill air bottles for self-
2	contained breathing apparatus (SCBA) through a permanently installed piping distribution system. The
3	system shall be tested and maintained in accordance with San Francisco Fire Department
4	Administrative Bulletin 5.07.
5	The air replenishment system may be installed in all new underground transportation or
6	pedestrian tunnels exceeding 300 feet (91 440 mm).
7	
8	CHAPTER 6. – BUILDING SERVICES AND SYSTEMS.
9	SECTION 606. – ELEVATOR RECALL AND MAINTENANCE.
10	606.9. Maintenance of Elevators.
11	At least one passenger elevator shall be maintained in working order and accessible for
12	immediate use by the Fire Department at all times.
13	
14	CHAPTER 9. – FIRE-PROTECTION SYSTEMS.
15	SECTION 901. – GENERAL.
16	901.8.3. Subsurface Construction.
17	Any person performing any subsurface work in close proximity or adjacent to any valve, gate,
18	hydrant, main, street cistern, or other part of the auxiliary water supply system (high pressure system),
19	any hydrant, hydrant piping, or hydrant gate valve connected to the mains of the San Francisco Water
20	Department shall comply with all Fire Department regulations and specifications, which are on file
21	with the Department of Public Works Bureau of Engineering.
22	
23	<u>SECTION 902. – DEFINITIONS.</u>
24	The following definition shall be added to Section 902.1 of the California Fire Code:
25	

1	[For SF] CERTIFICATED FIRE ALARM SYSTEM is a fire alarm system for which a serially
2	numbered certificate has been issued to the property owner by an organization that is part of the
3	Occupational Safety and Health Administration Nationally Recognized Testing Laboratory Program.
4	The certificate is a tool for assuring the reliability of fire alarm systems and is the alarm company's
5	declaration that the system will be installed, maintained, tested and monitored in accordance with the
6	applicable codes and standards. San Francisco Fire Department Administrative Bulletin 3.03 contains
7	details of the fire alarm certification program.
8	
9	SECTION 903. – AUTOMATIC SPRINKLER SYSTEMS.
10	Table 903.2.11.6. Add a new line to the Table as follows:
11	
12	TABLE 903.2.11.6. – ADDITIONAL REQUIRED FIRE SUPPRESSION SYSTEMS
13	<u>SECTION SUBJECT</u>
14	3202.3.4 Pedestrian Walkways over Public Streets
15	
16	903.3.6.1. Fire Department Hose Connection Type.
17	Fire Department Connections (FDC) shall have 3-inch national standard hose threads.
18	903.3.10. Installation Personnel Qualifications.
19	Contractors and personnel installing life safety equipment in San Francisco including, but not
20	limited to, sprinkler systems, standpipes, and other automatic extinguishing systems must possess a
21	valid current C-16 (fire protection) contractor license issued by the California Contractors State
22	License Board (CA-CSLB). The SFFD does not approve or accept work of the types listed above
23	conducted by persons or companies known not to hold the required license. Employees of companies
24	hired to work on these life safety systems are also required to maintain a valid current Fire Sprinkler
25	

1	Fitter Certificate (sprinkler/standpipes) issued by the CA Office of the State Fire Marshal (CAL-
2	<u>OSFM).</u>
3	903.5.1. Testing, and Maintenance Personnel Qualifications.
4	Contractors and personnel testing, maintaining, or repairing life safety equipment in San
5	Francisco, including, but not limited to, sprinkler systems, standpipes, or other automatic extinguishing
6	systems, must possess a valid current C-16 (fire protection) contractor license issued by the California
7	Contractors State License Board (CA-CSLB). The SFFD does not approve or accept work of the types
8	listed above conducted by persons or companies known not to hold the required license. Employees of
9	companies hired to work on these life safety systems are also required to maintain a valid current Fire
10	Sprinkler Fitter Certificate (sprinkler/standpipes) issued by the CA Office of the State Fire Marshal
11	(CAL-OSFM).
12	
13	SECTION 904. – ALTERNATIVE AUTOMATIC FIRE-EXTINGUISHING SYSTEMS.
14	The following San Francisco Fire Code section replaces the corresponding California Fire
15	Code section:
16	904.12.5.2. [For SF] Extinguishing System Service.
17	Automatic fire-extinguishing systems shall be serviced at least every 6 months and after
18	activation of the system. Inspection shall be by qualified individuals per Section 903.5.1, and the owner
19	shall maintain the certificate of inspection on site for at least 1 year following the inspection.
20	
21	<u>SECTION 905. – STANDPIPE SYSTEMS.</u>
22	905.2.1. Local Installation Standard.
23	Standpipe systems shall be installed using 3-inch (76.2 mm) national standard hose thread.
24	Each standpipe outlet shall be placed to provide a minimum of six inches on all sides of the handle and
25	18 inches on all sides of the outlet or located as approved by the fire code official.

2	The following San Francisco Fire Code section replaces the corresponding California Fire
3	Code section:
4	905.3.4. [For SF] Stages.
5	Stages greater than 1,000 square feet in area (93 m2) shall be equipped with a Class III wet
6	standpipe system with 1-1/2-inch and 3-inch (38 mm and 76.2 mm) hose connections on each side of
7	the stage.
8	
9	905.3.12. Buildings with Limited Fire Department Access.
10	Horizontal and/or vertical Class I standpipes shall be installed and maintained in any building.
11	regardless of height, in which, in the opinion of the fire code official, standpipes are necessary to make
12	hose connections available to firefighters.
13	
14	The following part of the San Francisco Fire Code section replaces the corresponding part of
15	the California Fire Code section:
16	905.4. [For SF] Location of Class I Standpipe Hose Connections.
17	1. In every required stairway, a hose connection shall be provided for each story above or
18	below grade. Hose connections shall be located at an intermediate landing between stories, unless
19	otherwise approved by the fire code official. See Section 909.20.2.3 of the California Building Code for
20	additional provisions on smokeproof enclosures.
21	* * * *
22	
23	905.4.3. Local Requirement for Location of Class I Standpipe Hose Connections.
24	There shall be at least one two-way outlet above the roofline when the roof has a slope of less
25	than 4 units vertical in 12 units horizontal (33.3% slope).

1	
2	SECTION 907. – FIRE ALARM AND DETECTION SYSTEMS.
3	907.1.6. Installation Personnel Qualifications.
4	Contractors installing any life safety equipment in San Francisco including, but not limited to,
5	fire alarms, elevator recall systems, and sprinkler monitoring systems, must possess a valid current C-
6	10 (electrical) contractor license issued by the California Contractors State License Board (CA-CSLB).
7	The SFFD does not approve or accept work of the types listed above conducted by persons or
8	companies known not to hold the required license. Employees of companies hired to work on life safety
9	systems are required to maintain a valid current Electrician Certificate (fire alarms) issued by the CA
10	Department of Industrial Relations (CA-DIR).
11	
12	The following parts of the San Francisco Fire Code section replace the corresponding parts of
13	the California Fire Code section:
14	907.2.9.1 [For SF] Manual fire alarm system.
15	* * * *
16	3. The building contains more than 6 dwelling units or sleeping units.
17	4. Congregate living facilities or congregate residences three or more stories in height or
18	having an occupant load of 11 or more.
19	Exceptions:
20	* * * *
21	
22	907.2.10.9. Smoke Alarm Information Disclosure.
23	(a) Annual Smoke Alarm Information Notice. On or before January 31, 2017, and on or before
24	January 31 of each year thereafter, owners of a dwelling unit intended for human occupancy in which
25	one or more units is rented or leased shall provide each tenant with a written notice regarding smoke

1	alarm requirements on a form provided by the Fire Department. The Fire Department shall develop the
2	notice in consultation with the Department of Building Inspection and shall make the notice available
3	on its website in English, Spanish, and Chinese. The Fire Department shall update the notice as
4	necessary from time to time to reflect changes in the law, and the owner shall provide the most recent
5	notice to tenants. The notice shall include, but not be limited to, the following information:
6	(1) information regarding the importance of maintaining smoke alarms in working
7	condition for life safety;
8	(2) a brief summary of legal requirements for smoke alarms in dwelling units;
9	(3) a statement that the landlord is obligated to provide operable smoke alarms in good
10	working condition in the dwelling unit in accordance with the Housing Code and Fire
11	Code and the landlord must promptly repair or replace inoperable smoke alarms upon
12	<u>request; and</u>
13	(4) attached as a separate appendix to the notice, a list, to be prepared by the Rent
14	Board, of tenants' rights organizations that provide counseling to tenants on issues
15	related to fires, and contact information [or those organizations.
16	(b) Posting Requirement. For all Apartment Houses as defined in the Housing Code, the
17	building owner shall post the notice referenced in subsection (a) in at least one conspicuous location in
18	a common area of each floor of the building.
19	907.5.2.2.6. Local Requirements for Emergency Voice Alarm-Communication System.
20	Multi-channel capability is required for new emergency voice/alarm communication systems in
21	<u>high-rise buildings.</u>
22	907.6.4.1.2. Local Annunciation Requirement.
23	Building fire alarm systems shall include visible annunciation in buildings with more than four
24	floors, or when required by the fire code official. Visible annunciation shall be a light-emitting diode
25	

1	(LED) type display. The annunciator panel shall indicate the type of device by floor, zone or other
2	approved designation from which the signal originated.
3	907.6.4.1.3. Graphic Annunciation.
4	Graphic annunciation shall be installed when required by the fire code official.
5	
6	The following part of the San Francisco Fire Code section is added to the corresponding
7	California Fire Code section:
8	907.6.4.3. [For SF] High-Rise Building Fire Alarm Annunciation.
9	* * * *
10	6. Status of emergency equipment such as the emergency generator, fire pump, and secondary
11	water supply. Shall comply with San Francisco Fire Department Administrative Bulletin 3.01.
12	
13	907.7.4. Fire Alarm Certification Required.
14	All new fire alarm systems shall be certificated. Fire alarm systems providing service that
15	complies with all requirements of this code shall be certificated by an organization that is part of the
16	Occupational Safety and Health Administration Nationally Recognized Testing Laboratory Program. A
17	document attesting to the certification shall be located on or near the fire alarm system control unit or,
18	if no control unit exists, on or near a fire alarm system component.
19	Exceptions:
20	1. Household fire-warning systems and fire alarm systems in one- or two-family dwellings or
21	three-unit apartment houses.
22	2. Fire alarm control panels whose primary function is to monitor a sprinkler system.
23	
24	The following San Francisco Fire Code section replaces the corresponding California Fire
25	Code section:

1	907.8.5. [For SF] Inspection, Testing, and Maintenance.
2	(a) Testing, Inspection and Filing Requirements. The building owner is responsible to maintain
3	the fire and life safety systems in an operable condition at all times. The building owner must have the
4	system(s) tested and inspected every year by service personnel who meet the qualification requirements
5	of Section 907.8.8 and NFPA 72, as amended from time to time, for maintaining, inspecting, and testing
6	of the systems.
7	(1) Filing Statement of Compliance. With regard to fire alarm systems in Apartment
8	Houses, as defined in the Housing Code, the building owner shall file a Statement of
9	Compliance with this annual testing and inspection requirement with the Fire
10	Department, on a form provided by the Fire Department, in accordance with the
11	following schedule: (A) for buildings with nine or more units, on or before January 31,
12	2017. and thereafter on or before January 31 of each odd-numbered year, and(B) for
13	buildings with less than 9 nine units, on or before January 31, 2018, and thereafter on
14	or before January 31 of each even- numbered year. The Fire Department shall consult
15	with the Department of Building Inspection in developing the Statement of Compliance
16	form. The Fire Department shall post all Statements of Compliance it receives on a City
17	website maintained by the Fire Department no later than 60 days from January 31 each
18	<u>year.</u>
19	(2) Posting Statement of Compliance in Common Area. In addition to filing the
20	Statement of Compliance, the building owner shall post a copy of the most recently filed
21	Statement of Compliance in at least one conspicuous location in a common area of each
22	floor of the building or, if no such common area(s) exist, the building owner shall
23	provide a copy to each residential tenant in the building. The building owner shall
24	comply with this requirement no later than 60 days from the date of filing of the
25	Statement of Compliance.

1	(3) Enforcement. For purposes of enforcement of this subsection (a), the Fire
2	Department shall be responsible only for posting the Statement of Compliance forms on
3	the City website, and the Fire Department and/or the Department of Building Inspection
4	shall respond to any complaint received by the respective department pertaining to
5	compliance with this subsection in the case of the Fire Department, or compliance with
6	Section 908 of the Housing Code in the case of the Department of Building Inspection.
7	The Departments may also enforce these requirements pursuant to periodic health and
8	safety inspections required by code.
9	(b) Recordkeeping. The building owner shall maintain written records of inspection and testing
10	as specified in NFPA 72, as amended from time to time, until the next test and for one year thereafter.
11	(c) Sticker. The building owner shall place, or shall cause service personnel to place, a sticker
12	on the exterior of the fire alarm control panel cover that includes the company name, phone number,
13	C10 license number, the type of last inspection or test, technician name (printed and legible), and the
14	date of service.
15	
16	907.8.6. Certificated Fire Alarm Systems for Existing Buildings.
17	Existing buildings are required to have certificated fire alarm systems in accordance with
18	<u>Section 1103.7.10.</u>
19	907.8.7. Reporting of Fire Alarm System Operational Matrix.
20	All fire alarm inspection and testing reports for high-rise buildings shall clearly state how the
21	fire alarm system's matrix was designed and approved to operate. The report shall indicate if the
22	system is designed as a Full Evacuation System (all floors are notified and shall evacuate), a Partial
23	Evacuation System (only some floors are notified of the alarm and must evacuate), or as a Relocation
24	System (only some floors are notified and asked to relocate to another floor within the same building).
25	

1	The report shall indicate which floors are designed for the full evacuation of occupants and on which
2	floors the occupants shall relocate to another floor.
3	907.8.8. Inspection, Testing, and Maintenance Personnel Qualifications.
4	Personnel inspecting, repairing, or testing any life safety equipment in San Francisco including
5	but not limited to, fire alarms, elevator recall systems, and sprinkler monitoring systems, must possess
6	a valid current C-10 (electrical) contractor license issued by the California Contractors State License
7	Board (CA-CSLB). The SFFD does not approve or accept work of the types listed above conducted by
8	persons or companies known not to hold the required license. Employees of companies hired to work
9	on life safety systems are also required to maintain a valid current Electrician Certificate (fire alarms)
10	issued by the CA Department of Industrial Relations (CA-DIR)
11	
12	SECTION 912. – FIRE DEPARTMENT CONNECTIONS.
13	912.8. Number of connections required.
14	Sprinkler systems requiring a 4-inch (101.6 mm) or larger water service shall have two or more
15	inlet connections as necessary to meet hydraulic demand.
16	
17	SECTION 913. – FIRE PUMPS.
18	913.2.3. Integrity of the fire pump room.
19	The integrity of the fire pump room shall not be compromised. All non-fire pump related
20	equipment, piping, drains, electrical equipment, and electrical services shall not be routed through or
21	located within the fire pump room. Examples include, but are not limited to:
22	1. Non-fire water system piping
23	2. Domestic water equipment and piping
24	3. Drain piping
25	4. HVAC equipment, ducts, fans, and piping

1	5. Boilers or furnaces, fuel equipment, and piping (unless feeding a diesel fire pump motor)
2	6. Electrical equipment and service (e.g. transformers and switchgear)
3	
4	SECTION 914. – FIRE PROTECTION BASED ON SPECIAL DETAILED
5	REQUIREMENTS OF USE AND OCCUPANCY.
6	The following San Francisco Fire Code section replaces the corresponding California Fire
7	Code section:
8	914.3.1.1. [For SF] Number of Sprinkler System Risers and System Design.
9	Each zone of any sprinkler system shall connect to at least two risers on each floor. Hydraulic
10	calculations shall be based solely on the riser with the greatest hydraulic demand.
11	
12	914.3.1.2.2. Fire pump drives.
13	The drive for each pump (including power sources, power supply lines, motors or engines, fuel
14	supplies, and controllers) shall be independent of the drive for any other pump.
15	914.3.1.3. Fire Department Connections.
16	A Fire Department connection shall be located on each side of a building that fronts a street,
17	and shall provide four inlets for each connection.
18	914.3.2.1. Integrity of fire water storage tank.

20	related system piping, electrical wiring, or drain piping shall not be routed through or located within a
21	fire water storage tank. Examples include, but are not limited to:

23	2. Sanitary sewer lines
24	3. Electrical conduit
25	914.3.2.2. Tank overflow line and drain line routing.

1	Any tank overflow line or drain line shall be routed to a remote drain that is designed to handle
2	the maximum flow without flooding or damaging the fire pump room, its equipment, or any other room
3	in the building. The routing shall not be located in a fire pump room.
4	914.3.2.2.1. Drain ejector pumps (Sump Pumps).
5	Drain ejector pumps shall be permitted to manage fire water tank overflow. Ejector pumps are
6	only to be used when gravity drainage is not available (CPC 709.1). Where overflow lines route to a
7	drain-ejector pump, the following shall apply:
8	1. Redundant or backup drain ejector pump(s) shall be provided.
9	2. All drain ejector pumps shall be installed in a remote location approved by the Fire
10	Department and shall not be located inside or near a fire pump room.
11	3. All drain ejector pumps shall be sized and rated for the maximum fill flow rate of the
12	<u>water tank.</u>
13	4. All drain ejector pumps shall be provided with approved emergency/standby power.
14	5. All drain ejector pumps shall discharge to a safe location that will not subject any portion
15	of the building to flooding.
16	<u>914.12. Piers.</u>
17	Group A and F occupancies located on piers of combustible construction shall be protected by
18	approved automatic sprinkler systems.
19	
20	CHAPTER 10. – MEANS OF EGRESS.
21	SECTION 1010. – DOORS, GATES AND TURNSTILES.
22	The following part of the San Francisco Fire Code section replaces the corresponding part of
23	the California Fire Code section:
24	1010.1.2. [For SF] Door Swing.
25	* * * *

1	Exception 6:
2	In other than Group A, E, H, I, R, and high-rise building occupancies, special purpose
3	horizontal sliding, accordion, or folding door assemblies complying with Section 1010.1.4.3.
4	* * * *
5	
6	The following part of the San Francisco Fire Code section replaces the corresponding part of
7	the California Fire Code section:
8	1010.1.4.3. [For SF] Special Purpose Horizontal Sliding Door, Accordion, or Folding Doors.
9	In other than Group A, E, H, I, R, and high-rise building occupancies, special purpose
10	horizontal sliding, accordion, or folding door assemblies permitted to be a component of a means of
11	egress in accordance with Exception 6 of Section 1010.1.2 shall comply with all of the following
12	<u>criteria:</u>
13	* * * *
14	
15	<u>SECTION 1013. – EXIT SIGNS.</u>
16	The following part of the San Francisco Fire Code section adds to the corresponding California
17	Fire Code section:
18	1013.1. [For SF] Where required.
19	* * * *
20	Exceptions:
21	* * * *
22	6. Doorways or other openings leading to a fire escape, except within individual dwelling
23	units, shall be provided with a sign reading "FIRE ESCAPE" in letters not less than 6 inches (152 mm)
24	high, in high contrast with the background.
25	

1	SECTION 1030. – EMERGENCY ESCAPE AND RESCUE.
2	1030.1.2. Direct Access to Public Way.
3	When buildings are constructed on lot lines, an emergency escape and rescue egress may pass
4	through the building via an exit passageway (per SFFC Section 1024) with approval from the AHJ.
5	The exit passageway shall be an independent exit access path to the public way from the building units.
6	
7	SECTION 1031. – MAINTENANCE OF THE MEANS OF EGRESS.
8	1031.2.3. Fire Escape Obstructions.
9	Fire escapes and related balconies, ladders, landings, and operating devices shall not be
10	obstructed in any manner. No object shall be stored on or attached to a fire escape without the
11	approval of the fire code official. Fire escapes shall not be located beyond a locked door or room that

12	1103.5.1. [For SF] Automatic Sprinkler System for Existing SRO Hotel Buildings.
13	Every residential hotel building existing on October 16, 2001, that contains twenty (20) or more
14	guest rooms, as defined in the California Building Code, shall provide and maintain an automatic
15	sprinkler system installed to comply with San Francisco Ordinance 170-02 throughout the residential
16	occupancy, including accessory areas. For purposes of this section, "Residential Hotel" means each
17	and every hotel for which a Certificate of Use for any residential units has been issued pursuant to San
18	Francisco Administrative Code Chapter 41. Any Residential Hotel that does not maintain an installed
19	automatic sprinkler system throughout the residential occupancy is out of compliance and subject to
20	immediate code enforcement action. The owner shall maintain the sprinkler system in accordance with
21	<u>Title 19 of the California Code of Regulations.</u>
22	
23	The following San Francisco Fire Code section replaces the corresponding International Fire
24	Code section:
25	1103.5.2. [For SF] Automatic Sprinkler System for Existing High-Rise Buildings.

1	All existing high-rise buildings shall maintain an automatic sprinkler systems installed to
2	comply with San Francisco Ordinance 377-93.
3	Exceptions:
4	1. Qualified historical buildings as defined in the California Health and Safety Code Section
5	<u>18950.</u>
6	2. Apartment houses, condominiums, or other R-2 Occupancies.
7	3. A mixed-use occupancy building containing an R-2 Occupancy.
8	Any existing high-rise not exempted from this section that does not provide an automatic
9	sprinkler system throughout the residential occupancy is out of compliance and subject to immediate
10	code enforcement action. The owner shall maintain the sprinkler system in accordance with Title 19 of
11	the California Code of Regulations.
12	
13	The following San Francisco Fire Code section replaces the corresponding International Fire
14	<u>Code section:</u>
15	1103.5.3. [For SF] Automatic Sprinkler System for Existing Hotels.
16	All hotels described in San Francisco Ordinance 319-86 shall maintain an automatic sprinkler
17	system installed to comply with San Francisco Ordinance 319-86 throughout all common areas of the
18	hotel. Any existing hotel that does not provide an automatic sprinkler system in accordance with the
19	ordinance is out of compliance and subject to immediate code enforcement action. The owner shall
20	maintain the sprinkler system in accordance with Title 19 of the California Code of Regulations.
21	
22	Section 1103.7.1 and 1103.7.2 of the International Fire Code are deleted.
23	
24	Sections 1103.7.4 through 1103.7.5.2.1 of the International Fire Code are deleted.
25	

1	1103.7.6.1. Sleeping Area Requirements.
2	For all buildings that are required to have a fire alarm system under this Code Section
3	1103.7.6, pertaining to Group R-2 occupancies, the Building Code, the Housing Code, or any other
4	law, the building owner shall upgrade the fire alarm system, if necessary, to comply with the sound
5	level requirement for sleeping areas set forth in Section 18.4.5.1 of NFPA 72 (2013 edition), as
6	amended from time to time, upon either (a) completion of work under a building permit with a cost of
7	construction of \$50,000 or more, (b) July 1, 2021, or (c) for buildings sold or transferred after
8	September 1. 2017, twelve months after the sale of the property, whichever occurs first.
9	Exceptions. Division 1103. 7. 6.1 (a) shall not apply to mandatory seismic strengthening
10	alterations being performed pursuant to Chapter 4D of the Existing Building Code. This subsection
11	1103.7.6.1 applies only to Group R-2 occupancies.
12	1103.7.10. Certificated Fire Alarm Systems for Existing Buildings.
13	The fire code official may require owners to obtain a certificate for existing fire alarm systems
14	based on severity of life safety hazards or problems identified with a system. Occupancies required to
15	install certificated fire alarm systems are as follows:
16	1. Tourist and residential hotels with twenty (20) or more guest rooms or three (3) or more
17	stories in height.
18	2. Apartment houses with sixteen (16) or more units.
19	3. Public assembly occupancies with an occupant load of 300 or more persons.
20	4. Day care facilities with fifty (50) or more occupants.
21	
22	SECTION 1104. – MEANS OF EGRESS FOR EXISTING BUILDINGS.
23	Sections 1104 through 1104.15 and 1104.17 through 1104.25 of the International Fire Code are
24	<u>deleted.</u>
25	

1	The following San Francisco Fire Code section replaces the corresponding International Fire
2	Code section:
3	1104.16.5. [For SF] Materials and Strength.
4	Components of fire escape stairways shall be constructed of non-combustible materials. Fire
5	escape stairways and balconies shall support the dead load plus a live load as per design when
6	installed. If the original structural design calculations are unavailable, then a registered design
7	professional shall determine the structural adequacy of existing fire escape stairways and balconies.
8	
9	The following San Francisco Fire Code section replaces the corresponding International Fire
10	Code section:
11	1104.16.5.1. [For SF] Examination.
12	All fire escape stairways and balconies shall be examined for structural adequacy and safety in
13	accordance with Section 1104.16.5 by a registered design professional or others acceptable to the fire
14	code official every 5 years, or more frequently as requested by the fire code official. The inspection
15	report shall be maintained on site and shall be made immediately available for review upon request by
16	the fire code official.
17	
18	SECTION 1105. – [DELETED].
19	Section 1105 of the International Fire Code is deleted.
20	
21	SECTION 1106. – [DELETED].
22	Section 1106 of the International Fire Code is deleted.
23	
24	CHAPTER 35. – HOT WORK.
25	SECTION 3511. – HOT WORK ON PIERS.

1	<u>3511.1. Scope.</u>
2	Burning or hot work conducted on marine terminals, piers, and wharves or moored vessels
3	shall be in accordance with this section.
4	3511.2. Repairs on Vessels.
5	An applicant for a permit to perform hot work on a vessel shall provide a copy of a Marine
6	Chemist's Certificate authorizing hot work with the permit application. If a permit is issued1 the permit
7	18 holder shall post a copy of the Certificate in a conspicuous place near the gangway of the vessel
8	under repair. The permit holder shall perform all work in accordance with NFPA 306, Control of Gas
9	Hazards on Vessels. Hot work is prohibited while a vessel is fueling, loading or unloading hazardous
10	materials, or when Class "A" or "B" explosives are on board or within 100 feet (30 480 mm) of the
11	vessel.
12	3511.3. Repairs on Piers.
13	Hot work is prohibited at marine terminals and on piers, wharves, or moored vessels under any
14	of the following conditions:
15	1. During gas freeing operations;
16	2. Within 100 feet (30 480 mm) of bulk cargo operations involving the loading or unloading of
17	flammable or combustible materials;
18	3. Within 100 feet (30 480 mm) of fueling (bunkering) operations; and
19	4. Within 100 feet (30 480 mm) of explosives or 50 feet (15 240 mm) of other hazardous
20	materials.
21	3511.4. Requirements for Hot Work.
22	Any person performing hot work shall perform the work in compliance with this code and the
23	regulations of the U.S. Department of Transportation, U.S. Department of Labor, and U.S. Coast
24	<u>Guard.</u>

1	CHAPTER 56. – EXPLOSIVES AND FIREWORKS.
2	SECTION 5601. – GENERAL.
3	The following San Francisco Fire Code section replaces the corresponding California Fire
4	Code section:
5	5601.2. [For SF] Permit Required for Explosives, Explosive Materials, Fireworks, and
6	Pyrotechnics.
7	No person may manufacture, assemble, test, use, possess, handle, store, or sell explosives,
8	explosive materials, fireworks, and pyrotechnic materials within the City and County unless the person
9	has obtained a permit from the fire code official.
10	
11	The following San Francisco Fire Code section replaces the corresponding California Fire
12	Code section:
13	5601.2.4. [For SF] Financial Responsibility and Insurance.
14	Before a permit is issued to use explosives, explosive materials, fireworks, or pyrotechnic
15	special effects, the applicant shall submit to the fire code official a certificate evidencing Commercial
16	General Liability insurance with limits not less than \$1,000,000 each occurrence, \$2,000,000 general
17	aggregate, combined single limit for bodily injury and property damage, including coverage for
18	Contractual Liability, independent contractors, Explosion, Collapse, and Underground (XCU),
19	Personal Injury, Broadform Property Damage, products, and completed operations, along with an
20	additional insured endorsement naming the City and County of San Francisco, its officers, agents and
21	employees as an additional insured. The insurance policy and endorsement shall be from an insurer
22	approved by the City's Risk Manager and in a form approved by the Risk Manager. In consultation
23	with the Risk Manager, the fire code official may specify a greater or lesser amount for the policy
24	when, in the fire code official's opinion, conditions at the location of use indicate a greater or lesser
25	amount is required.

1	Exception: Government entities are exempt from this requirement.
2	
3	CHAPTER 80. – REFERENCED STANDARDS.
4	NFPA 72-16: National Fire Alarm and Signaling Code, as amended.
5	Revise Section 18.4.2.1 as follows:
6	18.4.2.1. To meet the requirements of Section 10.10, the alarm audible signal pattern used to
7	notify building occupants of the need to evacuate (leave the building) shall be the standard alarm
8	evacuation signal consisting of a three-pulse temporal pattern in accordance with Figure 18.4.2.1.The
9	audible signal pattern used to notify building occupants of the need to relocate (from one area to
10	another) shall be a 1-second to 3-second alert tone followed by a message (or messages where multi-
11	channel capability is used) per Section 24.4.8.3.
12	
13	Delete Sections 18.11 and 21.5.3.
14	
15	Revise Section 24.4.8.3.1 as follows:
16	24.4.8.3.1. The sequence [the alert tone followed by the message(s)] shall be repeated
17	continuously to inform and direct occupants in the signaling zone where the alarm initiation originated
18	as well as other signaling zones in accordance with the building fire safety plan.
19	
20	CHAPTER 81. – PARKING LOTS AND GARAGES.
21	This Chapter does not exist in the California Fire Code or International Fire Code.
22	
23	<u>SECTION 8101. – SCOPE.</u>
24	
25	

1	Premises used for parking of motor vehicles and classified as Group S, Division 2 occupancies
2	or as a parking lot shall be in accordance with Chapter 81. See the Building Code for construction
3	requirements. Garages used to service or repair motor vehicles shall comply with Chapter 23.
4	
5	SECTION 8102. – DEFINITIONS.
6	PARKING LOTS AND GARAGES are lots and garages where the operator charges a fee for
7	the storage of motor vehicles. Parking lots shall include those premises that are open to the sky.
8	
9	<u>SECTION 8103. – GENERAL REQUIREMENTS.</u>
10	<u>8103.1. Aisles.</u>
11	A parking lot or garage shall include at least one aisle with a minimum width of 30 inches (762
12	mm) and arranged to provide access to all portions of the parking lot or garage.
13	8103.2. Exit Width.
14	Vehicle exits and entrances shall be at least 15 feet (4572 mm) wide.
15	8103.3. Vehicle Barriers.
16	The operator of a parking lot or garage shall install approved vehicle barriers to prevent
17	encroachment on any public right of way and to prevent damage to adjoining property.
18	8103.4. Illumination.
19	The operator of a parking lot shall illuminate the entire lot with light having intensity of not less
20	than 1 foot-candle (10.76 lx) at the pavement.
21	<u>8103.5. Sign.</u>
22	The operator of any unattended parking lot shall post a sign in a conspicuous location, stating
23	the name and telephone number of the operator.
24	8103.6. Vehicle Servicing.
25	Service or repair of motor vehicles is prohibited in parking lots.

1	
2	Section 5. Effective and Operative Dates.
3	(a) This ordinance shall become effective 30 days after enactment. Enactment occurs
4	when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not
5	sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the
6	Mayor's veto of the ordinance.
7	(b) The operative date of Section 4 of this ordinance shall be January 1, 2020,
8	consistent with the operative date of the 2019 California Fire Code.
9	
10	Section 6. Transmittal to State Authorities.
11	Upon enactment of this ordinance, the Clerk of the Board of Supervisors is hereby
12	directed to transmit this ordinance, including Exhibit A, to the California Building Standards
13	Commission and the State Fire Marshal for filing, pursuant to the applicable provisions of
14	California law.
