2. CASE NO. 2015-02: COMMISSION DELIBERATIONS AND POSSIBLE ACTION ON EMPLOYEE SUSPENSION APPEAL [Action item]

In accordance with Article 40, Section 4005 of the Rules and Regulations the employee has appealed a ten-day suspension for violation of the Rules and Regulations as follows:

Section 3905 – Familiarity with the Rules Section 3907 – Safety Rules Section 3919 – Proper Behavior Section 3923 – Acts Detrimental to the Welfare of the Department Section 3940 – Unauthorized Use or Disposition of Property Section 3941 – Use of Department Vehicles Section 4002 – Off Duty Conduct

This case may be heard in Closed Session pursuant to Government Code Section 54957(b) and San Francisco Administrative Code Section 67.10(b).

A. Public Comment on Special Meeting Agenda Item; Possible Closed Session

Members of the public may comment on Agenda items that are scheduled for discussion or action. [Government Code §54954.3(a), Administrative Code §67.15(b)]

President Evans called for public comment. No member of the public came forward and President Evans closed public comment.

The Commission reconvened in Open Session to report action taken at 3:58 p.m.

Member pled guilty to the charges of violating San Francisco Fire Department Rules and Regulations Section 3905 – Familiarity with the Rules; Section 3907 – Safety Rules; Section 3919 – Proper Behavior; Section 3923 – Acts Detrimental to the Welfare of the Department; Section 3940 – Unauthorized Use or Disposition of Property; Section 3941 – Use of Department Vehicles; and Section 4002 – Off Duty Conduct. By unanimous vote of members present, the Commission voted to impose discipline on the violations of Sections 3923, 3940, 3941, and 4002 only. (Ayes: Evans, Covington, Nakajo, Hardeman)

Accordingly, the Commission voted to reduce the Chief's recommended penalty to a 2day suspension, by a unanimous vote of members present. (Ayes: Evans, Covington, Nakajo, Hardeman).

Counsel for Commission will prepare the Findings of Fact.
