Update from FY21 & FY22 Budget

- Mayor Breed signed off on City's Fiscal Years 2020-21 and 2021-22 budget on October 1st, 2020, officially concluding a unique budget process for the City
- Budgets loaded and new initiatives were commenced in Fall
 2020
- At signing of the budget, many uncertainties surrounding the budget, including Federal Aid, the City's COVID response, revenue impacts, labor negotiations, and more, were front and center
- Many of those uncertainties remain as we move forward

Current Year Update

- Given these uncertainties and the corresponding variance that would result from changes, analysis of revenues and expenditures were tracked closely from the beginning of the fiscal year
- The Controller's Office issued a Three-Month Budget Status Report in the current year, allowing Department to identify and communicate any issues that have popped up as a result of these uncertainties and the on-going COVID pandemic
- This analysis, along with additional analysis of the fiscal situation of the City, drove the budget instructions for the upcoming fiscal years



Budget Process/Instructions

- Fire Department received budget instructions/reduction targets in mid-December 2020
- Departments must submit their proposed budgets to the Mayor's Office on February 22, 2021
- Mayor reviews Department budget submittals and consolidates them for an overall balanced City budget that then must be submitted to the Board of Supervisors by June 1, 2021 by charter mandate
- Budget Hearings in late June/early July at the Board
- Final approval late July/early August
- Continuation of rolling two-year budget cycle

Budget Process/Instructions

Budget Instructions

- In order to balance the \$653 million projected deficit over the two years, Departments were asked to reduce their budgets
- Mandatory reduction proposals of <u>7.5%</u> of adjusted general fund support proposed in each of the two upcoming future fiscal years, as well as a <u>2.5%</u> contingency proposed should fiscal conditions worsen in both years as well
- Departments to prioritize core services
- Emphasis on racial equity (as well as equity in general) in Department proposals

Budget Transparency Legislation

Ordinance 294-19

- Effective December 1, 2020, a number of new budget transparency requirements were put into place as a result of Board of Supervisors legislation with the goal of additional transparency during the budget process and centralized repository for City Department budget information
- Requirement of two public meetings prior to February 14th with proper notice and documentation available in advance
- Working closely with the Commission secretary and Controller's office to meet all reporting requirements

July 2021	Budget considered at Board of Supervisors
