



OPERATIONS REPORT

June 1 – June 30, 2022

GREATER ALARMS:

There were two Greater Alarm fires during this reporting period.

 2^{nd} Alarm – (6/1/22) 0535 hours, 74 Turk Street, cross streets Market and Taylor. There was one injury. This fire was determined to be accidental. (Assistant Chief Ken Yee)

A full box was dispatched at approximately 0537 hours for 74 Turk Street for a Fire in the Building. Units dispatched were Engine 1, Engine 3, Engine 36, Truck 1, Truck 3, Battalion 2, Battalion 3, Division 2, Rescue Squad 1 and Medic 80.

Engine 1 (Lt. Scheppler) arrived on scene, saw smoke above the roof line of 74 Turk and proceeded to investigate. Fire was found on the second floor, at the bottom of the lightwell, and Lt. Scheppler had his crew pull a ready line to attack the fire.

74 Turk is a four story Single Room Occupancy, with 57 rooms spread through three floors over a vacant restaurant on the first floor. The fire had started at the bottom of the lightwell, on the second floor, and had begun to travel up the lightwell when the Fire Department arrived.

The complement of the first alarm companies arrived and were given their assignments. Battalion 2 (BC Crispen), assigned as Fire Attack, ensured there were Engine companies operating hose lines on each floor, as well as Truck crews opening up walls to check for fire extension. Engines 1, 3 and 36 had hose lines operating on the second, third and fourth floors, respectively. Truck 1 split their crew, with two members going up their aerial ladder to perform roof operations and the other two members going inside to open walls and pull ceilings. Truck 3 laddered the Bravo side of the roof for an additional egress and the crew went inside to assist with search and rescue and overhaul operations. Rescue Squad 1 cleared the building of all occupants.

Due to the location of the fire and the type of building, a second alarm was needed. The additional companies were used to assist with evacuation and to check for fire extension. With the fire in the lightwell, companies had to open walls on every floor to check for fire extension. All the exterior siding in the lightwell that were burned had to be removed. Even though the fire was contained within a short time after our arrival, our companies spent almost four hours on scene performing overhaul operations.

The second alarm at 74 Turk Street could have turned into a larger fire, with the potential of losing the entire building. The quick and decisive actions by BC Crispen and the first arriving companies kept

the fire damage to a minimum. By attacking the fire aggressively and staying in front of it, our fire crews were able to contain the fire to the exterior lightwell, instead of letting the fire get into the walls, ceilings and the attic space.

One person was transported for medical reasons unrelated to the fire. Another occupant was briefly trapped in his room due to the smokey hallway and was evacuated by Rescue Squad 1.

Unfortunately for the occupants, the wall on fire in the lightwell is the exterior wall of the common bathrooms for each floor. This wall had to be removed to check for fire extension and the bathrooms on the top three floors were left unusable. Even though there was no fire damage to the residential units, Red Cross was called and they were able to place all the residents of this building.

 2^{nd} Alarm – (6/1/22) 1418 hours, 834 Washington Street, cross street Waverly Place. There were no injuries. This fire was determined to be accidental. (Assistant Chief William Storti)

The fire was discovered by pedestrians on the street seeing fire from the roof. Upon arrival E41 called smoke showing and a working fire was struck. E41 led a 150' ready-line to sub-level 1, located origin of fire, and placed water on the fire. E2 led a 200' ready line to the ground floor and extinguished the fire extension near the flue. Truck 13 requested a line on the roof, and E28 led a large line wye up T13's aerial to extinguish the roof fire. T13 interior started a primary search. T13 joined fire attack and searched for extension. By this time, the entire building was charged with smoke. As Fire attack B04 requested a 2nd alarm. Companies led lines to each floor of the building. B02 and E03 found access to the fire in Delta 2 through a bottom floor bathroom causing damage to the building in overhaul but extinguishing the last of the fire. The main obstacle was the old, tight construction of the buildings that made finding extension of the fire problematic. Companies did a good job of locating and extinguishing fire needing several hose-leads on several different floors. The building was in good condition with some damage to each floor near the flue. All operations worked well.







General Activities

On June 23, 2022, a Hybrid academy class of eleven H3L1 and four H3L2 members graduated. These 15 new members were put to work starting June 25, just in time for the many Pride events in the city, including the Pride Parade on the 26.

Many thanks to Homeland Security ADC Brown and EMS Captain Smith for their relentless planning in preparation for the Warriors Championship Parade, Pride Parade, and Fourth of July celebrations, all within a two-week period.

Special thanks to Section Chief of EMS Operations Tangherlini and Captain Smith who staffed the EMS command and SFFD-SFPD liaison functions, respectively, to coordinate the calls for assistance during both the Warriors and Pride parades.

- The Warriors event resulted in nearly 100 calls for service. With a last-minute recruitment for volunteers, Station 49 members responded to staff gators and ambulances, critically needed for this unexpected event.
- Station 49 members and City EMT 9910 interns staffed gators, ambulances, and the Mass Casualty Bus during the Pride parade. In addition, Dr. Chris Colwell, ZSFGH Chief of the Emergency Department, and EMSA Fellow, Dr. Courtney Shay volunteered to provide medical staffing for the bus.

Community Paramedicine (CP) Highlights

Emergency Medical Dispatch (EMD) of the Street Crisis Response Team began on June 22. EMD implementation was delayed for two days because of the preparation and staffing needs of the Warrior's celebration parade. EMD implementation of the SCRT means that law enforcement is no longer dispatched to 800B calls. An 800B is a "report of a mentally disturbed person" that is nonviolent and not brandishing a weapon. There had been approximately 14,000 annual 800B calls, of which approximately 62% of which were already being handled by the Street Crisis Response Teams. With the cutover to EMD, 100% of these calls will now be handled by some combination of Street Crisis Response Team and/or EMS response, and thus fulfilling the intention of the program to replace law enforcement response to these incidents. The process has been closely monitored and the first week of data showed that all calls that were SCRT eligible received the SCRT, or as backup, the SWRT, within expected response times.

All funded Community Paramedicine programs were fully implemented on June 27. The target date for implementation had been Saturday, June 25, but it was delayed due to operational concerns related to the busy Pride weekend celebrations. As of June 27, there are a total of 14 community paramedicine street teams deployed in every 24-hour period, including 3 overnight teams and 24-hour supervisorial coverage from community paramedicine trained EMS captains.

- 7 Street Crisis Response Teams (2 overnight)
- 5 Street Wellness Response Teams (1 overnight)
- 2 Street Overdose Response Teams

The Mayor's Tenderloin Emergency Initiative, which enabled expedited hiring and contract signing and led to the creation of the Tenderloin Center and Tenderloin Joint Field Operations, ended on June 30. The Tenderloin Center, a drop-in center administered through the Department of Public Health (DPH), will continue operations until the end of the calendar year. Joint Field Operations (JFO), which offer shelter and treatment referrals to members of the public and clean the streets at priority locations in the Tenderloin, will also continue operations, but with overall management switching from the Department of Emergency Management to the City Planning Department. The JFO, vital to improving the health and vibrancy of city streets, is comprised of members from the Department of Homelessness and Supportive Housing (HSH), DPH, DPW, SFPD, and the SFFD, which provides two Acting EMS Captains trained in community paramedicine that serve as the JFO field commanders for daily operations.

Successes:

A 45-year-old individual experiencing homelessness that has resided in San Francisco for several years was released from prison in the first week of May. In May he utilized SFFD ambulances 40 times, often activating 911 himself after excessive alcohol consumption and asking for shelter. Community paramedics on EMS-6 began intensive engagement, outreaching to him on average twice per day for the months of May and June. He was offered shelter, withdrawal management treatment, and a referral to the Managed Alcohol Program, and he declined them all. By connecting him to family members and his parole officer, and by aggressively connecting him to the Sobering Center prior to a 911 activation, EMS-6 personnel have reduced his utilization in June by nearly 50%.

A 45-year-old individual experiencing homelessness that had **245** 911 activations in the previous 24 months, was successfully inducted into the Managed Alcohol Program with the coordination and support of EMS-6 personnel in the first week of June. Due to a chronic medical condition and

alcohol use disorder, he has had nearly daily ER visits for the last 12 months (35 visits in May). However, he has adjusted well at Site 42, is consistently taking his medication, attending doctor appointments, and has had only 2 ER visits in the month of June.

After persistent advocacy by EMS-6 personnel, a 39-year-old individual with mental illness was placed on a conservatorship in early June. This individual, who resided with family members that had declining ability to care for him, utilized SFFD ambulances 117 times in the previous 12 months. EMS-6 personnel engaged this individual on 20 occasions during the months of May and June and have been instrumental in organizing many case conferences with Adult Protective Services, an intensive case management team, multiple ER social workers, the individual's family members, conservator's office, primary care physician, and psychiatrists. This led to a 5150 hold in May, which became a 5250 hold, then temporary conservatorship, leading to permanent conservatorship. There have been no 911 activations in the month of June.

Successes:

A 72-year-old individual experiencing homelessness who, according to neighbors, has lived in the Hayes Valley neighborhood for 10 years, has been housed in a "Tiny Home." There have been 36 SCRT responses in the previous 12 months, and neighbors, concerned about this person's well-being, state he is often heard yelling, crying, and talking loudly both day and night. SCRT personnel realized that the individual has significant hearing loss and is unaware of how loud and disruptive he can be. Once the hearing loss was understood, members began communicating with pen and paper. This individual, who has a history of mental illness and substance use disorder, had not only been engaged by the Street Crisis Response Team, but by the follow-up team of the Office of Care Coordination, and case management. Uncomfortable in group settings, he had often declined congregate shelter, and once declined placement in a hotel. However, he has accepted a Tiny Home and is now off the street, and there have been no SCRT contacts since early May.

SORT Highlights:

Of the encounters with a confirmed opioid overdose, there have been 12 buprenorphine starts in the month of June. Considering that our members must accompany the individual to a medical provider, advocate for administration and a prescription, and then accompany the individual to a pharmacy, this is an admirable connection rate of 24%.

Progress continues on the California EMSA pilot program that will allow community paramedics themselves to carry and administer buprenorphine. SORT has written training guidelines for the pharmacists of Poison Control, who will provide 24 hour per day, 7 day per week medical direction

for the pilot. The pharmacists will have to be trained in these guidelines before operations begin. EMS' expectation is that once the community paramedics can administer buprenorphine in the field, connection rates to treatment will increase.

- The Official Start of the 130th Recruit Class was 06/27/22, with 51 Recruits. The new instructors have mentors and are fitting in well.
























Auto Extrication Drills
