December of 2022 was a busy month without a COVID surge.

Promotion/End of Probation:

When members are promoted, they undergo a physical exam and drug screening. After **6 months**, the drug screening is repeated. Drug screening entails: urine (opiates, cocaine, amphetamines), saliva (point of care for THC only, a 48 hour look-back) and a breathalyzer test.

When recruits are in their probation period, we see them after **12 months** and perform the above drug screening.

In December, we performed 40 Promotion and End of Probation exams combined.

Return to Duty

When someone returns to work after an illness or injury, either Worker's Comp or personal sick leave, they must obtain a Work Status letter from their Occupational Health or treating physician. This letter specifies restrictions (so called, "modified duty") or released the member to full duty. After we receive this letter, we either speak to the member on the phone, via Facetime or in person depending on the length of leave and nature of the injury/illness.

For COVID, we have largely automated the process, and the below number, does not include return to work from COVID, unless it was a prolonged leave.

We did **15** Return to Duty exams in December.

New Hire Screens

We finished up screening **10** candidates for the 131st Fire Academy taking place now and also screened for an EMS Academy which will take place in February.

DMV Exams

NP Phelps performs Class C license for members who wish to maintain that level of license (commercial) with the DMV. She performed **1** DMV exam in December.

Other Activities:

We held a **COVID bivalent booster and Influenza Vaccine Clinic** at DOT on December 13 and 15. 65 members were give boosters or primary influenza shots.

We partnered with HSS to set up a **Know Your Numbers** event which looks at cardiovascular risk, to coincide with the SF Firefighters Cancer Prevention Foundation Galleri Cancer screening December 6, 7,8, 9. They screened over **250** retired and active members We are awaiting the aggregate results, but each person screened received their 10 year Cardiovascular Risk Score.

Fireboat/Energetix DOT Testing Program

It has been confirmed through the United States Coast Guard that our Fireboats do not fall under the DOT testing program as they are on a municipal mission. They will now be randomly tested through the normal Departmental testing program. This will provide additional savings to the budget, approximately \$5,000 annually.

Random Alcohol and Drug Testing Program

Forty-nine (49) members were randomly selected and tested; results were negative. Reviewed current contracts with CDT to streamline testing and cut costs. Working with Physician's office on new proposal.

Post-Accident Alcohol and Drug Testing Program

Two (2) Post-Accident Alcohol and Drug tests were administered this month, results negative.

Conditional Offer, Promotional and End-of-Probation Alcohol and Drug Testing Program

Cpt. Aspelin provided supplies and breathalyzer maintenance to the Physician's office.

Breathalyzers

All breathalyzers have now been re-certified and returned to the field.

FACILITY MAINTENANCE & PLANNING (June Waechtler, SFFD)

A total of 137 requests for service were initiated during the month of December 2022.
 95 service orders were completed and closed out. Fuel tanks, plumbing and electrical issues made up the majority of the requests.

PLUMBING

- Eleven (11) service calls were placed to resolve minor plumbing issues (faucet, toilet, urinal repairs; clogged sinks, shower drains) in the month of December 2022.
- Five (5) sewage backups were reported during December 2022: FS 3, 7, 9, 23 and 33.

HVAC/HEATING/BOILERS

- Discussed the possibility of ordering "reserve" recirculating pumps for station boilers to minimize downtime. DPW Steamfitters recommended that we wait and see how the replacement B&G pumps are. If satisfactory, DPW will purchase and set aside for SFFD facilities ten (10) of the most frequently used B&G pumps (Series 60). *Status Update: Waiting for feedback on B&G pumps*.
- FS 7: Recirc pump #5 needs to be replaced; Boiler is now functional and other zones are working. *Status Update: Pump replaced. Work complete.*
- FS 10: Boiler pump is damaged and needs to be replaced. Parts were ordered and have now been received. Still waiting for parts for Pump #2. Waiting for warranty replacement Pump #4 Pipe repair completed. *Status Update: Parts arrived and installed. Project complete.*
- FS 19 Total of five (5) radiators not working properly; parts (valves and fittings) ordered. *Status Update: All radiators replaced; units returned to service.*
- FS 43 Radiant heat is operational. HHW Boiler controls need to be repaired. SFFD gave approval to proceed with replacing boiler controls. DPW has obtained parts needed. Waiting for labor availability. *Status Update: Repair complete.*
- 1415 Evans Ave.: Installation of new HVAC system. Material is being fabricated. Job site coordination meeting took place in early November. *Status Update: Verified curb dimensions and voltage for new equipment at meeting. Sole source paperwork filed by DPW with OCA; currently under review. ETA for the new equipment is roughly 3-4 weeks out.*

CARPENTRY

No major carpentry issues were reported.

CEMENT/ASPHALT

Two cement/asphalt issues were reported: FS 35 and 32. Both repairs still pending.

ELECTRICAL

No major electrical issues were reported.

EXHAUST EXTRACTORS

• FS 5, 8 and 10 reported minor repairs needed to station's exhaust extractors. All units except FS 10 were returned to service during the month of December.

GENERATORS

• Minor issues were reported with stand-by generators located at FS 21 & 48 in the month of December 2022. All units were repaired and returned to service.

GLASS/WINDOWS/SCREENS

Requested estimate from DPW to replace windows at FS 43. Status: Pending.

LANDSCAPING

No major landscaping issues were reported.

PAINT

No major paint/graffiti issues were reported.

PEST MANAGEMENT

No major pest management issues were reported.

<u>E.S.E.R. BOND 2010 NFS – Updates through December 2022</u> Seismic Improvement Program (Magdalena Ryor, San Francisco Public Works):

• Fire Station 16 (\$14.2M) – Final Completion was achieved on July 18, 2019. Project is financially completed. Final PA was issued in June 2022.

Additional Focused Scope Program (Sherry Katz, San Francisco Public Works):

Emergency Generators:

- **Fire Station 14** Scope of work: replacement of existing generator with new rooftop generator, new subgrade fuel fill port at the sidewalk in front of the station, and new fuel piping from sidewalk to generator.
 - Building Permit issued on 6/17/21.
 - This project has been on hold to accommodate potential costs at Fireboat Station 35.
 - Invitation to Bid will be advertised in 2023.

<u>E.S.E.R. BOND 2014 NFS – Updates through December 2022</u> Seismic Improvement Program (Magdalena Ryor, San Francisco Public Works):

Fireboat Station 35 (\$50.5M) – Issuance of the Final Completion Certificate is projected in January 2023.

Focused Scope Program (Sherry Katz, San Francisco Public Works):

Total Funding allocated for the Focused Scope Program is \$21,407,279, approved by SFFD on 8/17/17.

Work is complete in 8 of 9 of the Focused Scope categories comprising Roofing, Apparatus Bay Door Replacements, Exterior Envelope Improvements, Windows, Showers, HVAC/Mechanical, Sidewalk/Slabs, and Security Access Control. Work continues to progress through the last scope category, Generator Replacements.

Emergency Generators:

FS 2 – Scope of work: replace existing rooftop generator set, structurally strengthen roof structure to support new fuel tank with capacity for 72-hour run time and provide new fuel fill port and piping to generator.

 - Project was bid on August 3, 2022; BBJ Electric was the sole bidder. CMD deemed BBJ nonresponsive due to LBE compliance issues, but on September 6, 2022, CMD issued a compliance memo that BBJ had remedied their LBE requirements.
 - On December 16, 2022, the PW Commission awarded this project to BBJ Electric.
 - The award package was sent to BBJ on December 27th.

- 19th Avenue EFWS Pipeline Construction contract continued. Expect completion July 2023
- Clarendon Supply EFWS Pipeline Construction contract continued. Expect completion April 2023.
- Fireboat Manifold Construction of new pipeline and fireboat manifold near Fort Mason Pier 2 and Pier 35.5 for fire suppression. Planning in progress.
- Pumping Station 2 Construction contract continued. Expect completion March 2023.

- Vicente EFWS Pipeline Construction contract continued.
- Potable Emergency Firefighting Water System (PEFWS) project Planning for the Richmond and Sunset areas continued.

BOE/FLEET MANAGEMENT (Captain Vince Wong, SFFD)

- BOE is assisting in the logistics of ordering, obtaining, and delivering of supplies critical to the department during the current pandemic. We are currently distributing all necessary PPE to the members.
- Three refurbished 1st-gen Ferrara Engines have been distributed to the field.
- First Ferrara Aerial Truck in service at T13 in downtown area.
- Second Ferrara Aerial Truck final inspection and testing scheduled.
- The Hose Tender build continues at Rosenbauer with "Final" inspection upcoming in December.
- Eight 12-passenger Ford vans and an RC Buggy for the Community Paramedicine Division have now been ordered, but no ETA currently due to auto industry chip/parts shortage. Conversions of two (2) MTA vans and two (2) Paratransit Transport vehicles at upfitters.
- Specs for new Type-1 ambulances were finalized with OCA and put out to bid. Vehicle acquisition request approved by Central Shops to acquire 7 new units. Bidding window now closed, and we are currently in protest period, after which we should be able to award contract and proceed with procurement process for these units.
- Two BME Type-6 Pumpers for wildland/mutual aid are receiving final upfitting at Golden State FA.
- The BOE continues to research and test out new equipment for our firefighters.
- The BOE would like to thank everyone in Support Services for their continued assistance and support. They are a vital part of our crew.

DEPARTMENT ENGINEERING (Stationary Engineer Avo Sarkissian, SFFD)

- Ongoing and routine maintenance at Fire HQ and ADF.
- Tenant improvement project at 1415 Evans remains 80% complete. HVAC units on order as of 7/12/22, with no ETA for units' arrival. EMS has moved in and are occupying building.
- Assisting ADC Serrano with logistics and planning of the new tradespeople potentially being hired in the coming months. Interviews were conducted for plumbers, and one has been tentatively selected to proceed with background process.
- Station 16 fuel oil cabinet was struck by truck; two vendors were contacted to assess and provide estimates, but they were not interested in taking on this project. DPW Plumbing and Steamfitters will now take on this job.
- Station 16 elevator has been continuously out of service for unknown reason; vendor/manufacturer Otis Elevator is currently troubleshooting cause of failure.
- Quote for modernization of elevator at HQ received and submitted to CFO for review; review is currently pending.

CLOTHING DEPOT & LOGISTICS (Lt. Michael Teupel, SFFD)

- The Clothing Depot serviced 149 requests for clothing and PPE repair or replacements during the month of December 2022.
- The first of the Lion PPE orders under the new contract have arrived, and are currently being distributed to the incoming 131st Fire Academy.
- Second order of Lion PPE ready to ship mid-December to begin addressing those members who currently only have one set of PPE due to their existing PPE exceeding life term usage.

- Cliff Rescue units provide cliff rescue and animal safety community outreach in areas such as Fort Funston.
- Sign up for emergency notifications by texting "ALERTSF" to: 888777
- Recruitment efforts continue.
- "See the Red Lights Pull to the Right" campaign for yielding to emergency vehicles is striking comments from the public regarding what to do when they see an emergency vehicle.
- Bicycle safety messages on social media and in public areas promote safe riding habits, wearing helmets, following traffic laws, yielding to pedestrians and emergency vehicles, and more. These efforts are to help reduce bicycle-related accidents and injuries.
- Pedestrian Safety and distracted driver safety messages on social media: "Look don't like" (referring to texting), yield to pedestrians, and share the road with a bicyclist, to name a few.
- P.E.T. safety tips for fire and environment-related issues are placed on social media and shared with media outlets. Examples include: Do not forget your pets when making a home, work escape, or disaster plan."
- Cliff and hiking safety messaging on social media help reduce falls, entrapments, and rescue incidents.
- Information on the station rebuilds and the ESER 2014 BONDS has been posted on social media to help keep the community informed.
- The Department has joined a national fire service campaign: "Close your Door before you Doze." These efforts encourage closing bedroom doors at sleep to increase your chances of survival or saving during a fire. The temperature outside a door can be 1000 degrees, and in the bedroom with a closed door, 100 degrees.
- The Department has teamed up with D.E.M. promoting: "When to Call 911" campaign to help reduce non-emergency calls to 911.
- The Department worked with SF-Environment to promote fire extinguisher disposal.
- The Department assisted SF-Environment with battery safety information and disposed of them properly. When improperly disposed of, old batteries can cause fires. To learn more, visit: www.sfbatterysafe.org
