





## PFAS and the Fire Service

### What are PFAS?

PFAS, or per and polyfluoroalkyl substances, is a large family of manufactured chemicals that have been used in industry and consumer products worldwide since the 1950s.

PFAS do not occur naturally and are found in people, wildlife, and fish all over the world. PFAS are highly persistent and will stay in the body for a long time. PFAS do not breakdown easily in the environment, and are toxic to the environment, animals, and humans.

### How can I be exposed to PFAS?

Fire fighters face an occupational exposure to PFAS through firefighting, training, and daily interactions with flame-suppressing foams (AFFF) and turnout gear.<sup>1</sup> Although some types of PFAS are no longer used, many products may still contain PFAS, including food packaging materials, nonstick cookware, stain-resistant carpet treatments, water-resistant clothing, cleaning products, paints, varnishes and sealants, some cosmetics, as well as AFFF firefighting foam and turnout gear.

### How is my exposure measured?

Exposures are measured through blood serum levels. PFAS compounds penetrate the skin on both animals and humans.<sup>2</sup> Dermal exposure may result in local and systemic toxicity.

Recent studies show that increases in blood serum levels of PFOA can be measured around six hours post dermal exposure to PFOA (C8),<sup>1</sup> demonstrating that skin is likely a significant route of exposure.

### How can PFAS affect your health?



Scientists are still learning about the health effects of exposures to mixtures of PFAS. Scientific studies suggest that certain PFAS may affect different systems in the body. Human research studies suggest that high levels of certain PFAS may lead to increased cholesterol levels; changes in liver enzymes; decreased vaccine response in children; increased risk of high blood pressure or preeclampsia in pregnant women; small decreases in infant birth weights; and increased risk of kidney, non-Hodgkin lymphoma, ovarian, prostate, and testicular cancers.

### How can I reduce my exposure to PFAS?

In addition to occupational exposures, PFAS are present at low levels in some food products and in the environment (air, water, soil, etc.). While you cannot prevent PFAS exposure altogether, you can take steps to reduce your risk of exposure and support additional research that looks into PFAS chemicals:

#### PFAS in Turnout Gear

- Turnout gear should NOT be taken into firehouse living areas.
- When transporting gear in personal vehicles, it should be in a sealed container or bag, and preferably NOT transported in the passenger compartment.
- Apparatus cabs should be cleaned regularly and after every fire.
- Wash your hands after handling turnout gear.





## OFFICER'S CANCER PREVENTION CHECKLIST

*Officers make numerous operational decisions everyday which ensure the safety of their crew. Now you can develop policies that will reduce the risk of cancer for your personnel while also protecting yourself. It is time to change the culture to cut out cancer.*

### SET THE SANDARD

- Set the example by properly donning PPE at all incidents and ensure crew members do also.
- Establish policies for mandatory decontamination whenever crews move from the fire ground. This includes:
  - Using hose lines to perform gross decontamination of bunker gear and SCBAs
  - Providing wet wipes to remove contaminants from all exposed skin
  - Switching crews to B-set gear (if available) until contaminated gear can be cleaned
- Ensure all crew members change and wash uniform clothing immediately upon returning to the station and can "Shower within the Hour".
- Station policies often include the routine washing of apparatus. Similar policies should address the routine washing of hoods and other PPE.
- Ensure personnel are properly trained and use in-station diesel exhaust systems.
- Establish policies for proper storage of PPE and prohibit PPE in living quarters.
- Establish and use personnel injury reporting systems to establish records of exposures.
- Advocate for the establishment of, and participation in, ongoing occupational medical surveillance.

### TRAINING AND TACTICS


- Treat every fire as a hazardous materials call - because it is.
- Include smoke hazards at planning and briefing sessions and in fire behavior forecasts.
- If possible, conduct overhaul 45 minutes after fire extinguishment to allow time for toxic gases to dissipate and ensure all crew performing overhaul operations continue to wear SCBA.

**TB and Hearing:**


We re-implemented OSHA mandated screenings for Hearing and Tuberculosis (via the Quantiferon blood test) using a mobile medical screening team. This allowed members working all over the City to get screened without being out of service for very long. As of January 31, 750 members had been screened. The screening will go on through the end of February.

Members with positive TB tests will get confirmatory tests and if the confirmatory is positive, they will meet with Occupational Health and have a Chest X-ray to make sure they don't have active TB.

Members with a "threshold shift" on their hearing test will be given the results and encouraged to follow up with their regular doctor to discuss options and educated about the process of filing a Worker's Compensation claim.





**FACILITY MAINTENANCE & PLANNING (June Waechtler, SFFD)**

- A total of 185 requests for service were initiated during the month of January 2023, which was a 35% increase from the previous month. Numerous facility issues resulted from the storms that occurred early in the month of January.
- 142 service orders were completed and closed out. Roofing, plumbing and electrical issues made up the majority of the requests.

**PLUMBING**

- Twenty-five (25) service calls were placed to resolve minor plumbing issues (faucet, toilet, urinal repairs; clogged sinks, shower drains) in the month of January 2023.
- Nine (9) sewage backups were reported during January 2023: CRT/BOE three (3), FS 33, 8, 29, 9, 13 and 32.

**HVAC/HEATING/BOILERS**

- Discussed the possibility of ordering "reserve" recirculating pumps for station boilers to minimize downtime. DPW Steamfitters recommended that we wait and see how the replacement B&G pumps are. If satisfactory, DPW will purchase and set aside for SFFD facilities ten (10) of the most frequently used B&G pumps (Series 60).
- 1415 Evans Ave: Installation of new HVAC system. Material is being fabricated. Job site coordination meeting took place in early November. Verified curb dimensions and voltage for new equipment at meeting. Sole source paperwork filed by DPW with OCA; currently under review. ETA for the new equipment is roughly 3-4 weeks out.  
*Status Update: New equipment expected to arrive the second week in February.*
- FS 23: Heater in Officer's Room needs to be replaced including new t-stats, on-off switch. Drying Room needs new heater and exhaust fan. Modifying controls to include timer and on/off switch in or outside Drying Room. Parts on order.
- FS 5: Boiler needs new flue to be fabricated by DPW Sheetmetal Shop; after fabrication and installation of new flue, DPW Steamfitters will run new drain and condensate neutralizer. Material and parts ordered.
- FS 13: Installed new compressor on CO2 Truck. Work completed.
- FS 28: Flushed entire heating system and strainers of fan coil and air handlers; will replace 3 t-stats.  
*Status Update: 75% complete.*
- FS 14: New pulleys, motors and belts were installed on the station's exhaust extractor system to improve intake.  
*Status Update: Work to be completed first week in February.*
- FS 16: Re-piping fuel lines and flex connectors.  
*Status Update: Waiting for materials.*
- FS 29: Boiler's Re-circ pump is 5/5. Parts ordered.

- FS 9: ESTIMATES RECEIVED from DPW Steamfitters to replace furnace: \$48,400.  
*Status Update: Pending approval from Client (SFFD).*
- FS 17 - ESTIMATE RECEIVED to replace Boiler: \$222,000.  
*Status Update: Pending approval from Client (SFFD).*
- FS 13: ESTIMATE RECEIVED for Furnace/Forced air units in dorm; price also includes replacing exiting ductwork: \$50,000.  
*Status Update: Pending approval from Client (SFFD).*
- FS 26: ESTIMATE RECEIVED for Furnace/Forced air units: \$80,000.  
*Status Update: Pending approval from Client (SFFD).*

#### CARPENTRY

No major carpentry issues were reported.

#### CEMENT/ASPHALT

- Two cement/asphalt issues were reported: FS 35 and 32.  
*Status Update: Waiting for estimates from contractor.*

#### ELECTRICAL

- CRT/1415 Evans Avenue - installed new doorbell and Intercom system at front door to assist with visitors and after-hours notifications.  
*Status Update: Work completed.*

#### EXHAUST EXTRACTORS

- FS 22 and 13 reported minor repairs needed to station's exhaust extractors.  
*Status Update: Repairs completed; units return to service.*

#### GENERATORS

- Minor issues were reported with stand-by generators located at FS 20 and FS 22 in the month of January 2023.  
*Status Update: Currently still waiting for some parts, but all units are operational.*

#### GLASS/WINDOWS/SCREENS

- Requested estimate from DPW to replace windows at FS 43.  
*Status Update: Received estimate from DPW Glass Shop (\$10K for Officer's Windows). ADC Serrano to discuss scope of materials with DPW Glass Shop before approval.*

#### LANDSCAPING

No major landscaping issues were reported.

#### PAINT

FS 25 was tagged with graffiti 5 times all in one day. Assigned to DPW for correction.

#### PEST MANAGEMENT

No major pest management issues were reported.

### **E.S.E.R. BOND 2010 NFS – Updates through January 2023**

#### **Seismic Improvement Program (Magdalena Ryor, San Francisco Public Works):**

- **Fire Station 16 (\$14.2M)** – Final Completion was achieved on July 18, 2019. Project is financially completed. Final PA was issued in June 2022.

#### **Additional Focused Scope Program (Sherry Katz, San Francisco Public Works):**

##### **Emergency Generators:**

- **Fire Station 14** – Scope of work: replacement of existing generator with new rooftop generator, new subgrade fuel fill port at the sidewalk in front of the station, and new fuel piping from sidewalk to generator.
  - Building Permit issued on 6/17/21.

**Fireboat Station 35 (\$50.5M)** – Substantial Completion Certificate has been issued; issuance of the Final Completion Certificate is expected during Q1 2023.

#### **Focused Scope Program (Sherry Katz, San Francisco Public Works):**

Total Funding allocated for the Focused Scope Program is \$21,407,279, approved by SFFD on 8/17/17.

Work is complete in 8 of 9 of the Focused Scope categories comprising Roofing, Apparatus Bay Door Replacements, Exterior Envelope Improvements, Windows, Showers, HVAC/Mechanical, Sidewalk/Slabs, and Security Access Control. Work continues to progress through the last scope category, Generator Replacements.

##### **Emergency Generators:**

**FS 2** – Scope of work: replace existing rooftop generator set, structurally strengthen roof structure to support new fuel tank with capacity for 72-hour run time and provide new fuel fill port and piping to generator.

  - On December 16, 2022, the PW Commission awarded this project to BBJ Electric.
  - The award package was sent to BBJ on December 27<sup>th</sup>.
- **FS 18:**
  - Funding will be made available by way of reallocation of funds back to PHS NFS from PHS ADF.
  - An Invitation to Bid will be advertised in 2023, following FS 15 Hose Tower, depending on available remaining funds to implement the construction phase.

**E.S.E.R.—Emergency Firefighting Water System (EFWS) / Auxiliary Water Supply System (David Myerson, Ada Zhu SFPUC)**

- 19<sup>th</sup> Avenue EFWS Pipeline – Construction contract continued. Expect completion July 2023
- Clarendon Supply EFWS Pipeline – Construction contract continued. Expect completion June 2023.
- Fireboat Manifold – Construction of new pipeline and fireboat manifold near Fort Mason Pier 2 and Pier 35.5 for fire suppression. Planning in progress.
- Pumping Station 2 – Construction contract continued. Expect completion June 2023.
- Vicente EFWS Pipeline – Construction contract continued.
- Potable Emergency Firefighting Water System (PEFWS) project – Planning for the Richmond and Sunset areas continued.

**BOE/FLEET MANAGEMENT (Captain Vince Wong, SFFD)**

- BOE is assisting in the logistics of ordering, obtaining, and delivering of supplies critical to the department as the global pandemic finally begins to recede. We are currently distributing all necessary PPE to the members.
- Three refurbished 1<sup>st</sup>-gen Ferrara Engines have been distributed to the field.
- First Ferrara Aerial Truck in service at T13 in downtown area.
- During acceptance testing for the second Ferrara Aerial Truck, several performance issues and spec discrepancies were identified. Ferrara will be dispatching a team of mechanics to address and resolve these issues in February.
- The Hose Tender build at Ferrara is approaching completion; “Final” inspection occurred in December 2022, which resulted in a punch list of final corrections to address any outstanding issues. Currently awaiting delivery of several parts to Rosenbauer plant in Minnesota before final punch list items can be completed.
- Eight 12-passenger Ford vans and an RC Buggy for the Community Paramedicine Division have now been ordered, but no ETA currently due to auto industry chip/parts shortage.
- Conversion of one MTA minivan and one Paratransit Transport van for Community Paramedicine are complete and have been delivered. One MTA van and one Paratransit Transport vehicles are still currently at upfitters.
- Specs for new Type-1 ambulances were finalized with OCA and put out to bid. Vehicle acquisition request approved by Central Shops to acquire 7 new units. Bid was awarded to Braun Northwest, and pre-construction phase will begin in March 2023.
- Two BME Type-6 Pumpers for wildland/mutual aid are receiving final upfitting at Golden State FA.
- The BOE continues to research and test out new equipment for our firefighters.
- The BOE would like to thank everyone in Support Services for their continued assistance and support. They are a vital part of our crew.

### **DEPARTMENT ENGINEERING (Stationary Engineer Avo Sarkissian, SFFD)**


- Ongoing and routine maintenance at Fire HQ and ADF.
- Tenant improvement project at 1415 Evans remains 80% complete. HVAC units on order as of 7/12/22, with no ETA for units' arrival. EMS has moved in and are occupying building.
- Assisting ADC Serrano with logistics and planning of the new tradespeople potentially being hired in the coming months. One plumber was tentatively selected, and we are currently waiting on HR for hiring and onboarding process.
- Station 16 fuel oil cabinet was struck by truck; two vendors were contacted to assess and provide estimates, but they were not interested in taking on this project. DPW Plumbing and Steamfitters will now take on this job.
- Station 16 elevator has been continuously out of service for unknown reason; vendor/manufacturer Otis Elevator is currently troubleshooting cause of failure.
- Quote for modernization of elevator at HQ received and submitted to CFO for review; review is currently pending.

### **CLOTHING DEPOT & LOGISTICS (Lt. Michael Teupel, SFFD)**

- The Clothing Depot recently outfitted the 131<sup>st</sup> Fire Academy, consisting of 56 recruits.
- Following the 131<sup>st</sup>, there are two MES academies beginning – an H3-L2 and an H3-L1, which will be out fitted for their training. Potentially 35 recruits.
- The Clothing Depot is also currently purchasing and planning for these graduations, and for the upcoming wildland season.
- In addition to the above outfitting, the Clothing Depot received 254 requests for clothing and PPE replacement/repairs that were handled.





**REVOLVING MONTHLY OUTREACH**

- Multiple Public Safety announcements were provided throughout the month.
- Engine companies continue to distribute fire prevention and education material on calls to the public. This material is now available on our website in multiple languages.
- Coastal Rescue companies continue to give Surf Hazard Education to the community while on calls or while out in public (Targeted to Ocean Beach Area)
- Cliff Rescue units provide cliff rescue and animal safety community outreach in areas such as Fort Funston.
- Recruitment efforts towards all populations continue.
- "See the Red Lights Pull to the Right" campaign for yielding to emergency vehicles is striking comments from the public regarding what to do when they see an emergency vehicle.
- Bicycle safety messages on social media and in public areas promote safe riding habits, wearing helmets, following traffic laws, yielding to pedestrians and emergency vehicles, and more. These efforts are to help reduce bicycle-related accidents and injuries.
- Pedestrian Safety and distracted driver safety messages on social media: "Look don't like" (referring to texting), yield to pedestrians, and share the road with a bicyclist, to name a few.
- Pet safety tips for fire and environment-related issues are placed on social media and shared with media outlets. Examples include: Do not forget your pets when making a work escape or disaster plan."
- Cliff and hiking safety messaging on social media help reduce falls, entrapments, and rescue incidents.
- Information on the station rebuilds and the ESER 2014 BONDS has been posted on social media to help keep the community informed.
- The Department has joined a national fire Service campaign: "**Close your Door before you Doze.**" These efforts encourage closing bedroom doors at sleep to increase your chances of survival or saving during a fire. The temperature outside a door can be 1000 degrees, and in the bedroom with a closed door, 100 degrees.
- The Department has teamed up with D.E.M. promoting: "When to Call 911" campaign to help reduce non-emergency calls to 911.
- The Department worked with SF-Environment to promote fire extinguisher disposal.
