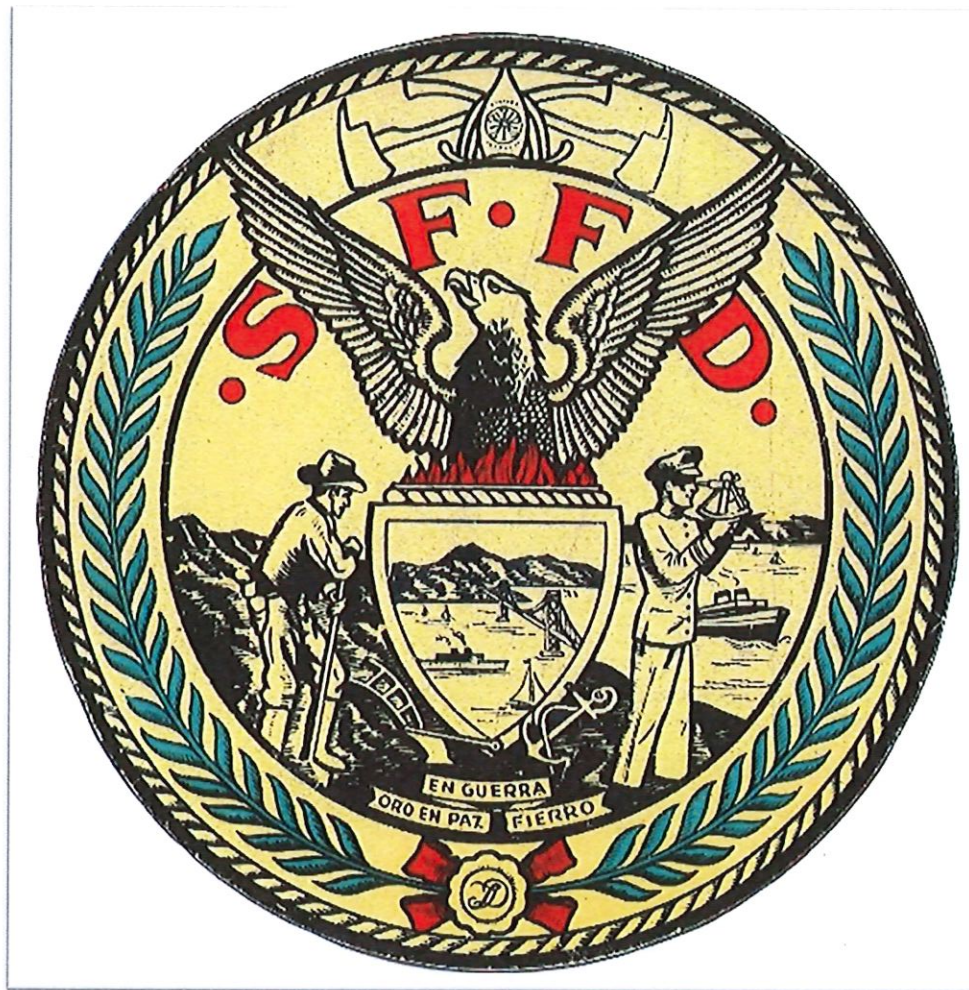

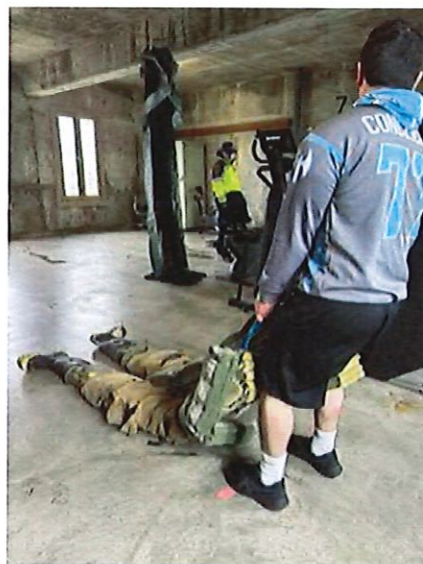

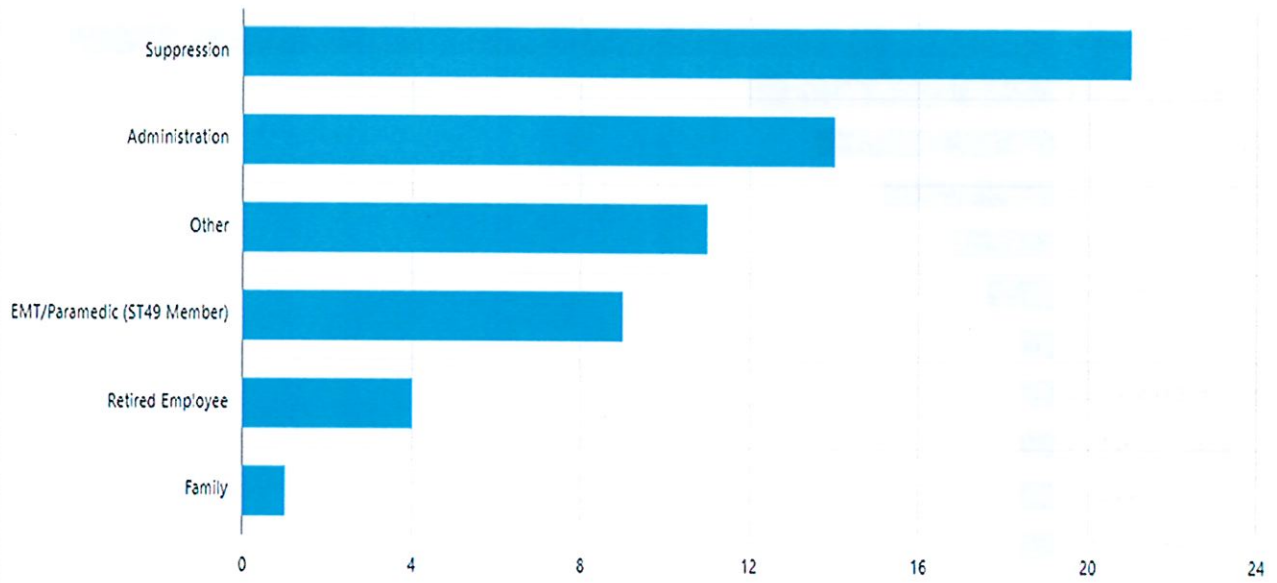
**Commission Meeting Report for Health, Safety, and Wellness March 2023**

- **Staffing:**
  - Captain Heather Buren was hired for the H39 BHU position
  - FF Chelsea Nelson was hired as a Navigator. The third H16 Navigator position recruitment in progress. High importance placed on finding the “right” fit
  - Generating a Navigator relief list is a high priority, we have generated a list of 20 names and after the training on 4/26, the list will be active.
- Met with Jeanette Longtin of **SFHSS**, we are going to have regular meetings, once a month, in-person to make sure we are aligned with SFHSS and the BHU.
- **Cancer Champions**
  - “Cancer Champions” is a concept that is a collaboration between: The San Francisco Firefighters Cancer Prevention Foundation (SFFCPF), The Division of Training (DOT), The Office of Health, Safety, & Wellness (HSW), The Office of Employee Health (OEH), Local 798, and DetecTogether.
  - Modeled after the 798 Station Stewards, these Cancer Champions will insure sharing monthly updates to the field about Cancer Awareness & Early Detection. DetecTogether will be providing the content to send to the Cancer Champions.
- **Violence in the Workplace**
  - Met w/ CD3, 798 rep. A. Sims, S.C. Craig, S.C. Sloan, & DA Jenkins & ADA Merin to discuss
  - Met with Sgt. Laura Colin (SFPD) and Lt. Mario Molina (SFPD) about Violence in the Workplace (VIW) to see if we can get training on De-Escalating techniques.
    - Talked about having a code that would designate **NEED ASSISTANCE RIGHT NOW “904-A”**

- Presented a 4-hour **Stress Reduction and Mental Health** introductory training to H-2 recruits on 3/14
- Research & Development of Trauma Informed Care presentation
- Mtg with Community Paramedicine to review training structure and resources
- **BHU Stats** for the month of March (**attached**)
  - Logged 150 hours with 45 members
  - Stress factors of members: family/marital, bereavement, pediatric code stress, EtOH/substance abuse, career stress, depression
  - Education and training with members, recruits, comPsych, EAP and clinicians
  - Approx 26 suppression members, 10 Station 49 members and 5 Retired members
- **Debriefings:**
  - Community Paramedicine division lost one of their “peer counselors” to an overdose 10 days ago. Jennifer Greene led 2 separate debriefings for the Unit on 3/25 and 3/27 (over 50 people in all)
    - The BHU was able to support not only our own members, but members of RAMS (Richmond Area Multis Service a subcontractor of DPH) and Hot Team (Heluna Health)
  - Crew debrief at 49 after a pediatric resuscitation, follow up with Engine 43 and RC4
- **New Quarters for BHU** in Old 21 (1152 Oak St.)
- Lexipol (**SFFD Wellness App**) had its First Responder Wellness Week (March 27–31)
  - to support, raise awareness and promote strong self-care among public safety workers. This inaugural week-long event is designed to honor and celebrate the contributions of first responders while also providing them with valuable tools and resources to help manage the stress and trauma associated with their jobs.

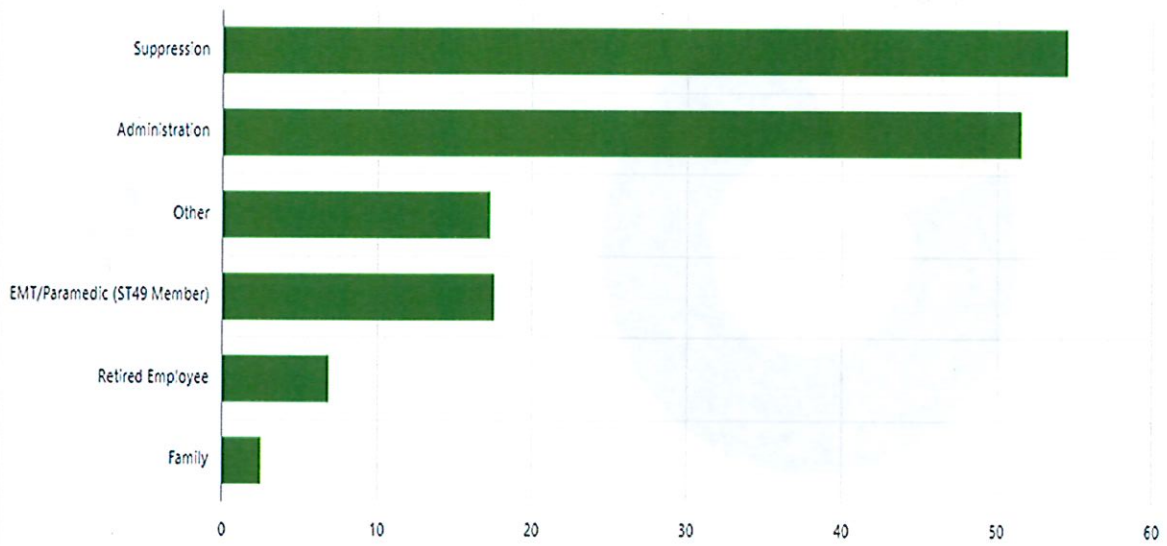

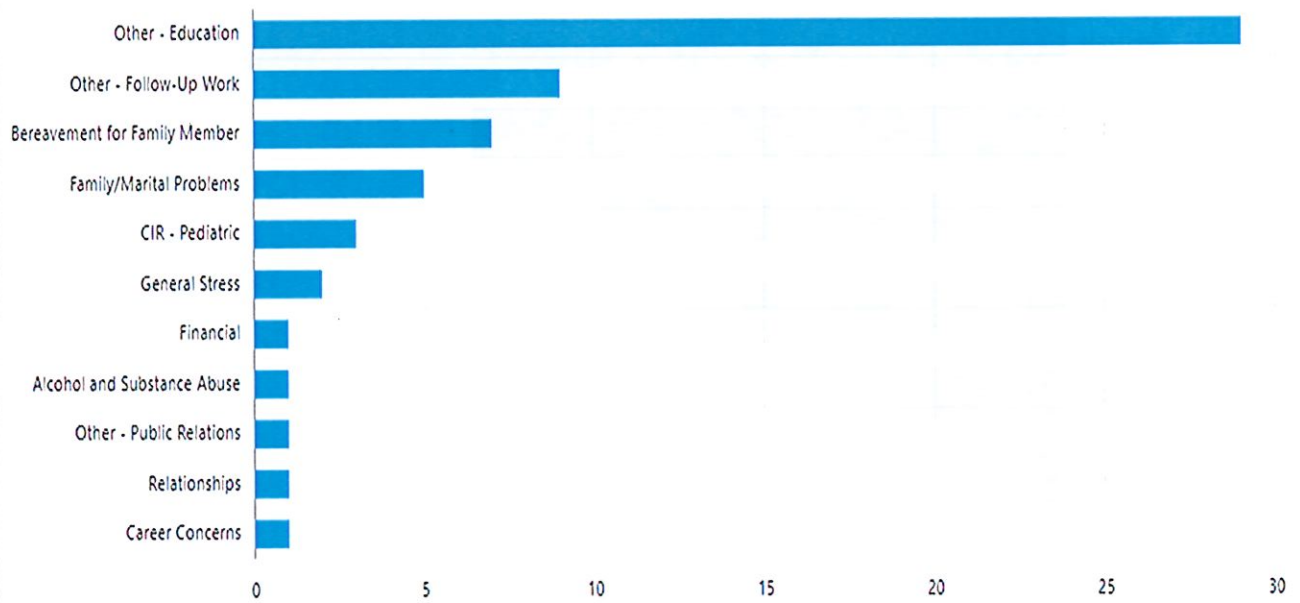

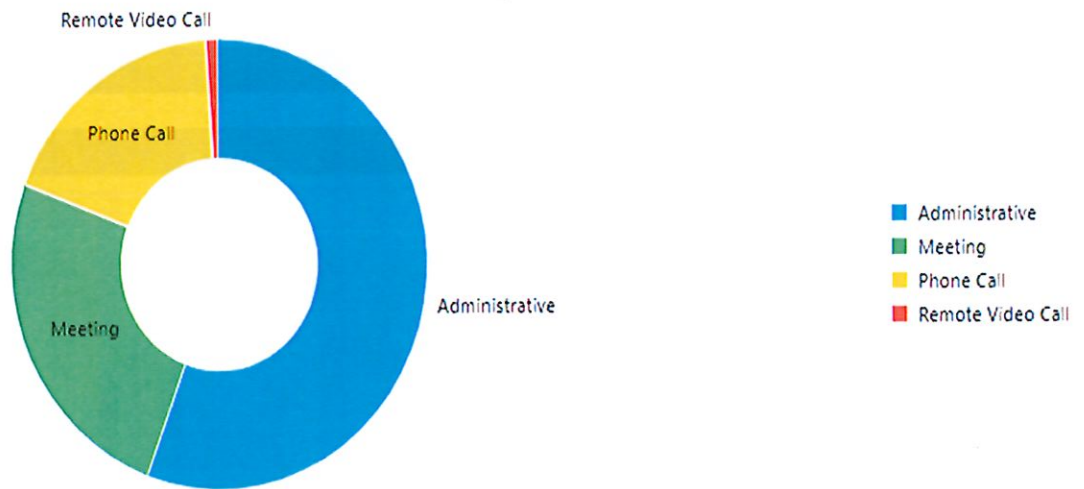
Hours By Work Group

Total Hours By Activity

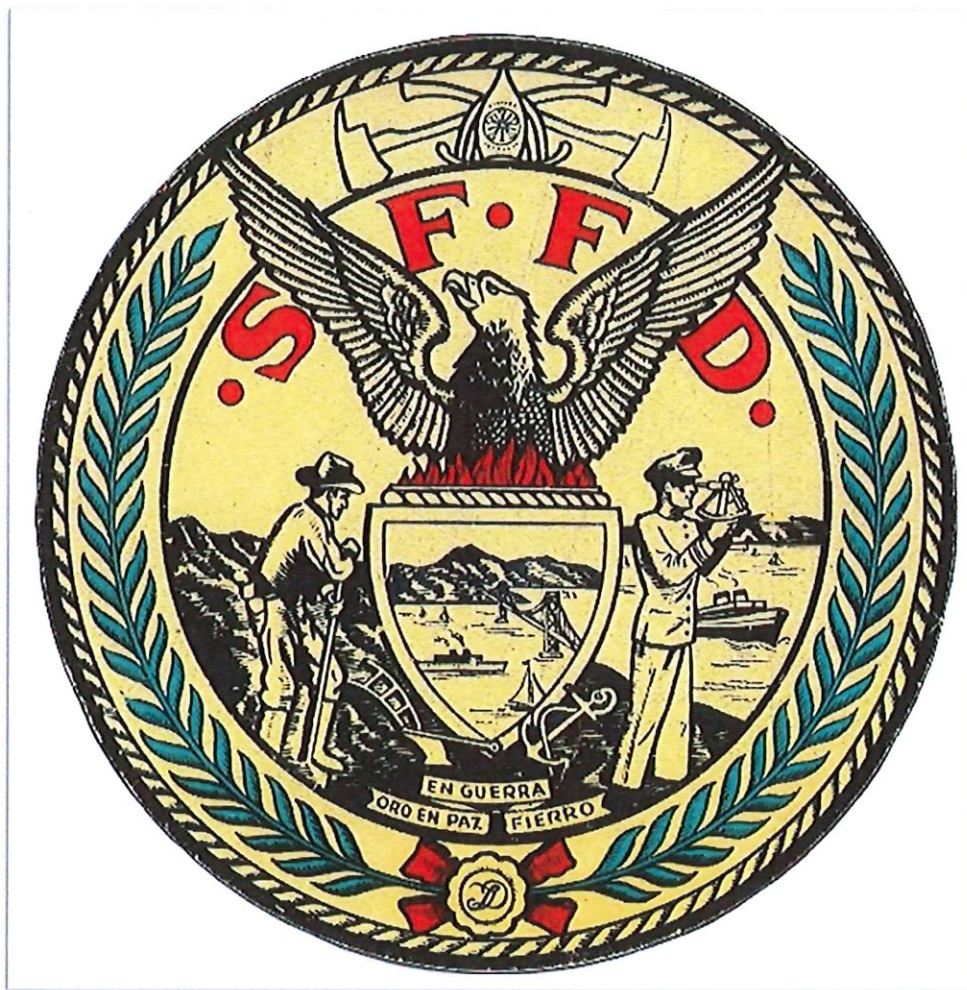

March was the end of probation for the graduates of the March 2022 EMS Academy. It was great to check in with members and hear about their first year in the field. All members passed their end of probation medical screen. We also completed our first TB and Hearing screening in several years.

**Number of New Positive TB cases: 6**

All members who had positive Quantiferon assays had a repeat test, and 6 were confirmed positive. All had follow up chest x-rays to rule out active disease, none had any chest x-ray findings or symptoms of Tuberculosis. They will follow up with Occupational Health to discuss whether or not they will take treatment for latent TB. Having latent TB is not a risk to co-workers or patients, but there is a risk that they will convert to active TB at some point. All known cases of latent TB in the Department will be screened for any TB symptoms annually.

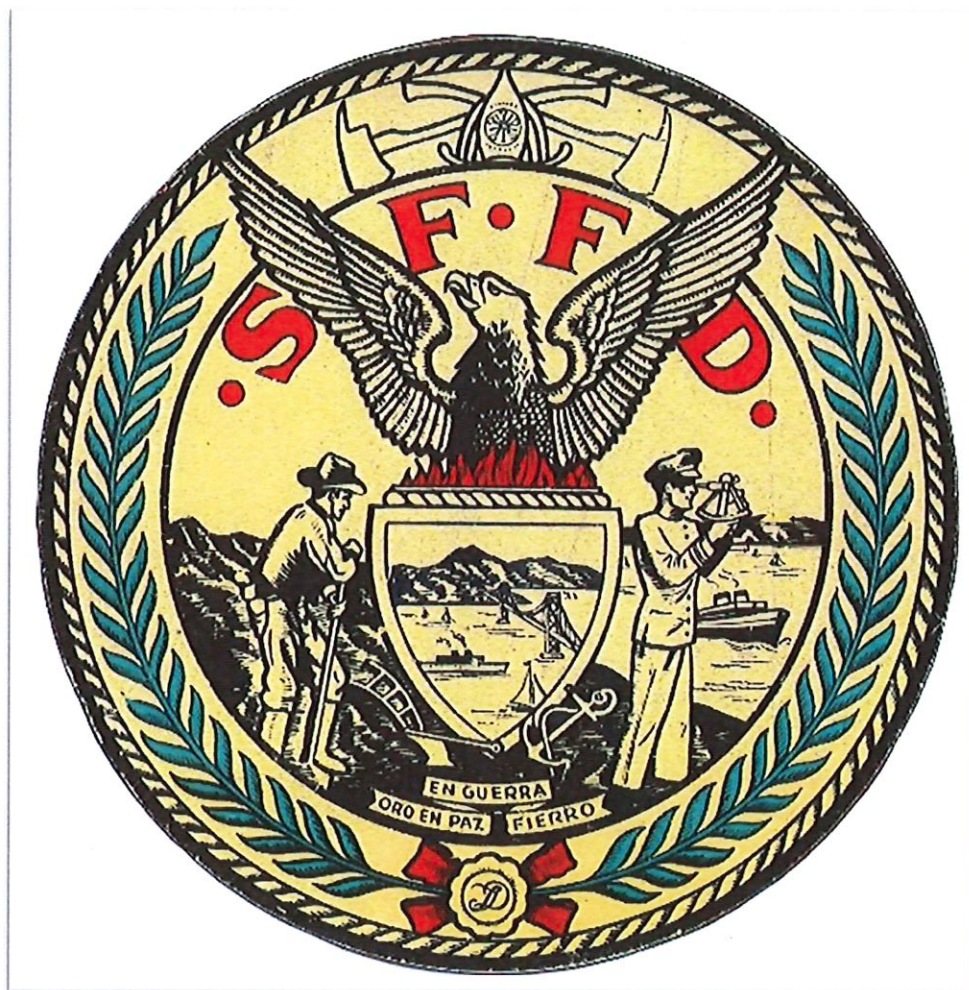

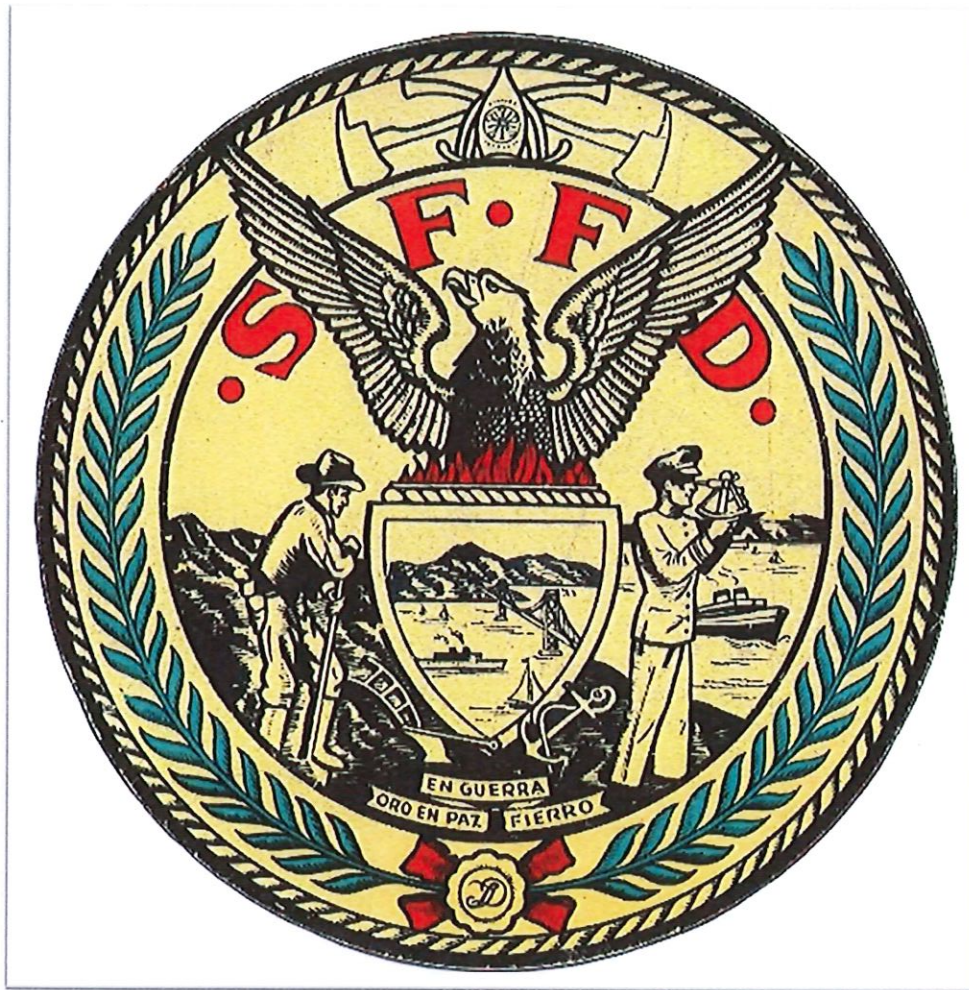
List of recent activity in the Assignment office for **March 2023**

1. Assignment Office is working with EMS Division and Community Paramedicine for on-going staffing and scheduling.
2. Assignment changes for Fire Suppression, all ranks.
3. Ongoing work with Fire Prevention on staffing and new promotions.
4. Ongoing work with Fire Pay roll for discrepancies for every pay period.
5. The EMS WDO-In-Advance continues per General Order 20 A-08. In accordance with the policy, pre-hiring 75% of open ambulance shifts seven days in advance.
6. Continues to assist Physician's Office with assigning personnel to Temporary Modified Duty Positions.
7. Continue new WDO-In-Advance Pilot Policy for Suppression members, General Order 21A-64. Pre-hiring of 50% of shortage seven days in advance on Thursday, Friday, Saturday, and Sunday.
8. Continue Mandatory Credit given WDOs for weekends to increase voluntary WDOs.





# Support Services

**FACILITY MAINTENANCE & PLANNING (June Waechtler, SFFD)**

- A total of 200 requests for service were initiated during the month of March 2023. This was an increase of 65% from the previous month's submissions.
- 165 service orders were completed and closed out in March 2023. Roofing, fuel tanks, plumbing and electrical issues made up the majority of the requests.

The Bay Area experienced two major storms during the month of March. Both storms brought significant rain and high winds to the region. As a result, twenty-eight fire stations and facilities were impacted with roof leaks, water intrusion, sewer backups and minor to major property damages were reported.

After a State of Emergency was declared on March 8, 2023, a detailed list with itemized losses (*estimates*) was created. A claim for reimbursement totaling \$307,350 was submitted to Director Corso on March 31, 2023. A copy of the claim that was submitted to the Controller's Office for reimbursement consideration is below.

In January, the department also submitted a \$335,000 claim to CA Office of Emergency Services, FEMA after a State of Emergency was declared for damages endured during the winter storms of 2022. Reimbursement from this claim was unfortunately denied.

#### PLUMBING

- Seventeen (17) service calls were placed to resolve minor plumbing issues (faucet, toilet, urinal repairs; clogged sinks, shower drains) in the month of March 2023.
- Eleven (11) sewage backups were reported during March 2023 most occurring during storm activity (February we experienced 1 backup). Stations that experienced sewage backups were: 1415 Evans Ave., BOE 25<sup>th</sup> Street, FS 26, 11, 9, 7, 28 (2 ea), 36, 8 and 43. Charges for these emergency plumbing services will be costly.

## HVAC/HEATING/BOILER

- 1415 Evans Ave: Installation of new HVAC system. Material is being fabricated. Job site coordination meeting took place in early November. Verified curb dimensions and voltage for new equipment at meeting. Sole source paperwork filed by DPW with OCA; currently under review. ETA for the new equipment is roughly 3-4 weeks out. New equipment expected to arrive the second week in February.  
*Status Update: Equipment was delivered. Anticipate units will be crane picked early-mid April. DPW's Steamfitters and Sheetmetal Teams will be setting the new units in place. Steamfitters will proceed with installing new gas piping and thermostats the following week.*
- FS 23: Heater in Officer's Room needs to be replaced including new t-stats, on-off switch. Drying Room needs new heater and exhaust fan. Modifying controls to include timer and on/off switch in or outside Drying Room.  
*Status Update: Project temporarily on hold while other options are being considered.*
- FS 5: Boiler needs new flue to be fabricated by DPW Sheetmetal Shop; after fabrication and installation of new flue, DPW Steamfitters will run new drain and condensate neutralizer.  
*Status Update: Project temporarily on hold until funding is available.*
- FS 28: Flushed entire heating system and strainers of fan coil and air handlers; will replace 3 t-stats. Pump was replaced and 2 of the 3 T-stats have been replaced. The last of the 3 T-stats will be installed week of March 13th. *Status update: New equipment is not syncing with older equipment plus multiple zones with inadequate heat. Additional control valves and thermostats are needed. Waiting on SFFDs approval for 3 days labor plus \$3,000 parts.*
- FS 14: New pulleys, motors and belts were installed on the station's exhaust extractor system to improve intake. Fan not performing as designed. Rep from Nederman (manufacturer of the exhaust extractor) scheduled to come on-site for inspection in mid-March.  
*Status update: Feedback from manufacturer recommends a different exhaust fan for exhaust extractor. DPW's Steamfitters and ADC Serrano are in negotiations to determine fair pricing for new exhaust fan.*
- FS 16: Re-piping fuel lines and flex connectors.  
*Status Update: New cabinet for fuel lines arrived; waiting for DPW labor.*
- FS 16: Suspected radiator leak.  
*Status update: DPW will replace radiator valve and see if leak stops. If not, we may need a new radiator.*
- FS 29: Boiler's Re-circ pump is 5/5.  
*Status Update: DPW is waiting for materials.*

- The BOE continues to research and test new equipment for our firefighters.

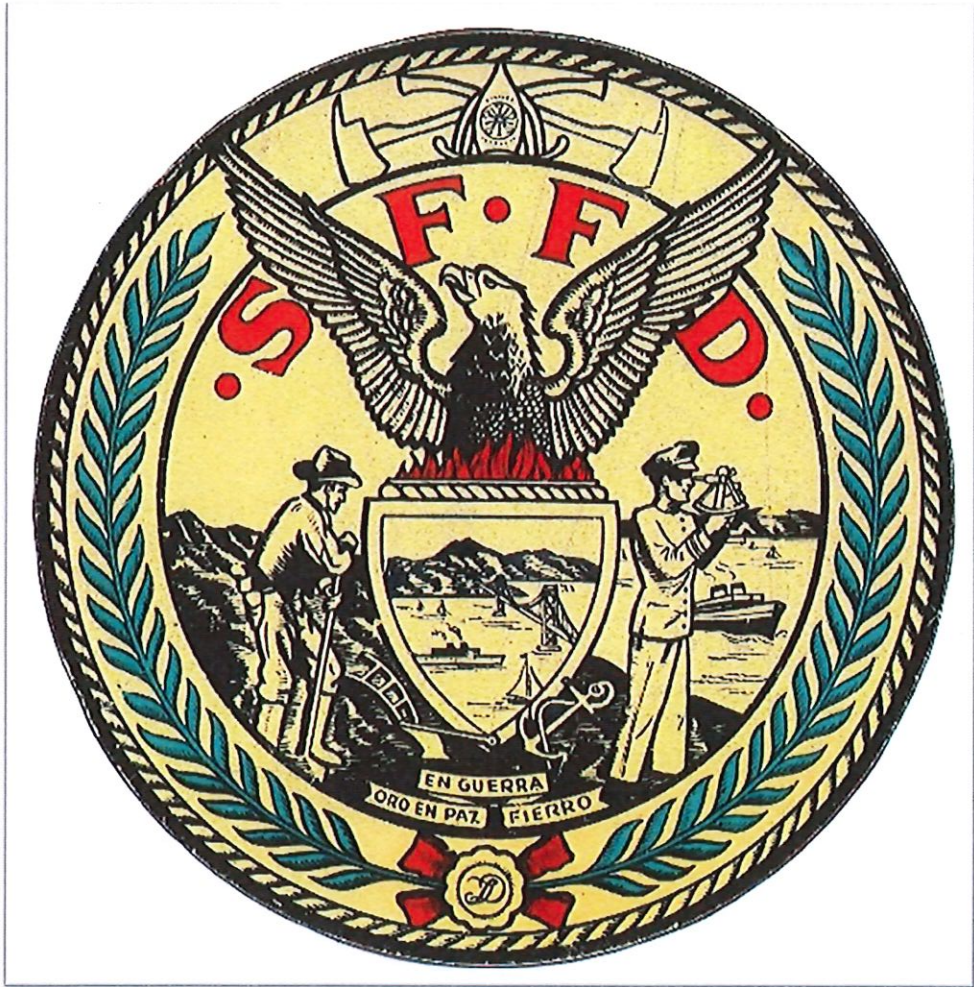
**DEPARTMENT ENGINEERING (Stationary Engineer Avo Sarkissian, SFFD)**

- Ongoing and routine maintenance at Fire HQ and ADF.
- Tenant improvement project at 1415 Evans remains 80% complete. HVAC units have finally been delivered to the crane company. DPW Steamfitters are coordinating logistics with the crane company for installation of these units.
- Assisting ADC Serrano with logistics and planning of the new tradespeople potentially being hired in the coming months. We are currently working with HR to hire an on-staff plumber.
- Station 16 fuel oil cabinet was damaged when struck by truck. DPW Steamfitters have removed the cabinet, and a new replacement cabinet is expected to arrive in mid-March.
- Station 16 elevator has been continuously out of service for a number of months. After extensive testing, the source of the problem was isolated & determined to be the amount of incoming voltage. PG&E is now assigned to try to resolve.
- Quote for modernization of elevator at HQ received and submitted to CFO for review; review is currently pending.

**CLOTHING DEPOT & LOGISTICS (Lt. Michael Teupel, SFFD)**

- During this last month the Clothing Depot has fulfilled 242 requests from the field for clothing and PPE repair, replace, or new due to promotion.
- The Clothing Depot and Banner Uniform also completed the outfitting of EMS class 9 graduation of 7 members & outfitting 17 entering the EMS class 23.
- The Clothing Depot is expecting two deliveries for Fire PPE (turnouts) on 5/19 & 6/2/2023 for the fulfillment of the 131<sup>st</sup> second set upon graduation, and for the outfitting of the first set for those entering into the 132<sup>nd</sup> Fire Academy .

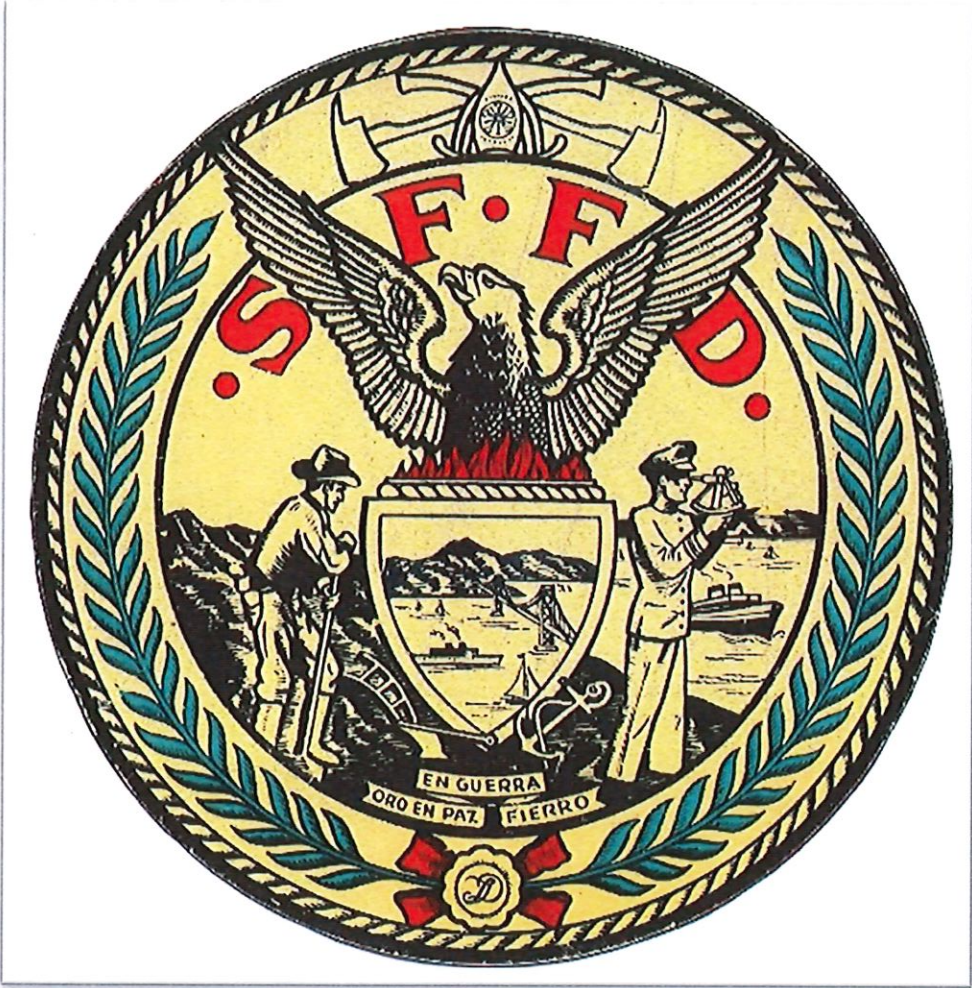

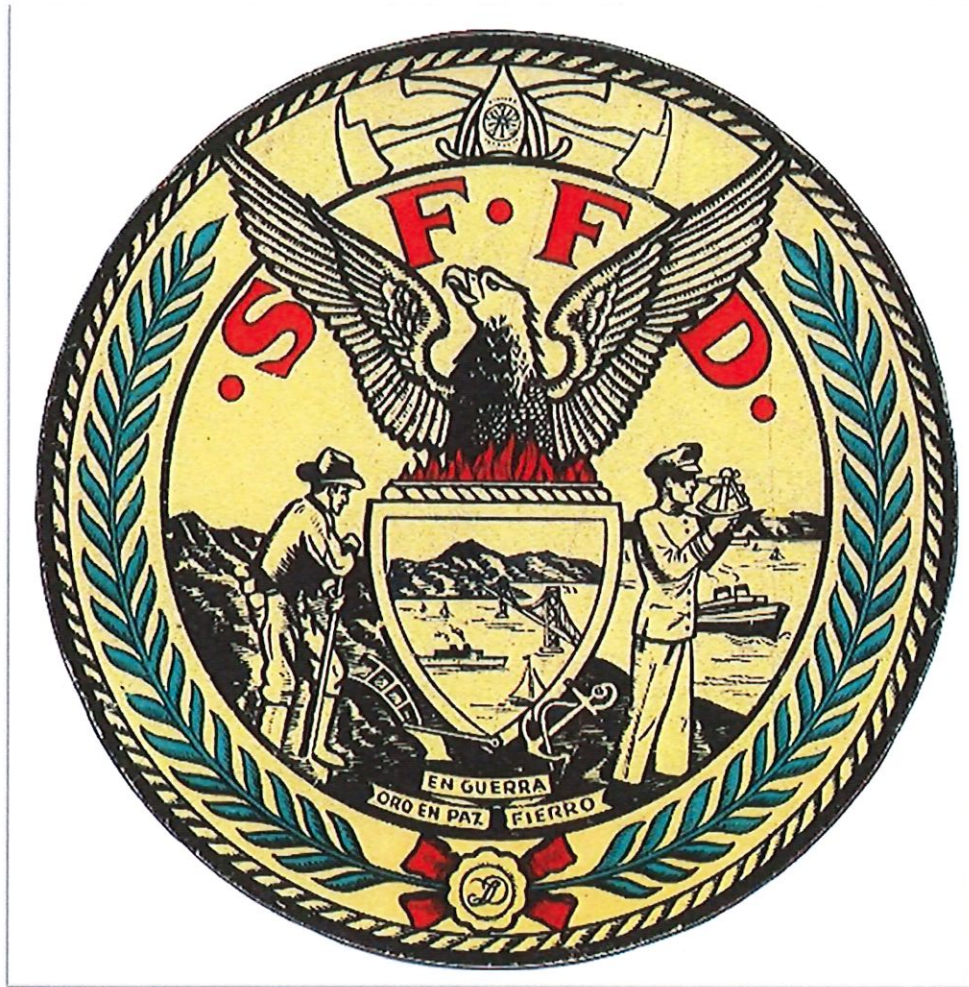

- Multiple Public Safety announcements were provided throughout the month.
- Engine companies continue to distribute fire prevention and education material on calls or the public. This material is now available on our website in multiple languages. To download, visit: [www.sf-fire.org](http://www.sf-fire.org)
- Coastal Rescue companies continue to give Surf Hazard Education to the community while on calls or while out in public (Targeted to Ocean Beach Area)
- Cliff Rescue units provide rescue and animal safety community outreach in areas like Fort Funston.
- Recruitment efforts continue.
- "See the Red Lights Pull to the Right" campaign for yielding to emergency vehicles is striking comments from the public regarding what to do when they see an emergency vehicle.
- Bicycle safety messages on social media and public areas promote safe riding habits, wearing helmets, following traffic laws, yielding to pedestrians and emergency vehicles, and more. These efforts are to help reduce bicycle-related accidents and injuries.
- Pedestrian Safety and distracted driver safety messages on social media: "Look don't like" (referring to texting), yield to pedestrians, and share the road with a bicyclist, to name a few.
- Pet safety tips for fire and environment-related issues are placed on social media and shared with media outlets. Examples include: Do not forget your pets when making a home, work escape, or disaster plan."
- Cliff and hiking safety messaging on social media help reduce falls, entrapments, and rescue incidents.
- Information on the station rebuilds and the ESER 2014 BONDS has been posted on social media to help keep the community informed.
- The Department has joined a national fire Service campaign: "[Close your Door before you Doze.](#)" These efforts encourage closing bedroom doors at sleep to increase your chances of survival or saving during a fire. The temperature outside a door can be 1000 degrees, and in the bedroom with a closed door, 100 degrees.
- The Department has teamed up with D.E.M. promoting: "When to Call 911" campaign to help reduce non-emergency calls to 911.
- The Department worked with SF-Environment to promote fire extinguisher disposal.
