4. CHIEF OF DEPARTMENT'S REPORT [Discussion]

REPORT FROM CHIEF OF DEPARTMENT, JEANINE NICHOLSON

Report on current issues, activities, and events within the Department since the Fire Commission meeting on April 12, 2023, including budget, academies, special events, communications, and outreach to other government agencies and the public.

Chief Nicholson reported on activities since the last meeting. She mentioned that in preparation for warmer water, Surf Rescue training is being offered. She also announced the upcoming retirement of Assistant Deputy Chief Ramon Serrano of Support Services and that they have posted a General Order for members to apply to replace his position. She stated that she and three deputies visited the Department of Emergency Management in honor of 9-1-1- dispatch week. She mentioned that they had an H-3 Level 2 graduation, a NERT drill, and the Cherry Blossom Festival. She also attended a labor-management meeting where they have done their best to maintain a good relationship with the union despite the challenges they are facing. She expressed her concerns about a potentially large number of retirements that could happen in June. She touched briefly on the budget, including getting money reallocated within the existing budget for overtime.

Vice President Morgan thanked Chief Nicholson for her report and congratulated Chief Serrano on his upcoming retirement.

There was no public comment.

REPORT FROM ADMINISTRATION, DEPUTY CHIEF TOM O'CONNOR Report on the Administrative Divisions, Fleet and Facility status and updates, Finance, Support Services, Homeland Security, and an update from Assistant Deputy Chief, Darius Luttropp, ESER

Project Manager.

Chief O'Connor presented his report for February 2023. He mentioned that they had a National Weather Service briefing, the Federal Department of Homeland Security and the Secret Service working together for the Vice President's visit, the St. Patrick's Day parade, and the national CERT/NERT conference planning meeting. He described other activities/events he attended during the reporting period. He touched on the Diversity, Equity, and Inclusion Division, the Health, Safety, and Wellness Division, and the

Behavioral Health Unit. NERT, the Office of Employee Health, and the Support Services Division. He described the slides in his report in detail and played a video that was part of Women's History Month. His report is attached: https://sf-fire.org/media/2752/download?inline.

Commissioner Collins confirmed that the \$307,000.00 storm damage to Station 35 will not be reimbursed by FEMA.

Chief Luttropp, Assistant Deputy Chief of Earthquake, Safety and Emergency Response Bond Project Management introduced himself and provided a brief overview of his position as manager overseeing the ESER Bond Program. His report is attached: https://sf-fire.org/media/2753/download?inline.

Commissioner Collins confirmed that with the Bonds, they can define the scope of work with their Public Works partner and that ESER Bond 2010 is nearly closed out and they will fold all remaining work from 2010 into the 2014 ESER Bond.

Vice President Morgan thanked Chief Luttropp for his comprehensive report and stated he appreciates the explanation on the Bonds.

President Nakajo thanked Chief Luttropp for his report and clarity of the responsibility of the ESER Bonds and he acknowledged Chief Nicholson for providing support to Chief Serrano on all the work that is handled by his unit. Chief Luttropp introduced two of his team members, Scott Moran, project manager at Public Works, and Captain Roger Ng of Support Services. President Nakajo stated that the training facility is important and with coordination, communication, and working on the same goal, he thinks will be important. He thanked Chief Serrano for all the hard work he has done over the years.
