August 1 – August 31, 2023

GREATER ALARMS:

There were two Greater Alarm fires during this reporting period.


 4^{th} Alarm – (8/1/23) 0555 hours, 300 Octavia Street, cross streets Oak and Hickory streets. There were no injuries. The cause of this fire is under investigation. (Assistant Chief William Storti)


On August 1, 2023, a full box was dispatched at 0555 hours to 240 Gough Street for a fire in the building. There was no delay in response or reporting. There was no failure in fire protection as the building was under construction.

Engine 36 arrived on scene and declared a working fire for a multi-unit building under construction Battalion 2 came on scene and called a 2nd alarm and established Octavia Street command. The main obstacle for the fire was a building under construction fully involved on all floors with exposures on the Bravo and Delta sides. The volume of fire made ladder-pipe operations on the Alpha side of the building untenable due to radiant heat. The main fire building was a total loss. Two exposures on the Delta and Bravo sides sustained fire and water damage.

Battalion 2 immediately established defensive operations on the fire building ordering Truck 5 on the delta side and Truck 06 on the Alpha/Bravo corner to set up ladder pipes. Engine 3 gained its own supply and started offensive operations in Delta 2 then Delta. Engine 36 started offensive operations on Bravo and Bravo 2, with assistance from Engine 5. Engine 21 supplied trucks 5 and 6, then assisted Engine 3. Battalion 2A and RS1 performed a quick primary search of exposure buildings and evacuations/rescues. Division 2 assumed command and assigned Battalion 2 Fire attack/Delta. RS1, E01 were assigned to fire attack and extinguished fires on roofs. Battalion 5 was assigned to Bravo command. 3rd and 4th alarms were struck. Truck 11 set up a ladder pipe on Bravo side while Truck 7 and RS2 led a line to the roof of Delta to contain the fire. Battalion 3 was assigned to the Bravo/Charlie side and Battalion 6 was assigned safety. Greater alarm companies were assigned to ICS groups as needed.

Many operations worked well, including first alarm companies attacking the fire from the exposure buildings which stopped the spread of the fire. Truck companies efficiently set up ladder pipes. Drone operations were very useful in repositioning master streams for optimal effect but should have been utilized earlier. However, Command should clear up confusion over exposure identification. DEC should have been able to handle City coverage without units working at incident. Tablet Command was underpowered for dealing with 4th alarm, Lastly, buggy should have been used to assist with command post.













3rd Alarm – (8/8/23) 2011 hours, 1279 8th Avenue, cross streets Lincoln Way and Irving Street. There were no injuries. The cause of this fire is under investigation. (Assistant Ken Yee)

On August 8, 2023, a Fire in the Building was dispatched for 1279 8th Avenue. 911 callers described fire and smoke visible on the ground floor. Division 2, Engines 12 and 22, Trucks 12, 14, Battalion 5, Rescue Squad 1, and Medic 67 were dispatched.

Lieutenant Waters, Engine 22, arrived on scene and reported light smoke showing on the ground floor. Engine 22 searched inside the building and in the garage area but was unable to locate the origin of the smoke. Lieutenant Hua, Truck 12 arrived next, and ordered three members to access the roof with their 35' extension ladder while assisting Engine 22's crew with forcible entry and to help search for the seat of the fire. Battalion 5, Chief Maloney, arrived on scene, established Command, and assigned other companies to search the tradesmen alleyway, the interior, and the rear of the building to locate the smoke's source.

Eventually, Truck 12 notified Command that the fire was in the exterior Bravo/Charlie area of the original Fire Building (1279 8th Avenue) and extended into a shed in the Charlie Exposure (724 Irving Street). Division 2 quickly declared a Working Fire and assumed Command of the incident, assigning BC Maloney as the Fire Attack Group Supervisor.

Physically getting to the seat of the fire was difficult. A fence in the rear impeded access to the fire from the tradesmen's alley of the Fire Building. Companies that went around and/or through the Fire Building found that the rear of the Fire Building butted up against the Charlie Exposure, preventing these companies from gaining access to the Bravo/Charlie area. Once the Rescue Squad found access through the tradesmen's alley of the Bravo Exposure (1285 8th Avenue) companies had access to the seat of the fire.

As the fire extended to the walls of the Fire Building and the Charlie Exposure building, a second alarm was struck. The Charlie Exposure building, Progress Hardware Store, was closed for the day. Battalion 8, Chief Sato, arrived on the second alarm, and led second alarm companies (Engine 20, Engine 40 and Truck 18) into the hardware store from Irving Street to contain and extinguish any fire. The fire entered the hardware store from the shed in the rear. Due to the narrow aisle ways packed with merchandise, firefighters had a difficult time leading their charged hose lines through the hot, smokey aisles to the fire.

Once the seat of the fire was accessible, firefighters quickly contained and extinguished all visible fire. Checking for fire extension proved difficult in the original Fire Building, as the fire had burned through the exterior walls and traveled up and into the void spaces. The exterior walls of the Fire Building were reinforced with double sheer walls, so firefighters had to breach two layers of plywood, in addition to the exterior siding in order to search for any hidden fire. This effort was time-consuming and labor-intensive.


A third alarm was struck to provide some much needed relief for firefighters on scene. For the size and extent of the fire, and the length of time firefighters had to search for and to extinguish this fire, it was fortunate that there were no injuries to our members.

Due to extensive damage in the Fire Building, electrical power could not be restored and Red Cross was contacted to assist with seven displaced adults. DBI was on scene and red tagged the Fire Building. MUNI traffic on Irving Street was disrupted during the initial stages of our operations.

The Fire Reserves responded quickly and assisted as needed. They remained on scene until the fire was extinguished and helped pick up and reload hose and refill SCBA bottles.


The third alarm fire at 1279 8th Avenue began between buildings and quickly spread to impact the Fire Building and two neighboring buildings. The fire was difficult to locate initially and once found, finding access to the seat of the fire proved challenging. Firefighters worked tirelessly to locate and extinguish this fire. As this fire affected multiple buildings, communication and teamwork were keys to safely accomplish all fireground operations. All personnel from the Fire Department and other agencies that responded to this fire should be proud of their work to mitigate this incident.















MAUI FIRES

As most of you know by now, on August 8th, the island of Maui, Hawaii experienced one of the deadliest wildfires in US history. With fires ravaging several areas of the island simultaneously, including both Kula and Kihei, the hardest hit area was the west side in the town of Lahaina which was completely decimated.

The blaze, which was fueled by Hurricane Dora (a Category 4 storm), took off so fast that people in historic Lahaina had little to no warning. Many fled with just the clothes on their backs, while others didn't have time to flee at all or were trapped in their vehicles trying to escape in grid-locked traffic as the inferno descended upon them.

At this time, the death toll has reached 111 with more than 1,000 estimated to still be missing. The search for victims continues.

Among the many people affected were also Maui firefighters who lost their homes in the blaze – some of whom were at these very fires.

To assist them, SFFD has partnered with Maui Fire Dept in creating t-shirts and hoodies for sale in which 100% profit will go directly to them.

Originally, the class was meant to have only the four volunteers (Belal Mogadeddi, Cameron Andersen, James Mogannnam and Kimani Lovan) however, it seemed like a lot of energy to put into such a small audience so I asked Chief D'Arcy: "Hey, can we put a G.O. out to the H-2 rank to see if there is any interest in ARFF training without imposing the 2-year commitment?" After all, we had to put the class on anyway, why not fill it up?

Our objective was to give anyone who had been curious about the airport an opportunity to learn what we are all about without the uncertainty of committing 2 years to a place they knew nothing about. In the process though, we could potentially get more volunteers. Furthermore, we would have a pool of firefighters to call upon for overtime if needed as well as a reserve list for anyone wanting to come later.

Well, that's exactly what we did & if there is one thing, I've learned in my years in SFFD, it takes the right people in the right positions with the willingness to think outside the box to make progress happen & we are lucky enough to have a Chief like Pat D'Arcy who not only supports forward thinking, but finds ways to make the unattainable happen. So, watch out folks, looks like the airport will soon have no vacancies at the Inn & we will be back to a waitlist. Yes, I believe our job here is done.








Cancer Champions by Captain Maribeth Jensen

I volunteered to be a SFFD Cancer Champion a few months ago because as an Officer, I feel it is my responsibility to ensure that members receive training in all aspects of this job. As Firefighters we are continually training for low frequency- high risk events. Unfortunately for us, cancer is a high frequency event and we receive very little training for it. Firefighters' risk for esophagus cancer is elevated by 62%, breast cancer by 45%. We are 2X more likely to get testicular cancer and 1.3X more likely to get skin cancer. In June 2022, the World Health Organization classified Firefighting as a Group 1 carcinogen and 40% of us will face a cancer diagnosis in our lifetime. We cannot ignore cancer any longer.

Detec Together, a non-profit education and advocacy organization, was founded to teach people how to identify the early warning signs of cancer. Early detection means higher survival rates and a better quality of life after treatments. They developed 3 **Steps Detect** to help us recognize the warning signs of cancer and empower us to have the right conversations with our doctors, at the right time, to ensure the best outcome. By passing this information along to you I feel you will have the tools needed to be strong, healthy and successful firefighters who will enjoy a long career & retirement.





3 Steps Detect

Early Cancer Detection Training

STEP 1: Know You Are Great

- Know what's normal for you, bathroom habits, energy level, weight, etc.
- Get an annual physical
- Practice regular exams
- Go for screenings

STEP 2: Use the 2- Week Rule

- If your subtle health change lasts more than 2 weeks, it's time to seek help
- Track these subtle health changes

STEP 3: Share With Your Doctor

- Prepare for appointments with your doctor
- Share everything with your Doctor, your risks.
- Be aware of next steps, follow up if you don't feel better and symptoms persist.


The most common cancer symptom is a subtle and persistent health change that lasts 2 weeks or more. Below is a list of possible symptoms. Should you experience any of these symptoms lasting more than 2 weeks, it's time to seek help.

- -Fatique
- -Weight loss or gain for no known reason
- -skin changes
- -Cough or hoarseness that doesn't go away
- -Swelling or lumps -Pain for no known reason
- -Unusual bleeding or bruising
- -Change in bowel habits
- -Bladder changes
- -Fever or night sweats
- -Headaches, vision or hearing problems
- -Mouth sores, bleeding, pain or numbness
