



OPERATIONS REPORT

September 1 – September 30, 2023

GREATER ALARMS:

There was 1 Greater Alarm fire during this reporting period.

2nd Alarm – (9/14/23) 0008 hours, 2975 Mission Street, cross streets 25th and 26th streets. There was one injury. The cause of this fire is undetermined. (Assistant Chief Patrick Rabbitt)

On September 14, 2023, Box 5613 was struck at 0008 hours to the intersection of Lilac and 26th Streets. Engine 11 arrived first on scene and found a large volume of fire in Lilac Street. Due to the initial conditions upon arrival, Engine 11 was not able to provide a street address. Engine 11 began to

address the large volume of fire as Battalion 06 arrived on-scene. Fire was impinging on the exposure building, a 3-story Type 5 structure with wood siding. Rescue 02 arrived on-scene and was directed to Mission Street to determine the address of the fire building and to conduct a primary search.

Division 03 approached the fire on Lilac from 26th Street. Division 03 noted a large volume of fire climbing the rear of the 3story Type 5 building with flames coming from and impinging on a utility pole with telecom and high



voltage electrical wires. A face-to-face transfer of command with Battalion 06 was conducted. The Incident's communications plan, strategy and tactics were confirmed. Division 03 was on-scene and in command on Mission Street. Battalion 06 was assigned fire attack. During this time, Engine 07 led out from Lilac Street to an LPH on 26th and Capp streets. Truck 07 arrived on Lilac Street from 25th Street and laddered the Bravo building.

Rescue 02 provided valuable information from Mission Street and determined the fire building to be 2973-2975 Mission Street, a 2-story Type 5 building. 2969 Mission Street, a 3-story Type 5 building was declared the Bravo exposure. Battalion 10 arrived on-scene and was made safety chief. Battalion 10 was directed to force entry to Bravo and check for fire extension in top floor and attic.

Truck 11 arrived at the command post and spotted their apparatus IFO 2975 Mission Street. They were directed to ladder the fire



building and conduct forcible entry on both metal roll-up doors at 2973-2975 Mission and the scissor gate on 2969 Mission Street.

Engine 32 arrived on-scene as RIC and were redirected to bring their apparatus on Mission Street. Engine 32 was placed past the property line of 2973-2975 Mission in the middle lane of Mission Street. Engine 32 was now the primary engine for fire attack on Mission Street.

A second alarm was requested on Control A3 and companies responding were directed to report to Division 03 on Mission Street for assignment.

Engine 32 prepared for a 2 1/2" lead as forcible entry was made into 2973-2975 Mission. Engine 32 Driver secured a primary supply from the LPH mid-block on Mission Street. Engine 26 arrived onscene and was directed to supply Engine 32 from the LPH on 26th and Mission Street.

Battalion 06, Engine 32 and Truck 11 made a 200' 1 3/4" ready line lead into 2975 Mission Street. Through hoarding conditions, they advanced to the rear of the building and extinguished the fire inside. Active fire was minimal in 2975 Mission Street and the large fire load was not consumed by the fire.

Battalion 06, RS2 and Truck 09 made a 150' 1 3/4" ready line lead into 2973 Mission Street. The building was determined to be vacant and under construction. Active fire was minimal in 2973 Mission Street.

Battalion 02, Engine 29, Engine 09 and Truck 06 arrived on-scene and were assigned to the Bravo Exposure, 2969 Mission Street. Engine 29 provided a secondary water supply to Engine 32 from the LPH on 25th and Mission Streets. Truck 06 laddered Bravo with their aerial ladder. A large line lead was made and extended with 1 ³/₄" high rise packs to the 3rd floor. Fire was found in the Delta walls and attic space. Coordinated fire attack in Bravo with Truck 07 on the Bravo roof enabled crews to stop the fire efficiently and effectively.

RC3 checked in at the command post and had M76 and M52 at the command post. RC3 was made Medical Group Supervisor. M76 and Engine 37 were directed to check on an invalid in Lilac Alley. They located and provided treatment on-scene. M76 transported the invalid Code 2 with smoke inhalation to CPMC – Bernal. M73 arrived on-scene and checked in with command and medical group.

Engine 24 arrived first on the second alarm and was designated as the RIC. Truck 09 laddered the Delta exposure with their aerial ladder and assisted fire attack in 2973-2975 Mission Street. Engine 37 assisted in evacuating Delta exposure and checking on an invalid on Lilac Street. Engine 37 returned and remained at the Command Post. Engine 42 checked in at the command post and was not assigned.

A member of Engine 29 activated their emergency alarm on their portable Motorola radio. Radio contact was made with the Officer of Engine 29 and a PAR was conducted.



In the end stages of this incident a civilian vehicle proceeded through the SFPD officer directing traffic at the intersection of 25th and Mission Streets. Battalion 06 made an emergency traffic declaration on the tactical channel notifying all companies on the fire ground of the hazard. Battalion 02 and Engine 29 were just released from the Incident and had to seek refuge from the vehicle on Mission Street. The vehicle was stopped approximately 20' from intersection of 26th and Mission Streets by SFPD.

This fire's location in the rear of 2973-2975 Mission Street presented several significant challenges. Initial companies did an excellent job addressing the fire from Lilac Street and then identifying the fire buildings on Mission Street. The construction of the fire building prevented significant damage to 2973-2975 Mission Street. However, the construction features of the Bravo exposure and depth of the building on the lot led to significant fire extension and damage. Fire Attack and Bravo successfully coordinated extinguishment and vertical ventilation from Mission Street with apparatus committed to the rear in Lilac Street. Clear communication and defined strategy and tactics from Chief Officers to Company Officers proved paramount.

Fire extension to the actual fire building was minimal. Significant fire extension was found in Bravo due to the fire origin. Both buildings were vacant and under renovation. 2975 Mission Street was a working mercantile shop and was conducting business within the previous two days. No people were displaced by this fire.

Members worked efficiently and Officers provided clear direction. An aggressive interior fire attack brought this fire under control in the Bravo exposure. Without the responding companies'

aggressiveness, discipline, and efficiency in containing this fire, it would have destroyed much more property and endangered many more lives.

Recommendations

- 1. Remind Battalion Chiefs that a face-to-face transfer of command to the Assistant Chief is a top priority. This is to confirm communication plans, strategies and tactics, as well as to provide accountability for crews already operating on the fire ground.
- 2. Hold forcible entry training related to metal rollup doors. Companies must be proficient and effective.
- 3. Acknowledge any Emergency Activation on the fire ground. The IC must confirm with Dispatch and then the IC must conduct a PAR.
- 4. Maintain situational awareness while operating on the fire ground and at any emergency incident. The civilian vehicle that entered the fire ground from 25th and Mission Street was traveling at a high rate of speed and came close to striking SFFD members.



Remembering 9/11

As I was pulling into work on the morning of 9/11, the sun was just rising from the East behind the runways casting a beautiful reflection on the firefighters standing at attention as they paid tribute to the New York firefighters who lost their lives 22 years ago at Twin Towers.

The sight of them standing there gave me pause to reflect at how much I love this career & have so much pride in seeing my co-workers honoring the fallen yet at the same time, acknowledging how dangerous our jobs can be. Even here at SFO, we too put ourselves in danger and could easily be a target of terrorism.

Coincidentally, as I was thinking about what I wanted to write to pay tribute to 9/11, I randomly came across a story about the life of one of the firefighters who died in the Twin Towers on that fateful day. The timing was serendipitous because the story came from a book I was reading having nothing to do with 9/11.

In any event, it made me think about how nice it would be, in the spirit of remembering, to learn a little more about the firefighters who perished that day. Something more than just reading a name from a list. Although I do realize that if this newsletter lasts beyond me and it features one story a year, that it would take another 342 years to write about every firefighter but hey, why not try?

With that, please enjoy this story through the voice of the wife of FF Bruce Van Hine.

Ann & Bruce were married in 1980. When they wed, each were small business owners. Bruce was an arborist & owned his own company; Ann owned a ballet school. The couple were soon blessed with two daughters. Living in the northeast, Bruce's tree job was seasonal. This meant he had to pick up other kinds of work during the winter.

One night, not long after they were married, Ann saw Bruce scanning for a job in the newspaper when she asked "What did you always want to be when you grew up?" Bruce answered, "A real New York City firefighter". "So, go do that" Ann said to him. So he did, but it would take another 10 years before he'd be hired. Bruce registered for the test in the summer of 1980 which was offered a year later in September 1981. When the list came out, he did fairly well. He and Ann assumed he'd be hired any time, but the list ended up in the midst of a lawsuit – a discrimination against women lawsuit – so the city could not hire off that list until they redid the physical test. In the meantime, Bruce went to work for the West Point Fire Department, NY until in he was hired by the New York Fire Department in 1990 at the age of 36. After years of waiting, Bruce finally achieved his lifelong dream. Originally, he was stationed on Engine 79, then Truck 37 and finally Squad 47.

Sunday, September 9, 2001 was the last time Ann and her 2 daughters saw Bruce since he was scheduled to work through the weekend. Exactly how everything unfolded that day for Bruce and Squad 41 is unclear. It is known that after the first plane hit, they were sent to lower Manhattan but as they were heading there, the second

plane hit so they went straight to the and one Lt, all from Squad 41, went up got very high up. It is believed they made They were believed to be headed back

Boat Crew Member Training

This month marked the resurrection of the Boat Crew Member training. The purpose of training ALL field members at SFO is to ensure that in the event we need crew members to assist with rescue on the water, there is a base knowledge of the roles and responsibilities, safety concerns, vessel knowledge, equipment knowledge, location of rescue equipment, anchoring, docking & mooring and familiarity with nomenclature.

The training is basic and does not currently require members to be swim qualified but as we start to get more members swim qualified, we will put on a more extensive training for swim qualified members that will include a deep dive into the training listed above as well as Helicopter Operations, Spill Response, Use of Inflatable rescue platforms and sidewalks, communications, mass rescue operations & launching and retrieving using the trailer.

Ideally, we would have conducted the more extensive training AFTER getting rescue swimmers but that training is slow going as few members are signing up. To date, we have 19 qualified swimmers. The magic number is 29 (1/3 of the staffing). So please, if you haven't taken the swim training, sign-up when we offer it again. I hope to offer another training soon.

The attendance was large and very eclectic which is a testament to Megan at how many people's lives she touched from so many different backgrounds.


This year's Annual Disaster Drill took place on September 20th and involved multiple agencies and multiple simulated incidents at various locations of the airport. The drill was mostly SFPD and CBD driven but SFFD had a significant role as well.

The scenario was that multiple suspects arrived at SFIA during an International conference attended by global leaders and they attempted a complex, coordinated attack. Part of the attack involved trying to launch a drone over Signature as well as assembling an IED. The suspects also set off a small fire as a distraction to lure resources away from where they intended to assemble their bomb.

Due to the multiple scenarios and complex nature of the drill, the EOC opted to use the old Post Office on Westfield Rd as a "mock" terminal. This proved to be challenging for some agencies since we are told not share too many details of the drill itself. This made it difficult for some players in the scenarios to know entry and exit points.

The good news is that in the post-drill briefing, Chief Kasper and I were able to make the argument for not keeping these Annual Drill scenarios a secret but rather, let us prepare our members so that we can polish our skills and show up on game day bringing our best.

Overall though, FD did a very good job as usual. Our biggest take-away was that these big drills only happen once a year so we should pull out all the stops and utilize all the toys (such as the equipment on the MCU) and put on a really good show for the folks on the 5th floor and their constituents. Play it like it's the real thing! Thanks to all who participated!!
