



OPERATIONS REPORT

October 1 – November 30, 2023

GREATER ALARMS:

There were no Greater Alarm fires in October 2023. There was one Greater Alarm fire in November 2023.

2nd Alarm – (11/14/23) 0558 hours, 975 Valencia Street, cross streets Liberty and 21st streets. There were no injuries. The cause of this fire is under investigation. (Assistant Chief Brook Baker).

On 11/13/2023 at 0558hrs Box 5456 was struck for Fire in the Building at 969-975 Valencia Street,


between 20th and 21st streets. The building involved was a three-story type 5 apartment building with two floors of apartments over commercial/retail storefronts, a common arrangement throughout San Francisco. The building was approximately 75'w x 100'd with fire escapes on the front and rear of the building. There was an open lightwell on the Bravo side of the building containing an exterior wooden staircase accessed via a tradesman door on the Alpha side of the building near the Alpha/Bravo corner. The roof was a flat, torch-down membrane style. The roof was accessible via interior stairwell which exits onto the roof through a penthouse door. The roof was also accessible via goose neck ladders from the front and rear fire escapes. The second and third floors were normally accessed via a front gate and door and an open stairwell. The four apartments on each floor were arranged around a central



hallway, with the interior stairwell on one end near the Delta side, and the exterior stairs/lightwell near the Bravo side on the other end. There was no central fire alarm system or fire sprinklers present.


The first due company, Engine 7, reported a working fire upon arrival. Fire was visible from the street in the bravo side lightwell, with the exterior stairs fully involved from top to bottom, and flames extending 50' over the roofline. Smoke was pushing out all over from the interior of the building, and there were three occupants awaiting rescue on the alpha side fire escape, indicating interior egress pathways for occupants were likely untenable due to the hallway/stair arrangement. Fire was visibly extending up the lightwell on the Bravo side and into each floor through windows and doors, filling the hallways with heavy fire and smoke. The Bravo exposure, a similar three-story apartment building, was also in danger of being consumed by fire. The occupants' only option for escape was to climb out of their apartment windows onto the fire escape. First arriving SFFD companies recognized the seriousness of the situation and took immediate action. These companies were Engine 7, Engine 11, Engine 6, and Engine 24 (RIC), Truck 7, Truck 11, Rescue 2, Battalion 6, Battalion 2, Division 3, Rescue Captain 3, and Medic 74.





The priorities for this incident were to protect life first, then property.

Engine 7 arrived and positioned their apparatus just past the front entrance of the building. The crew forced entry through the front gate and door, entered up the main stairway, and conducted a quick reconnaissance of interior conditions before choosing to deploy the 200' 1-3/4" ready line.



Engine 11 arrived and immediately assisted Engine 7 getting the hose line stretched and into operation. Both companies encountered heavy fire and smoke in the second-floor hallway, and water was applied to the fire very quickly.

Truck 7 arrived, and the crew split up to accomplish raising ladders, rescuing occupants from the fire escape, and cutting open the heavy metal security gates in front of the stores. Truck 7 rescued three occupants from the front fire escape, 2 occupants from the rear fire escape, and accomplished vertical ventilation of the fire by cutting a vent hole in the roof.

Division 3 and Battalion 6 arrived at the same time and met in front of the fire




building. After a brief meeting, Division 3 Chief Baker assumed command of the incident and

assigned Battalion 6 Chief Siguenza as Fire Attack inside the fire building. At this time, a resident approached the command post to report a trapped elderly woman on the second floor in her apartment. Incident Commander Chief Baker struck a Second Alarm.

Rescue 2, assigned as the Search and Rescue Group, split into two teams and entered the building to begin searching for any trapped occupants, including the elderly woman. Rescue 2 Team "A" followed the initial hose lead through the front door and upstairs. Rescue 2 Team "B" forced entry into the tradesman entrance looking for a quicker route to the trapped woman. Team "B" discovered heavy fire in the tradesman blocking their path. This was reported to Incident Commander Chief Baker.

Engine 6 arrived and was assigned to lead a large 3" hose line, with wye and 1-3/4" bundles, up the interior stairway to attack the fire on the third floor.

Battalion 2 Chief Schwartz arrived, reported into Command, and was assigned as the Safety Chief. Chief Schwartz led a hose team down the tradesman entrance to extinguish the exterior fire and protect the Bravo exposure building.



Truck 11 checked in with the Chief Baker and placed their aerial ladder to the roof. They were assigned to Fire Attack Chief Siguenza to assist with interior operations.

Rescue Captain 3 was assigned medical group supervisor and immediately tasked Medic 74 with receiving the three rescued victims from the crew of Truck 7 to evaluate for injuries. All three victims were treated at the scene for smoke inhalation, and one was transported to the hospital with minor injuries.

Second Alarm Companies Engine 29, Engine 36, Engine 37, Engine 32, Truck 9, Truck 6, and Battalion 10 arrived and were assigned into the Bravo exposure building, under the supervision of Battalion Chief Smith, to cut off any fire extension into that building.

During operations at this fire, multiple victims were rescued and treated for injuries. Two aerial ladders were raised to the roof, several ground ladders were placed at fire escapes and windows by Truck companies, two hydrants were utilized, and multiple hose lines were stretched to each floor of the fire building. The Bravo exposure building by Engine companies cut off and extinguished fire, Rescue 2 responded to complete search and rescue, SCBA bottles were filled by Mobile Air One, and Arson/4710 responded to investigate and determine cause and origin of fire. The Bureau of Equipment responded to ensure continued operation of apparatus, while Rescue Captain 3 supervised medical units treating victims. Extensive salvage operations were conducted by firefighters after the fire was extinguished to protect valuable contents from water and smoke damage.

This was an extremely challenging fire. Due to the large, advanced fire on all three floors, many trapped occupants encountered heavy metal security gates on all fire escapes, and the immediate threat to the exposure building on the Bravo side. This incident serves as a perfect example of why the San Francisco Fire Department requires fully staffed Engines, Trucks, Rescue Companies, Chief Officers, and Emergency Medical Personnel. Without the proper resources to quickly rescue citizens and gain the upper hand on this fire, a devastating conflagration with many lost homes, businesses, and injured or killed civilians would have occurred. Firefighters responding to this incident acted in a highly proficient, selfless, and professional manner exemplified by the San Francisco Fire Department.

As a result of their actions directly contributing to the saving of many lives at this incident, a recommendation to acknowledge meritorious conduct by Truck Company 7 has been submitted to the Meritorious Review Committee by the Incident Commander.

What does it take to be an ARFF Driver? by Lt Dale Dockery

The classroom portion encompasses may subjects including Vehicle Familiarization, Emergency Procedures, Vehicle Operations, Communication, AOA Familiarization, Tactics and Strategy, and a Cones Course.

After completion of the 40-hour classroom instruction, trainees complete 25 tasks including timed tasks, 19 quizzes, a final 100 question test, 10 hours of simulator training, 20 hours of AOA driving, & a final test proctored by the Training Lieutenant and/or Training Captain.

As you can see this is a detailed and thorough ARFF Driver program. This program requires dedication and commitment not just from trainees but also from the H-16 training staff. I would like to thank H16 Janice Hoaglin and H16 Francisco Ochoa for their continued dedication and commitment to the ARFF driver training program. Janice single handedly taught the classroom portion of the last trainee group and Francisco has become an integral team member who has assisted with both field training and testing along with Janice. I would also like to thank the current ARFF drivers for their assistance and support in training of the ARFF trainees. I would also especially like to thank Rey Buzon, Lando Greene, Irvin Cheung, Jose Cortes, Desmond Cotter for their hard work and commitment to completing the training program and for their continued commitment to ongoing training.

What's going on in Training?

Here are a few pics from this month's Vehicle Stabilization Drill's held at Station 1. We have been very fortunate in that I was able to reach the right person in Parking Management (Rachel Young) who was able to secure us several abandoned vehicles free of charge. All we have to provide is a tow truck driver to move them from Long Term parking to Station 1. For that, I'd like to thank James Kucharsky for connecting me with Nelson Chicas of Blue Water Towing who tows these vehicles free of charge as well (although we do let him take the vehicles to turn in to the scrap yard for cash). If you ever see Nelson, please show him our gratitude! We get the most Vehicle Extrication training than any other Department or agency I know!



A note from Chief D'Arcy regarding the new mandatory Confined Space Training

Many members have been wondering why confined space has suddenly become necessary for members at the Airport. There are 3 basic reasons that our assumption of the Confined Space Rescue Role here at the Airport is Critical. To understand these reasons, we must first look at the confined space entry permits written here at the Airport. Every day, the plumbers, fuel system maintenance personnel, and construction contractors here at the Airport write and average of 3-4 confined space permits. On each of those permits, we are listed as the Rescue Group. For as long as anyone can remember, the department has considered Rescue 2 to be that rescue group.

- The rescue group cannot be 25 minutes away, or possibly further if Rescue 1 must respond for some unforeseen reason. The persons trapped in a confined space cannot be made to wait 25 minutes for us to start setting up a rescue. If OSHA were to evaluate our program, the Airport would be required to hire a standby team which would cost thousands of dollars per day. So, the Airport expects us to assume this responsibility.
- Per FAR 139 in Advisory Circular 150/5210-17C Programs for Training of ARFF Firefighters, "If the airport emergency plan calls for ARFF personnel to respond to special situations, such as water rescues or confined space rescue, provide training specific to such situations." Given that we are expected to assume this responsibility by the Airport Director, we will be required to have every member qualified in our audited 139 Training Records.
- Most importantly, if someone is dying in a confined space and our wait for a squad is 20 minutes, I know our members will spring into action and do whatever they can to save a life because they're dedicated to that mission. It's my responsibility to anticipate that and provide you with the needed knowledge and skills to keep you safe while doing what you do best.

If you have any questions, I'm always happy to answer them. Please feel free to stop by my office when you see me in there and I can expand on my thoughts on this subject. In the meantime, thank you for participating in our effort to improve the services we provide to the 25000 employees of the Airport and its Tenants.



Did you know???

There is SO much to learn at the airport when you first get reassigned here. Everyday is a new learning experience. That learning continues throughout your career, especially if you are someone open to learning. We should never have the "I know it all" attitude. But after the first few years, the learning of new things starts to be less frequent simply because we've come across it at some point in our day to day. However, every so often a new "nugget" comes your way. Such was the case in preparing for the Red Cap this month which involved the ATC Tower. (*more on that drill on Pg3). Do you know how to access Control Tower in the event the guard must evacuate? The answer is...if you are ever in this situation and there is no guard available to buzz you in, you must call dispatch and request the code and enter it into the keypad located adjacent to the entry. For security, dispatch can see us via cameras to verify that we are the Fire Department.

If you've seen the October newsletter, you would've read Chief D'Arcy's explanation as to why we are now requiring every current & future member go through the week-long confined space training to be State Certified as confined space techs. We anticipate having roughly 80% of current members through confined space by the 3rd class scheduled for February 26 - March 1st. The 4th class will be dedicated to new members and those who were unable to attend the 1st 3 classes.

Following that, barring any need to add additional classes, confined space will resume annually in August in conjunction with the 40-hour ARFF new member training. Also, in order for everyone to stay current with their confined space training, we must ensure all members participate in at least 1 confined space **entry** annually. This training will be part of our recurrent annual training curriculum here at SFO and will not require going off site for the training.

As always, thank you for your participation in the training. The feedback from the first class was that it was fun & informative training!

Red Cap, Recap (October)

I didn't get a chance to update you all on last month's Red Cap so here is a short synopsis: Air Train reported a worker trapped under one of their trains with his arm trapped under a wheel. Fire was dispatched and RS33/RS48 quickly went to work simulating the setting up of cribbing and air bags to lift the Air Train. After FIRE secured the cribbing and airbags, RS67/RS93 prepped the patient for Crush Syndrome by giving IV fluids and sodium bicarb (simulated). RS67 even considered the steps needed in case of possible amputation to free the victim. This is a real possibility given the fact that the max lift of an Air Train is only a couple inches.









Current & Upcoming Training

ARFF IN ACTION!!

As you know, ALERTS are a regular occurrence for us. It's what we train for and the main reason why we are a presence here at the airport. However, it is rare that we get the chance to put our training into action. One of the skills that ARFF drivers are trained to deal with is an issue known as "Hot Brakes" in which an aircraft lands and the pressure and speed with which they land causes the brakes to overheat and smoke with the potential to catch fire. Often, the ALERT is for another issue and hot brakes is the result of coming in "hot", as we say.

Well on Saturday November 25th that very situation arose. Delta 2272 reported a "hydraulic issue" and landed such that the brakes became very hot upon impact with the runway. Luckily, all ARFF drivers have trained on this extensively. In fact, one of our new drivers, Rey Buzon was the driver on RS2 with Lt Balzarini when the aircraft landed. Their expertise along with some suggestion from H16 Janice Hoaglin who was listening in, resulted in RS2 being quick to address the issue. This was a job well done by all, including T/BC Wong who was the interim Battalion Chief for the day. This just goes to show that we all have to be prepared at all times. Especially when we are in positions that aren't our usual ones.



Red Cap, Re-Cap (November)



This month's Red Cap was a report of a "suspicious device" planted in the ATC Tower. Obviously, the drill was SFPD driven with Fire being in a more supporting role. The drill went well, with BC Crean having crews stage in firehouses, ready to respond if needed. SFPD brought in dogs to do sweeps. They found the 1st device on the 2nd floor and a second device on the 9th floor. Meanwhile, the entire tower (minus the controllers & other essential workers) evacuated the tower. Their evacuation route is to the AOA where (in a real situation) a white truck is parked to transport a supervisor and controller to Lighthouse 1 where a temporary tower would be set up. In the meantime, flights would immediately be diverted to other airports until the tower has been cleared or the situation put







Probationary Testing


- Probationary members shall begin testing no earlier than 4 months in their new assignment.
- Training staff shall call the firehouse the day prior to testing to confirm the Probationary testing is on the station schedule.
- Two attempts are allowed on the first DMV Cone Test. One attempt is allowed for all other DOT tests.
- Failure of a second test will generate a PX Notice to Improve, and DOT training staff will conduct a conference with the Probationary and the Officer. The form will be routed through the Chain of Command to CD2. The ADC of the Office of Diversity, Equity & Inclusion shall also be notified.
- Per the Probationary Handbook, a third and final test shall be scheduled after a period of at least four (4) watches.
- DOT shall provide additional opportunities for practices, including with DOT Training staff and/or with Probationaries and their companies.
- DOT will review Probationary Evaluation Forms and ensure Officers are up to date with their reports.
- A third an final test that is not a clear pass shall be deemed "under review" and a general form routed from DOT to CD2
