Incident Description

- August 10, 2024 15:51 HRS
- Box 5416
- 443 Castro St.
- RP reported smoke coming from the roof of the Castro Theatre. Second RP reported flames coming from the bank on the ground floor.
- B6 set up command and B2 was assigned fire attack.



Incident

Engine 6 reported fire in the rear of the bank, C/B corner, behind a chain link fence and under an exterior window. The fence surrounded the entire rear of the bank window and was secured by heavy rebar. This fence was added security for the rear doors of the bank. Engine 6 stretched a ready-line down the tradesman on the Bravo side and extinguished the fire on the exterior of the building, and began forcible entry of the fence. It was unknown if the fire had extended into the bank.



After checking in with E6, Battalion 2 returned to the front of the bank to look into the glass doors. Smoke was banked down inside the bank and charged smoke was observed pushing through the gaps of the entry doors. T6 was instructed to force the bank doors. The remainder of T6 went to the roof of the bank. Due to the heat coming from the rear of the bank command was notified that fire had extended into the interior. E7 brought a ready-line into the through the front doors to begin containment of the fire.

The interior of the bank had teller windows along the B wall. The teller windows were secured by bulletproof glass and ended with the vault, also behind a bulletproof glass door, at the B/C corner. Along the D wall were the office cubicles and workstations. Past the workstations was a small office kitchen followed by two storage rooms on either side of the rear exit door on the C wall.

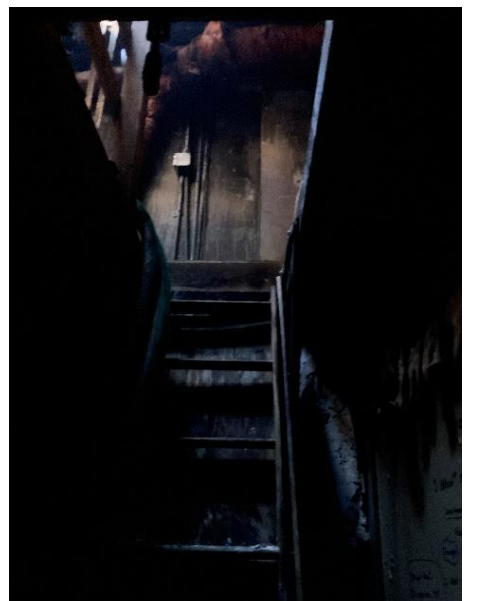


Because of the heat buildup on the interior, vertical ventilation was requested. As E7 made their way to the rear of the bank, E6 forced the rear entry door of the bank. Both hose lines extinguished all known fire in the rear storage rooms, kitchen and bank lobby. Interior crews began to pull ceiling to search for fire extension. The bank had a drop ceiling on the ground floor with plywood underneath. T6, on the roof, notified interior crews that there was still heavy black smoke coming from the attic on the B/C corner, above the vault.

The vault door was difficult to force because of the bulletproof glass. The substance does not flex like ordinary construction, and the doors' hardware was strong stainless steel. Though the irons eventually won the battle, future incidents may want to employ a metal cutting saw or a rabbit tool. The vault was a reinforced concrete box, on five sides, and a heavy vault door on the front. Easy access was impossible. The plywood above the drop ceiling prevented crews from accessing the unknown space above the ground floor. E6 began using a circular saw to cut the heavy bars protecting the second story windows, also covered by sheet metal on the interior, while interior crews searched for access to the upper area.



E24 eventually found a residential folding attic ladder at the ceiling of the office kitchen, revealing a second floor with two rooms at the rear of the bank. A hose line was extended up the stairs to extinguish the remaining fire over the vault. In these upper rooms were shelves of three ring binders, files and office supplies.



## Obstacles and Challenges

The secure nature of the bank presented obvious challenges. Though the rear chain-link fence area allowed for quick knock down of the fire, it still presented an unusual access issue for crews.

The front entry doors of banks are almost always glass. Breaking these doors provided a large clean opening for interior crews to use. Members must remember that breaking the interior metal push bars, after the glass windows, will further increase the opening size and provide improved access and egress.

The bulletproof contained teller windows and vault area also provided a bit of a challenge for crews. This substance is more plastic than glass and may require the use of metal cutting saws to cut through it or the lock/hinge mechanisms attached to it.

The lack of access to the top floor rooms delayed our finding the fire on the second floor. But, because vertical ventilation was initiated early, the fire in the upper floors did not move laterally, and the spread of fire was contained.

E6 reported that the ¾" - 1" rebar protecting the second story window was very strong. Our gas-powered circular saw slowly progressed through these bars. It would have taken an extended amount of time to cut these bars if this was our only means of access.

## Conclusion

Because companies aggressively employed the SOP's long used by the SFFD, they were able to locate, attack and contain the fire on the exterior and interior of this business. Multiple hose lines used in coordination with forcible entry and vertical ventilation proved successful. Even though the hardened nature of the bank presented a number of challenges and delays, crews were still able to contain and extinguish the fire in short order. No members were injured, and the majority of the business' contents were saved.

### SPOTLIGHT: BFP AT PORT OF SAN FRANCISCO



The Port of San Francisco manages 7.5 miles of waterfront that is home to popular attractions, historic districts, and small businesses. The Port has over 550 leases, including landmarks such as Fisherman’s Wharf, Pier 39, and the Ferry Building. Most of the Port’s facilities were constructed between 1878 and 1945, and are listed in the National Register of Historic Places.

SFFD has a BFP office at Pier 1, where a staff of three H-4 Inspectors, one H-32 Captain, and one civilian Fire Protection Engineer manages all the Bureau of Fire Prevention’s Port responsibilities, such as: overseeing fire safety compliance for Port properties, new construction plan review, issuing operational and event permits, and performing construction, annual, complaint, and high-rise inspections.

The Port contains a variety of distinctive projects, venues, and events. The Mission Rock project near Station 4 recently completed four new high-rises and is slated for several more, and a massive redevelopment of Pier 70 is in the works. Events outside of Chase Center, at Oracle Park, the Exploratorium, Piers 30/32, the new China Basin Park, and the Portola Festival that draws 45k members of the public annually are all managed by the Port’s BFP. Port BFP also inspects all the barges in the Bay that detonate fireworks for large events such as July 4<sup>th</sup> and New Year’s Eve. Due to the unique nature of the Port, occasionally buildings that are outside the scope of the Port will utilize their adjacent outdoor spaces, which then become Port BFP’s to oversee.

Port BFP members provide critical fire safety support to these special buildings and structures that are irreplaceable from a historical perspective and serve over 30 million visitors to San Francisco annually.

## RESIDENTIAL HIGH-RISE SPRINKLER UPGRADE REQUIREMENT

Non-sprinklered residential high-rise buildings represent a significant risk to occupants and emergency responders. This risk increases as a function of building height, occupant density, fire load, and where a building has inadequate fire detection and suppression systems. Effective January 1, 2023, the San Francisco Fire Code (SFFC) 1103.5.4 requires all existing residential high-rise buildings, including those qualifying as historical buildings, to be fully equipped with an approved automatic sprinkler system by January 1, 2035.

The SFFC requires all high-rise buildings to be retrofitted with automatic sprinklers where any of the following conditions apply:

- Any building over 120 feet
- Any building over 75 feet, but not exceeding 120 feet, where the building does not have two interior stairs that are separated from the rest of the building by 2-hour fire rated walls
- Any building over 75 feet, but not exceeding 120 feet, where the building does not have a complete fire alarm system with smoke detection

This means that previously exempt 120 residential high-rise buildings will need to be fully equipped with automatic sprinklers by 2035; locations include Parkmerced and The Gateway. Building owners should have received notice of these upgrade requirements as of April 30, 2023, and had 1 year following receipt to submit a compliance schedule to the SFFD BFP.

Because this upgrade will be extensive and expensive, especially for larger or historical high-rise buildings, the requirements in this code shall be completed in the steps and timeline below, at the minimum:

- Submit a complete automatic sprinkler system permit drawing and application to the Department of Building Inspection (DBI) by January 1, 2027
- Connect the approved automatic water supply to the system riser and provide Fire Department Connection (FDC) by January 1, 2031
- Completion of the approved automatic sprinkler system, including sprinkler monitoring by January 1, 2035.

### BFP SPECIAL PROJECTS SECTION: COMMUNITY HOUSING

San Francisco has two major initiatives designed to build affordable housing: a program through the Mayor’s Office of Housing and Community Development, and an ADU ordinance born of a Mayoral Executive Directive. SFFD’s Bureau of Fire Prevention Community Housing section is part of a team of City agencies that have partnered with one another to carry out these initiatives, including: Capital Planning Committee, DBI, DPW, PUC, Office of Assessor-Recorder, MOHCD, Office of Community Investment and Infrastructure, SF Planning Department, and Urban Forestry. In the past 10 years these initiatives have created 16,823 affordable units through 373 projects, and 2,264 affordable ADUs.

The BFP Community Housing section is comprised of one H-32 Captain, one H-22 Lieutenant, one H-4 Inspector, and one part-time civilian Fire Protection Engineer. This team is responsible for reviewing all plans and enforcing fire code compliance in the construction of new buildings, as well as ADUs that are being converted from underutilized storage areas or parking spaces. Their contributions to these projects are comprehensive, starting below ground (low- and high-pressure hydrant system installation), to streets (establishing adequate access to fire apparatus), to EERO (Emergency Escape and Rescue Opening) requirements to ensure firefighters can adequately access buildings via tradesmen, side entrances, roofs, etc.) and fire protection systems.



These affordable housing units are being built to the latest fire codes, and as such are as safe as possible – a significant step up from existing SROs, for both residents and the firefighters who serve them. This is also true of the ADU projects, many of which are built within typical SF balloon-frame construction homes. Notable updates to these include upgraded means of egress, SFFD access, and the installation of sprinkler systems. The BFP’s Community Housing section is making a direct contribution to the wellbeing of firefighters as well as the unhoused and other marginalized demographics across San Francisco by working to provide safe and affordable housing.
