
Incident Description

Near-Miss Firefighter Fall
Date of Event: 08/16/24
Time of Event: 15:55 hours

• Location of Event: 1341 Grove St., San Francisco, CA 94117

Summary

While conducting an R2 inspection at a multi-residential building, E21's FF/PM climbed a "house" ladder that extended from a 4th floor exterior stairwell landing to the roof level and protruded through an opening in an awning structure that covered the stairwell in an attempt to gain access to the roof level. After climbing through the opening in the awning structure, the FF/PM stepped onto the awning's corrugated, plastic sheathing. The FF/PM's weight caused the plastic sheathing to break. The FF/PM then began to fall from the roof level. He struck a pipe affixed to the lightwell's wall on the 4th floor and then fell further making contact the stairwell's handrail between the 3rd and 4th floors. E21's Officer was ascending the stairs at this location and was able to rescue the FF/PM onto the stairs, thus prevented him from falling an additional 3 stories to the base of the lightwell.



Sequence of Events

On 08/16/24 at approximately 15:55 hours, E21's Officer, Firefighter, and Firefighter Paramedic were conducting a R2 inspection at a multiresidential building located at 1341 Grove St. (E21's Driver remained with the rig). During the course of the inspection, the crew of E21 entered the tradesman alley on the Bravo side of the building where the alarm panel was located. After inspecting the panel, the crew of E21 then decided to ascend the exterior stairs located in the lightwell at the midpoint on the Bravo side of the building. E21's FF/PM was the first Member to ascend the stairs. When he reached the 4th floor stairwell landing, he noticed a "house" ladder that provided access from the stairwell landing to the roof level. This "house" ladder also protruded through an awning structure that served as weather protection over the stairwell area. The awning structure had alternating sections of plastic and metal sheathing on the top side. The FF/PM climbed the ladder, and once he climbed through the opening, he placed one foot on a section of the corrugated plastic sheathing in an effort to test its integrity. The FF/PM was unaware that the sheathing's support joists spanned 4 ft. on center and believed the sheathing was capable of supporting his weight since it passed his initial test. As a result, the FF/PM stepped off the ladder with his second foot and placed his full weight on the sheathing which caused it to fail and shatter into pieces. The FF/PM fell through the awning structure, hit and dislodged a section of 2" waste pipe attached to the lightwell wall at the 4th floor level, and continued to fall approximately 12 ft. before hitting the stairwell railing where the Officer was ascending the stairs one story below. The Officer grabbed the FF/PM, thrust him off the railing and onto the stairs, and prevented him from falling to the base of the lightwell. Had the FF/PM not been rescued off the stairwell railing, he would have continued to fall an additional 3 stories, and most certainly been severely injured at the very least.



The FF/PM suffered only minor injuries. He was evaluated at the scene by a SFFD Medic unit and a Rescue Captain, released on scene, and completed the remainer of the watch.


Contributing Factors

The awning structure was illegally constructed and did not comply with official San Francisco building codes.

The "house" ladder was also illegally installed and not an acceptable means to ascend to the roof level.







Safety Issues for Review

Members should maintain situational awareness at all times including deficiencies with building construction features and materials. Operating at the roof level should be considered dangerous at all times. Operating at the roof level under fire conditions creates a higher level of danger.

Corrugated plastic and fiberglass sheathing is common in the City covering lightwells, deck roofs, and skylights. It can be covered by other roofing materials. It should never be considered structural and weight bearing.



Members should always sound the roof before stepping off onto the roof and continue to sound ahead while moving about on the roof level. It is highly recommended to use a tool to conduct sounding operations.

2024-07 Preliminary Safety Report of SFFD Near-Miss Incident

SUBJECT: 163 West Portal Avenue

Summary

At 1248 hrs. on September 5, 2024, Box 8612 was struck for Smoke in Building at 163 West Portal Avenue. The first arriving officer of Engine 39 reported a "Working fire with heavy smoke showing", with the fire appearing to be on the second floor of 157 West Portal Avenue (two-story type 5 offices over commercial storefronts).

While attempting to maneuver the aerial ladder under high voltage MUNI streetcar wires to the roof of 157 West Portal, first arriving Truck 19's aerial ladder made contact with the wires resulting in an arc/explosion. Battalion 8 witnessed the incident. This incident is a significant near miss situation that had the potential to seriously injure or kill firefighters operating on the scene.

Sequence of Events

Engine 39 positioned in front of the fire building, conducted a size up and initial report, and proceeded to stretch the 150' ready line to the second floor of 157 West Portal Avenue. Engine 39 officer determined early on that the bulk of the fire was between 157 and 163 West Portal Avenue, and all of this information was reported over the tactical channel.



Truck 19 approached the scene from the South and positioned on the East side of West Portal Avenue facing in front of the Delta 2 building (also a one-story type 5 commercial storefront) and proceeded to place outriggers with the goal of raising the aerial to 157 West Portal Avenue (two-story type 5 offices over commercial storefront). The outriggers were placed such that one foot of an

outrigger landed directly over the recessed MUNI streetcar track. While rotating the aerial ladder around the outside of the Truck 180 degrees and over the cab, the tip of the aerial came in contact with the high voltage MUNI wires and a large arc/explosion occurred.

While approaching the scene on foot from the rear of the truck, Battalion 8 witnessed the arc/explosion between the aerial and the MUNI wires, as well as a subsequent arc/explosion where the outrigger was placed on the ground directly over the steel MUNI streetcar track embedded in the street. Battalion 8 stated that he witnessed the arc occur at the tip and also subsequently at the base of the outrigger. This confirms that when an aerial ladder contacts high voltage wires, the apparatus will become energized, and the electricity will seek a path to ground.

Description of Injury (or Potential Injury):

In video footage and photographs a firefighter can clearly be seen standing on the ground under the aerial, preparing to access a compartment on the truck, when the arc/explosion occurs. This firefighter was extremely fortunate to have not been electrocuted and seriously injured or killed.



Cal OSHA and the SFFD require that aerial ladders be operated at a minimum clearance of 10 feet, and that firefighters shall not work in violation of the 10-foot rule unless participating in a rescue attempt. In such instances firefighters should be extremely alert to the risk and be aware that one-third of all those shocked by high voltage die as a result.

Any metal part of an aerial ladder that touches high voltage lines (or otherwise comes in close proximity and is energized by arcing) energizes the entire apparatus, and the entire apparatus is then a potential killer. Electricity always seeks the path of least resistance from point of contact to ground. A firefighter stepping off of an energized apparatus, grabbing a tool or SCBA off of an energized apparatus, or otherwise standing on the ground and touching an energized apparatus provides the path of least resistance through their body for that high voltage electricity to the ground. In this case, the electricity had an additional path of travel through the metal MUNI track endangering



firefighters and civilians in the area. Therefore, officers and firefighters working on/around aerial apparatus when the aerial ladder is being maneuvered around high voltage power lines

should always stand clear, watch out, and be alert until the aerial ladder is safely in position for use.

Contributing Factors

- 1. Unfamiliar with Rules and Regulations: The SFFD Truck and Ladder Manual clearly states that aerial ladders be operated at a minimum clearance of 10 feet, and that firefighters shall not work in violation of the 10-foot rule unless participating in a rescue attempt.
- 2. Failure to conduct a risk analysis and weigh the risks associated with planned actions against the potential rewards or outcomes (whether the planned actions are a "go" or "no-go" based on the risk vs. benefit analysis). The risk analysis at this incident should include some consideration of options such as: "We could use the aerial, but there are high voltage MUNI wires overhead with little clearance"



(dangerous). Conversely, "This is a two-story building with a parking lot on the Bravo side, and multiple one-story exposure buildings on the Delta side where we can throw a ground ladder" (less dangerous).

Safety Issues for Review

1. In this situation, the initial fire building was a two-story commercial building with offices over store fronts with an open parking lot on the Bravo side. The Delta exposure building was a one-story commercial storefront building with several similar storefronts on Delta 2 and Delta 3. Ground ladders raised to the fire building from the parking lot or one of the Delta exposures next to it would have



been a safer and quicker option for gaining access to the roof. Officers should keep in mind that use of the aerial reduces the available manpower of their crew from five firefighters to four.

- 2. Aerial truck drivers may get "tunnel vision" and be determined to utilize the aerial because ego compels them to "get the shot" even in situations where ground ladders might be more appropriate.
- 3. Inexperienced truck officers may avoid making challenging ladder calls because these situations require a high level of confidence, leadership and teamwork. Truck officers must lead their crew and train consistently to prepare for the many situations encountered.

4. There may be situations where operating the aerial ladder around high voltage wires is unavoidable if the mission is to be accomplished. Officers then should be clear in alerting firefighters to the electrical hazard present, designate spotters to aid the driver in maneuvering the aerial into position, and post lookouts to ensure firefighters remain clear of the apparatus without touching it until the aerial is safely outside of the 10-foot envelope.

Neighborhood Response Team (NERT), Lt. Jonathan Honda

September 2024 Monthly Report

NERT is a free training program for individuals, neighborhood groups and community-based organizations in San Francisco. Through this program, individuals will learn the basics of personal preparedness and prevention. The training also includes hands-on disaster skills that will help individuals respond to a personal emergency as well as act as members of a neighborhood response team.

San Francisco is made up of many neighborhoods. NERT trains San Francisco residents to be one ready community when it counts. Together NERT can create a lifeline between your family and neighbors, and the City's emergency responders.



Projects and Short-Term Plans

- October Train the Trainer Course to onboard more instructors into program and have them be mentored during the remaining calendar year courses scheduled.
- Work on CityWide Disaster Drill preparation (Oct 19, 2024)
- Confer again with Aaron Yen from DEM regarding upcoming SF Ready/DEM joint Community Education, goal is 3 by the end of this calendar year. More to follow.
- Prepare for Listos (Spanish disaster preparation program) return, Class date set for October 25, 2024 (first once since last year).
- Prepare for anticipated Listos expansion due to interest/demand in Spanish Speaking community, source materials, instructors, etc. Next Listos class already slated for Nov 2, 2024.
- Continue increasing availability/scheduling of SF Ready once Full classes wind down for Calendar Year (end Dec 3rd).

Challenges

- Seeking approval for Grant application against items needed by Office. (i.e. ID Card printer
 is considered equipment, grant specifies use for training aids, not equipment). Once Grant
 approval is obtained, then the Grant process that requires items going out to bid. Delays end
 result of NERT office obtaining required training aids, tools or equipment to support current
 operations before quotes expire and prices increase, minimizing funds available.
- Failing equipment, ID Card printer and laptop needed to be rebooted multiple times. Took multiple attempts to successfully produce one ID for a replacement ID card.
