The San Francisco Conservation Corps underwent new leadership since the first wildland firefighting training cohort in January 2024. The team that Chief Siguenza and I established this program is no longer working with the SFCC. The training was originally scheduled for the week that the Recruit Academy was scheduled to be at 19th and Folsom in August. With the new leadership in place, there were some continuity issues with what was needed in order for us to conduct this training.

The training was rescheduled for the week of September 23. Due to this change, we were not able to conduct the training at TITF. The SFCC secured the Mid-peninsula facility for us to use. Chief Siguenza and myself drove down to San Mateo for the training on the 23rd. On the 23rd, we provided classroom instruction along with Skills Training.

The SFCC lacked the required equipment necessary to continue the second cohort on day 1. Chief Siguenza and I made the executive decision to finish out the day but canceled the training for the rest of the week. I followed up with an email to clearly communicate to the SFCC what is required from them if we were to continue this partnership.

- **NEW**: SFFCPF / UCSF 2024 Firefighter Infrared Hyperthermia Study with UCSF
 - Researchers at the UCSF Osher Center for Integrative Health are conducting a study to determine if infrared sauna treatment can lead to the excretion of environmental toxins in sweat and urine among firefighters.

- Specifically, Drs. Leena Pandya and Ashley Mason will test whether a 60-minute infrared sauna session can lead to the excretion of harmful substances that firefighters are exposed to in their line of duty.
- By analyzing sweat and urine samples before and after infrared heat treatment, the study seeks to identify the potential for infrared sauna as a preventive health measure for firefighters.



Investigative services will then review all past work, driving, residential, criminal history for each candidate to ensure that the candidates meet all minimum requirements to be a San Francisco Firefighter.

FACILITY MAINTENANCE & PLANNING (June Waechtler, SFFD)

- A total of 148 requests for service were initiated during the month of September.
- 114 service orders were completed and closed out in September.

PLUMBING

- Fifteen service calls were placed to resolve minor plumbing issues (faucet, toilet, urinal repairs; clogged sinks, shower drains) in the month of September. All issues were addressed by DPW Plumbers.
- No sewage backups were reported during this month.

HVAC/HEATING/BOILER

FS 9: SO # 2066398. ESTIMATES RECEIVED from DPW Steamfitters to replace 3 rooftop HVAC units: \$149,701.72.

Submitted approval to DPW/BBR to proceed with work as quoted. DPW Steamfitters submitted a quote for new equipment on 7/31/23. Equipment is due to arrive shortly. Given that FS 26's furnace install is nearing completion, DPW Steamfitters can start on FS 9's AHU replacement. Roof will be open for 1 week while sheetmetal is building curbs for the new units. Postponed until 1 week of clear weather is in forecast. Lift to remove old units off roof is scheduled for Monday, May 13. Curb adapters will be fabricated, and units will be set in place. 2nd lift TBD. Lift Review Meeting is scheduled for Friday, May 10th. Status Update: Old units were removed, and the curbs were fabricated. Lift to set new equipment was rescheduled to Monday, June 17th, 8:00 am. Steamfitters propose to complete gas piping and drains mid-July. Sheet metal will be done with the economizers and powered exhaust fans mid-July. Extra items that were not included with the unit: 1) Hail guard for the coils; 2) Exhaust extension piece to prevent flue gas from being pulled into the economizer; 3) a fuse block terminal at the power exhaust fan. These items were identified upon installation. Hail guards and flue extension pieces were delivered. Fuse blocks were installed for the power exhaust section. 2/3 units are started 1 remaining had a vent pipe that needed to be relocated for the power exhaust fan code clearance, which was completed by DPW plumbers. The exhaust fan on 1 remaining unit is ready to be installed and wired. Final walkthrough will be upcoming after completion. Terminal block for the power exhaust fan is being ordered, when part arrives we will install the power exhaust fan and wire. Units are running. Coil guards need to be attached. Status Update: All units have been installed and start-up is complete. The thermostats are programmed and operation was checked. All roof penetrations have been sealed.

FS 12: SO #2155506. Boiler re-pipe proposal. Received revised quote from DPW Steamfitters \$72,025.26. Approved by Support Services. Boiler re pipe has begun. New piping is installed and new pumps are set. We are waiting for alternating relay and power to be installed. Status Update: New pumps were installed and powered. Alternating relay has been installed as to switch pump usage for equal run time as well as to add redundancy and eliminate heating system downtime. Hydronic separator has been re piped and circuit setter was installed to resolve flow and efficiency issues, as well as eliminate pump dead head which has been wearing out system

pumps. Project is 95% complete as the Steamfitters need to re pipe the point of connection on the expansion tank due to the new piping reconfiguration and balance the new heating system delta P. SO #2369966 Drying Room heat is currently out of service. Steamfitters are preparing estimate to restore unit.

FS 13: SO #2154832. ESTIMATE RECEIVED for Furnace/Forced air units in dorm; price also includes replacing exiting ductwork: preliminary estimate \$80,000. Awaiting formal ESTIMATE from DPW/BBR. DPWs Steamfitters made a temporary repair, however 2/4 zones have bad heat exchangers and gas is locked out. Unit is working with temporary repair in place. Received estimate for \$104,888.00. Quote approved by Support Services. Waiting for labor availability and funding transfer. DPW Steamfitters are reviewing system operations of new units at St 26 then they will replicate system for St 13 as per discussion with Support Service's Assistant Deputy Chief and Stationary Engineer. Still discussing which units to purchase with SFFD Stationary Engineer. Waiting for equipment to be approved by Support Services. Steamfitters also propose surveying the electrical panel as discussed with SFFD. Waiting for labor. Equipment has been ordered Norman S. Wright. Status Update: As of 10/8/24, Steamfitters are waiting on a PO for the new equipment.

FS 14: SO #2203579. New pulleys, motors and belts were installed on the station's exhaust extractor system to improve intake. Fan not performing as designed. A rep from Nederman (manufacturer of the exhaust extractor) came on-site for inspection and recommended a different exhaust fan for the exhaust extractor. HVAC installation is complete. Nederman exhaust fan had to replaced and has been ordered; ETA is 3 months. DPW Steamfitters are still waiting for fan procurement. Issued PO to Air Filtration on 5/25/23. Replacement fan arrived. Waiting for labor. Status Update: New fan has been installed and is working by design. New springs are \$1,200.00 will take 16hrs labor + 2hrs supervision to complete installation. I will need to be advised on how to proceed. New fan spring isolators have been installed and fan is floating appropriately. Pump doghouse may be needed to further reduce noise.

FS 22: Re-circ pumps need to be replaced. DPW Steamfitters to conduct walk thru with Support Services then provide estimate for re-pipe. Moving forward with estimate for re-pipe. SO # 2314145 was submitted to SFFD for approval to re-pipe boiler. Waiting on client approval. Status Update: Still waiting on client approval 10/8.

FS 23: Heater in Officer's Room needs to be replaced including new t-stats, on-off switch. Drying Room needs new heater and exhaust fan. Modifying controls to include timer and on/off switch in or outside Drying Room. Waiting for quote from DPW's Steamfitters Shop for two heaters, one exhaust fan and the necessary control work. Quote received from DPW; in for ADC of Support Service's review. ADC of Support Services requested that a quote be provided just for the fan coil replacement. Status update: Steamfitters propose to modify the existing estimate and resend mid-July. SO # 2115449 was submitted to SFFD for the Officers Room heater replacement. As of 10/8, still waiting for client approval.

FS 28: Flushed entire heating system and strainers of fan coil and air handlers; will replace 3 t-stats. Pump was replaced and 2 of the 3 T-stats have been replaced. The last of the 3 T-stats installed in March. New equipment is not syncing with older equipment plus multiple zones with inadequate heat. Additional control valves and thermostats are needed. Quoted 3 days labor plus \$3,000 parts which was approved by ADC Mullin. New thermostats and control valves have been received and need to be installed. Installation scheduled for mid-July. New control module was installed on air handler. T-stats and control valves still need to be added to the 4 heating zones. We are complete with 3 of the control valves and t-stats. Steamfitters need to install 2 more control valves (which were buried in ceiling). All new thermostats and control valves have been replaced. Additional issues remain: HHW pump is making grinding noise and

control valves on the roof units are becoming severely compromised by exposure to the elements. DPW proposing to replace one pump and 2 control valves with weather shield for the roofing units. Waiting for equipment and labor cost estimate. The new pump and valves with the weather shield is \$4,600 installation will take approximately 2 men to install in two days. Approved by Support Services. Waiting for parts to be procured. Material is in, waiting for labor. New control valves were installed, and heat is on in the dorm and other areas of station. Insulating of rooftop is next. Steamfitters are monitoring the heating system's operations. Insulation on roof is complete. Still have one day of control wiring to complete on roof which will include adding a control box on the roof to fit the zone controller. DPW will schedule labor for 1 day to clean up the exposed control wire on the roof after HVAC start up at St 9. Currently waiting for labor. Status Update: Control wires have been rewired and box was installed on roof. Heating system including air handler re pipe, VAV control valves install and boiler pumps have all been restored. Cold spots have been fixed via air handler supply temp sensor and controls. Work has been completed SO # 2192773 has been closed as of 9/28/24.

FS 29: SO #2249790 Heating system is down. Noted that the pumps here on this system are frequently replaced. Steamfitters are recommending to re-pipe unit similar to FS 12. Status Update: Waiting on Support Services input.

FS 37: RADIATORS It was discovered that 17 radiators need new valves to control on/off. Nine (9) units do not work. Waiting for proposal to change out all valves. Drying Room Heater needs a 3-way valve and an outdoor air override that needs to be installed. Proposing two men to take nine (9) days, plus \$3500 in parts. The heat is on in the Station and the new program settings are adequate to get through the winter. Work will need to be done when they are permitted to shut Boiler down for a few days. Waiting for formal quote to be sent to ADC Support Services for sign off. Status Update: Deferred.

FS 41: SO #2155508. Boiler controls proposal. Received revised quote from DPW Steamfitters \$23,559.83. Approved by Support Services. Order of new relays and wire has arrived; DPW will schedule labor to replace contactors and relays in the control panel. Status Update: Work is scheduled to start on the boiler controls mid October, including new pump contactors and relays.

FS 43: DPW Steamfitters are investigating intermittent heat issues on 1st Floor. Waiting for findings. There is an existing radiant heating system on the 1st floor of the Station. Steamfitters are proposing to see if they can repair system which could resolve the heating issue. Steamfitters advise if unit is not repairable, they propose designing a new heating system for the 1st floor. Status Update: Project under consideration by Support Services. Steamfitters anticipate that they will be restoring the old system that was abandoned (as indicated in old system drawings) versus designing a whole new heating system.

CEMENT/ASPHALT

No major cement issues were reported.

EXHAUST EXTRACTORS

FS 34, 44 and 48 reported issues with units. Parts have been ordered to resolve and restore units. FS 23 and 18 reported issues with station's exhaust extractor previously. Waiting for quotes from vendor who will provide specialized fabrication. Received quotes which includes stainless steel exterior fans to prevent premature rusting. Processing purchase orders. Waiting on delivery dates. Status Update: Vendor advised that FS 23's fan is expected to arrive first

week in October. Installation will follow. FS 18's fan is expected to ship 10/17. Installation is anticipated to take place the last week of October.

GLASS/WINDOWS/SCREENS

No major glass/window/screens issues were reported.

No major carpentry issues were reported.

[M. Rossetto] FS35 Security Gate Enhancement: 9/24/24: BCDC issued the permit amendment 2018.002.02 dated 9/24/24. Port permit to follow.



Focused Scope Program (Michael Rossetto, San Francisco Public Works):

Total Funding allocated for the Focused Scope Program is \$21,407,279, approved by SFFD on 8/17/17. Work is complete in 8 of 9 of the Focused Scope categories comprising Roofing, Apparatus Bay Door Replacements, Exterior Envelope Improvements, Windows, Showers, HVAC/Mechanical, Sidewalk/Slabs, and Security Access Control. Work continues to progress through the last scope category, Generator Replacements.

Emergency Generators:

- FS 2 Scope of work: replace existing rooftop generator set, structurally strengthen roof structure to support new fuel tank with capacity for 72-hour run time and provide new fuel fill port and piping to generator.
 This project is complete.
- FS 19 Scope of work: replace existing generator at grade and replace main electrical panel.
 The generator lead time has increased. The manufacturer now reports a delivery date of April 2025.
- FS 14 Scope of work: replacement of existing generator with new rooftop generator, new subgrade fuel fill port at the sidewalk in front of the station, and new fuel piping from sidewalk to generator.

- DPW-BOA has been approved to re-initiate the project with a concepts phase to validate changing the generator from a rooftop to a ground-mounted location that will be fuelfilled by hand in lieu of piped. The concepts drawing was delivered to SFFD on 4/29/24 and approved. DPW held a design review with the new SFFD Captain and is awaiting SFFD direction to move forward with redesign. On hold.
- A pre-application meeting has been set for 10/25/24 to discuss the redesign concept with the Fire Marshal.

Exterior Envelope:

- o **Package 1 (FS 8, 20, 23, 29)** FS 8, 20, and 29 are complete; On 1/15/21, SFFD requested a hold on FS 23 painting due to other priorities.
- o **Package 2** (FS 24, 34) This project remains on HOLD initially placed at the request of Capital Planning in order to provide supplemental funding to the Police TC&FSD project. It is now expected that those funds will be returned to the SFFD for allocation to a priority project, possibly FS24 and/or FS34.
- o **FS 17 & 31** Exterior Envelopes were requested as new projects by SFFD in August 2023, both as lower priorities. These were approved by the Capital Planning Committee for use of ESER 2014 interest. A waterproofing consultant is recommended to determine corrective measures and potential costs.

Miscellaneous:

FS35 Security Fence Enhancements, FS17 Boiler Replacement & FS 29 Apparatus Bay Door Replacement were requested as new projects by SFFD in August 2023. These are ranked as the highest priority (most urgent) projects after the Network Modernization project.

- o FS 35 See Fireboat Station 35 description.
- o FS 17 Boiler Replacement ON HOLD per SFFD 12/12/23 email.
- o **FS 29** Apparatus Bay Door Replacement: JOC fee proposal from Rubecon was received, reviewed, and approved. Kick off meeting with Rubecon held on 6/13/24. Contractor agrees to provide door glass as specified at no additional cost. Submittals have been finalized allowing doors to be ordered. A 60-day door lead time is anticipated.
- ODT/FS 7 Railings: Permits obtained for both north and south sides in August 2024 with railing installation completed at the north. Due to training schedules, the contractor was asked to pause in September, however the south side installation was completed on 9/24. Inspections remain and the contractor will submit a CO to replace a ladder counterweight and cable found in poor condition (not original scope).

Network Modernization Project (Michael Rossetto, San Francisco Public Works):

- o 9/23/24: Construction NTP for MIK. Submittals & Schedule in process. On-site activities anticipated for October.

- Design progress estimates on 100% Schematic Design in September came in on budget. No value engineering or cuts were required. SFFD has accepted the completion of Schematic Design, and the design team was authorized to begin on the Design Development phase of work on 9/25/24.
- O SFPUC provided a determination on the project relative to the Non-potable Water Ordinance. They have agreed that the training structures are shell buildings and can be excluded from the gross building square footage, therefore the project is under the 100,000 square foot threshold and will not be required to have an onsite water reuse system. However, the project is over 40,000 square feet and will still be required to submit water budget calculations based on the criteria of the ordinance.
- WSP environmental engineers provided some preliminary comments in September on their review of the SCS Engineers draft smoke study which includes significantly lower projected emissions. They are still finalizing their review and will eventually provide a formal response along with a request for additional information. This review is instrumental in determining if

- Planning will consider possibly modifying or eliminating the smoke capture system identified in the CEQA as a mitigation measure.
- October. A final report with more detailed soils evaluation and foundation recommendations will be provided by December 2024 to better inform design during the Design Development phase.
- SFFD applied for a FEMA Grant on the project, and they have been told it is set to be approved shortly. However, with federal funding there is an existing restriction on "local contracting preferences" (e.g. San Fracisco's Local Business Enterprise Program). That restriction is set to change after 10/1/2024, therefore the advertisement of the combined RFQ and RFP (Request for Qualifications & Request for Proposal) for Construction Manager/ General Contractor services has been postponed until after 10/1/24.
- o Civic Design Review, Phase 1: Schematic Design is scheduled for presentation and review before the San Francisco Arts Commission (CDR Committee) on 10/21/24.

The PIO Office has been responding to incidents across the city and capturing rescues and more significant incidents as they happen. When the PIO arrives, they must consider the target audience for incident reporting. This can include alerting the public of a hazard, providing information on road closures or detours, and engaging the larger community in the efforts and successes of the San Francisco Fire Department. These messages will be in different formats, including visual aids, text, alt text for images and video. This includes video in both portrait format for social media and online sharing and landscape video for media partners to use instead of sending a camera crew to the scene. This variety of messaging allows SFFD incidents to be reported by the traditional TV and radio media swiftly.

September saw a significant jump in online reach of overall content, growing the Instagram audience by almost 90%, almost doubling the amount of accounts that viewed our reels, stories and posts.


