October 1 – October 31, 2024

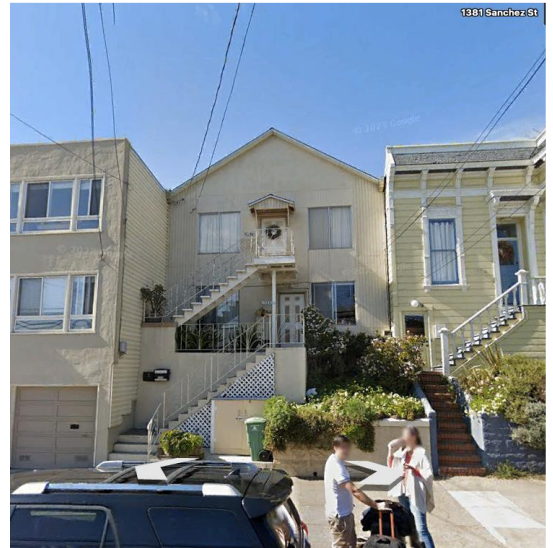
GREATER ALARMS:

There were four Greater Alarm fires during this reporting period.

2nd Alarm – (10/31/24) 02:29 hours, 1382 Sanchez Street, between 27th and Cesar Chavez Streets. There were no injuries. The Red Cross was notified of five displaced citizens. (Battalion Chief Marc Kasper)

San Francisco Fire Department responded to a fire at 1382 Sanchez Street which was a 3 story Type 5 building. It consisted of two residential units which were both occupied. The 1st floor was the basement level and the 2nd and 3rd floor were each living spaces with one unit on each floor. The second floor had an address of 1380 Sanchez Street. It was an older wood frame home with attached buildings on either side. The Bravo building was newer construction with 2 units with the address of

1386-1388 Sanchez Street. The Delta building was also an older wood frame construction building and was a single-family residence with the address of 1374 Sanchez Street. The fire building had a peak roof and there were several power lines in the vicinity of the fire building and neighboring buildings.



On the morning of the incident, prior to SFFD arrival, the resident observed the space heater in the front living space on the third floor “burst into flames” which warranted evacuation and call to 911. Engine 11 arrived on scene and reported a working fire on the third floor and that they were “extending a 200’ ready line.” They placed their apparatus in front of the Bravo exposure just past the property line of the fire building. Truck 11 arrived on scene in front of the Delta exposure. A secondary power line fell onto the turntable portion of the truck after it burned away from the weather-head on the fire building. Truck 11 had already removed their 35’ ladder and tools for roof operations. Battalion 6 arrived on scene and made an announcement that there was a power line down in front of the building and for all units to use caution while standing in safe proximity to maintain safety for arriving units. Battalion 6 also called for a PG&E response. Engine 26 was then directed by Battalion 6 to the second

floor of the fire building to ensure fire was not below the engine company on the third floor. They deployed the 150” ready-line. Truck 7 arrived on scene and extended their aerial ladder to the Bravo exposure on 27th Street. Truck 7 was directed by Battalion 6 to force entry to the Delta building to quickly check for extension. Division 3 arrived on scene and did a transfer of command with Battalion 6. Division 3 made Battalion 10 fire attack and assigned Battalion 6 to Safety as Battalion 6 was needed to perform all safety officers duties as well as maintain mobility to check exposures. Division 3 observed fire impinging on the eaves of the Delta roof as well as the siding of the Bravo building which had paint blistering. There was also smoke puffing from between the building of the fire building and Delta. The RIC team Engine 39 arrived, and Division 3 ordered them to get their RIC equipment and watch that “no members touch Truck 11,” and “guard the downed power line.” Division 3 also ordered them to obtain hose bundles and throw them on top of the power line. There was no electrical arcing observed at the incident by Division 3 but later saw arcing on a video early in the incident prior to Division 3 arrival. D3 called for a Second alarm due to the downed power line and exposure issues in the Bravo and Delta at that time. Also, due to the older wood frame construction of the Delta building and the concern of rapid fire spread, Engine 32 arrived on scene and Division 3 assigned them to check the Bravo building for extension with the 3” Large Line wye and 1 3/4” bundle. Engine 26 reported no fire on the second floor of the fire building, Division 3 redirected their 150” ready line and the crew to the Delta to address any extension. At this time, Fire Attack reported water on the fire, and it was obvious from the outside that crews had overcome the heavy fire found on arrival. It was also reported that there was no extension into the Bravo and Delta exposures. Truck 11 reported a hole in the roof and that there did not seem to be any extension into the exposures. When second alarm companies arrived, Division 3 began to



release companies as no other resources were needed. PG&E arrived and secured the utilities and the downed power line. Decontamination was set up with Engine 11 and Red Cross was notified for five displaced citizens. We then began the process of salvage and overhaul and let the residents of the unaffected units back into their homes.



The aggressive efforts of the San Francisco Fire Department were successful in quickly extinguishing this structure fire. It also contained the fire to one unit and protected the exposure buildings from further damage. The rapid notification and abatement of the downed power line protected our citizens and firefighters from serious injury.

2nd Alarm – (10/19/24) 03:11 hours, 1258 6th Avenue. (Assistant Chief William Storti)

A full box was struck at 1258 6th Ave. at 0311 hours for a fire between buildings. There were no delays in response or reporting and the alarm system had alerted the residents. Engine 22 was first on-scene, declared a working fire and led a 150' ready-line to a second-floor apartment to extinguish fire. E20 came on-scene and led the 150' ready-line down the tradesman entrance between buildings encountering fire; later they extended the line to put out fire between buildings. Truck 12 laddered the roof of the fire building and proceeded to the roof reporting heavy fire between the fire building and the apartment on the corner (445 Hugo) but no fire in the attics of either building. Battalion 5 came on-scene and established Command. D2 came on scene shortly after and took over command assigning B05 to Fire Attack and B07 to the exposure building.



D02 struck a 2nd alarm at 0326 hours. B08 was assigned safety. RS01 performed a primary and secondary search of both buildings with negative results. Truck 14 and 18 were assigned to the fire building and exposure respectively to perform overhaul. Second alarm companies were assigned to hose lines in the exposure building with large line leads to the 4th and 3rd floors.

Strategy was to attack the fire from both buildings and keep it from the attic spaces. All operations worked well, and the aggressive attack mitigated the fire.



Lightwell



2nd Alarm – (10/22/24) 17:28 hours, 3126 22nd Street. No injuries. (Assistant Chief Michael Thompson)

At 1738 hours a full box was struck for a Fire in the Building, with a reported fire on the roof. The building was described as a 3 story Buddhist temple next to a large church.

At 1741 hours, Engine 7 arrived and a working fire was declared within three minutes of dispatch. Engine 7 reported that the fire was on the second floor exterior and was running up towards the eaves.

Battalion 2 arrived and assumed command, while Battalion 6 was made Fire Attack.

Initial companies encountered a front door on the second floor that was very difficult to force. Efforts to force the door for the initial hose lines were rebuffed by a small entry landing, and what ended up being a barricaded door for entry. Upon further investigation, companies discovered that the “front door” had not been used for entry for some time.



As companies attempted entry, Engine 36 noted that the exterior fire was rolling up the exterior of the building on the Alpha and Bravo sides of the fire building, and the fire appeared to be in the attic. Engine 36 was directed to deploy an exterior ready line for the sole means of keeping the fire from impinging upon the Bravo side of the structure. If the bravo side was allowed to catch fire, it was certain that the approximately 10,000 sq ft church next door would become involved. Engine 36’s line was extremely successful in keeping the fire from spreading to the church on the Bravo side. This strategy, although uncommon, had a positive outcome.

Truck 7 placed an aerial to the roof of the fire building and began vertical ventilation using saws. Although they were successful, their efforts were slowed by the fact that most of the roof they were operating on was completely hidden due to the thick smoke emanating from the fire. As Truck 7 performed ventilation, Truck 11 laddered the Delta building with a 35’ extension ladder, and a 24’ straight ladder.

Finally, crews were able to blow the front door off it’s hinges and remove debris and furniture blocking the entrance to the second floor. They began an aggressive interior attack with Engines 7, 11, and 24 assisting Fire Attack with leading lines to the second and third floors along with members of Truck 11 and Rescue Squad 2. Third floor companies encountered intense heat and smoke as they performed search and rescue and fire extinguishment.

By now Division 3 had arrived and assumed command, sending Battalion 2 to command the fire fight on the second floor, while Battalion 6 as Fire attack lead the charge on the third floor.

At 1742 hours, a second alarm was struck.

As second alarm companies began arriving, possible motion in the main fire room on the third floor was noticed by Command, signaling a potential victim trapped on the third floor in the front window on the Alpha Delta side of the fire building. Fire Attack companies in the building were unable to make their way to this location quickly due to the large volume of fire.



Due to the potential need for rapid rescue, Command ordered companies operating on the Delta building to breach the exterior wall of the fire building with saws. From the Delta roof, Truck 11 cut a large hole in the exterior wall in front of them, and assisted by Engine 29 on a 1 3/4' hose line, were able to enter the building, and search the third floor. No victim was found. This action was only possible due to coordination between Command, Fire Attack, and Truck 11/Engine 29. Communication of the strategy was clear, and tactics understood before they were carried out.

1904 hours, the fire was declared under control.

This was a very good, coordinated firefight. Most importantly, the fire was kept from entering the much larger church building adjacent on the Bravo side. That would easily have caused this to become a fourth alarm due to the size of the structure next door.



Other considerations that were discussed post fire were:

1. The importance of opening all walls due to balloon frame construction contributing to rapid fire spread.
2. Although technically a single family home, this building housed Buddhist nuns, metal bed frames had been bolted to the walls and floor on both floors. They needed to be cut away from the walls during the firefight to check for fire spread.

3. The need to identify multiple alternative ingress options for the leading of hose lines.
4. The difficulties in fighting fires in trapped attic spaces.

Approximately 15 residents were displaced, 3 cats and one dog rescued from the Fire Building, and Delta. One firefighter was transported to SF General for back spasms.

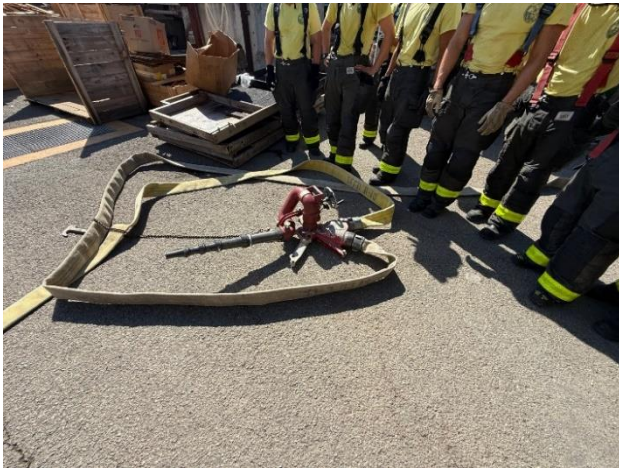

Neighborhood Response Team (NERT), Lt. Jonathan Honda
October 2024 Monthly Report

NERT is a free training program for individuals, neighborhood groups and community-based organizations in San Francisco. Through this program, individuals will learn the basics of personal preparedness and prevention. The training also includes hands-on disaster skills that will help individuals respond to a personal emergency as well as act as members of a neighborhood response team. San Francisco is made up of many neighborhoods. NERT trains San Francisco residents to be one ready community when it counts. Together NERT can create a lifeline between your family and neighbors, and the City's emergency responders.



Projects and Short-Term Plans

- Prepare for SF Ready Expansion. Demand coming in, Work out details of SF Ready 12/20/24, “150 students” anticipated, work logistics with DEM/Treasure Island regarding facility, capacity, AV system, etc.
- Confer again with Aaron Yen from DEM regarding upcoming SF Ready/DEM joint Community Education, goal is 3 by the end of this calendar year. More to follow.
- Prepare for Listos! expansion due to interest/demand in Spanish Speaking community, source materials, instructors, etc. Listos class was very well received, anticipate demand for courses to increase.
- Continue increasing availability/scheduling of SF Ready through remaining Calendar Year.

Challenges

- APEX software issues regarding mass communications being sent in a prompt manner. Took up to 2 hours to send one email message en masse (SFFD IT Dept to investigate throttling issue). Have had to revert back to ReGroup to send out mass communications in a timely manner but ReGroup subscription renewal has come and gone (was due 10/10/24).
- Failing equipment, ID Card printer and laptop needed to be rebooted multiple times. Took multiple attempts to successfully produce one ID.
- Many students sign up for classes, approx. 50% no show rate. Staff & logistics planned out for the expected number of signed up participants, but 50% no call, no show rate.

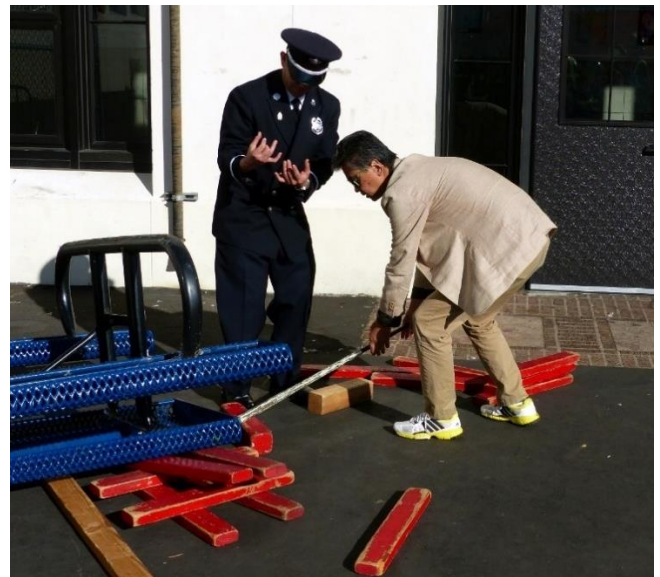
