

OPERATIONS REPORT November 1 – December 31, 2024

GREATER ALARMS:

There were two Greater Alarm fires during this reporting period.

2nd Alarm – (11/18/24) 22:49 hours, 150 9th Street. (Assistant Chief Brook Baker)

On November 18, 2024 at 10:50 p.m. Engine 1 was dispatched to an outside fire on Washburn Alley, between Mission and Howard Streets. While enroute to this call, a building alarm was transmitted from 150 9th Street between Howard and Mission Streets, to which Engine 36, Truck 1, and Battalion 2 were dispatched. When Engine 1 arrived on scene at Washburn Alley they found a very large outside fire consisting of construction materials and a port-apottie on fire adjacent to a four-story type 5 apartment building, with fire involving the entire exterior of the building from street level to the roof line. This type of fire presents a critical life safety threat to any occupants in the building because of the rapid spread of fire to all four floors of the building. Good communications and quick action by the crew of Engine 1, and good situational awareness and coordination from the units



responding to the building alarm at 150 9th street contributed to a successful outcome for this incident. Engine 1 encountered a difficult situation when they arrived at Washburn alley. Not only did they encounter four floors of fire, but there were live high voltage power lines down in the street, having been burned away from the pole by the fire, but they also had no additional engines responding to supply them with water. As they went to work stretching hose to attack the fire, units responding to the building alarm recognized that the fire was on the back of 150 9th Street in Washburn Alley, and they quickly reoriented themselves to respond to the location where Engine 1 was going to work to assist with the fire attack. Engine 36 supplied Engine 1 with water from a hydrant on Howard Street and then started stretching hose into the building to address the rapidly expanding fire. Truck 1 arrived and recognized that there was a need for truck firefighters inside the building to search for victims and fire, but also that the roof needed to be accessed immediately due to fire threatening to spread into the attic. Truck 1 positioned their apparatus in Washburn Alley and raised their aerial ladder to the roof of the fire building (the rear of 150 9th Street) and split up to accomplish their tasks. Battalion 2 immediately recognized the seriousness of the situation and called for a 2nd Alarm due to fire involving all four floors of a large wood frame building, with extension into the open attic space. This was a recipe for a large catastrophic fire.

I arrived on scene and met with Battalion 2 who had established a command post in Washburn Alley. We quickly discussed our assessment of the fire situation and both agreed that search and rescue of building occupants while stopping the fire from getting established in the attic were our top



priorities. This presented a unique challenge because firefighters would need to advance above the fire and trust that later arriving firefighters would be able to protect them by stopping the fire on lower floors. Battalion 2 and I agreed on the plan of attack, and he proceeded into the building assigned to Fire Attack on the top floor. Rescue 1 arrived on scene and was immediately assigned to search and rescue for any trapped occupants or victims in the fire building.

Meanwhile the remainder of the 1st alarm companies, and the 2nd Alarm companies began to arrive

and check in to the command post. These companies were assigned one by one to lead hose lines into the building beginning on the first floor, then the second and third, to protect companies led by Battalion 2

already working on the top floor. Meanwhile, an additional and extremely dangerous electrocution hazard still needed to be addressed in Washburn Alley as the live high voltage power lines in the street still posed a threat to firefighters working on the scene. While waiting for PG&E to arrive, an Engine company was assigned to cordon off the area with yellow tape and make sure no one came in close proximity to the wires. The situation inside the fire building posed challenges for firefighters, as the majority of the fire was now concealed in the walls and void spaces and needed to be accessed by ripping open walls with hand tools to locate and extinguish the fire as it attempted to spread to all corners of the building. This is extremely arduous work, especially when wearing full PPE including turnout and SCBA air masks. Stopping the fire from gaining a foothold in the attic also took a tremendous amount of hard work and coordination, cutting a hole on the roof to vent fire and hot gasses, while firefighters inside



stretched hose lines, raised attic extension ladders, exposed the attic by pulling ceilings with hooks, and then attacking the fire and cutting it off from burning the whole roof off the building. Without aggressive action and good coordination by firefighters who responded to this incident, it could have easily resulted in a fourth or fifth alarm and the destruction of dozens of housing units.

Due to the hazard posed by downed live electrical wires, and the frequence with which this occurs at fire scenes, I recommend that the SFFD coordinate with PG&E to find a better solution for protecting firefighters from electrocution hazard.

Operations note:

This incident highlights the importance of expecting fire. Companies prepared to fight fire and perform any necessary assignment were decisive at this greater alarm. Training and Company Officer leadership are the antidote to complacency.

2nd Alarm – (12/15/24) 08:31 hours, 30 Crisp Avenue (Temporary Assistant Chief David Thompson)

At 0834, E17 was dispatched to investigate a "smoke in the area" call. The call came in from a 3rd party caller who was not on-scene. They reported smoke coming from an abandoned warehouse in the Hunters Point Naval Shipyard area.

E17 followed the smoke once they were close enough to see it. Through some trial and error with closed off roads and access issues E17 was on scene at 0844 and declared a Working Fire. E17's initial report on tactical to B10 stated that this was a "1 Story Type 5 attached to a large Type 2 warehouse....unsure of extension into the Type 2 but the Type 5 is fully involved" Upon hearing this report B10 requested a Second Alarm while enroute. A Second Alarm was struck at 0849.

B10 and B6 arrived on scene and B10 set up command as Innes Street Command and B6 was assigned Fire Attack. Initial first alarm companies arrived on scene to assist E17 with supply from an uninterrupted water source and



were met with multiple issues. E25 initiated a split line lead east on Crisp Road to a hydrant approximately 900 feet away. However, the hydrant they tried to hook up to was dry. Simultaneously, E9 extended a split line lead approximately 700 feet in a westerly direction on Spear Ave. to a hydrant that also was dry.

During this search for water D3 arrived on scene and took over Command. Command was changed to Crisp Command, B10 was given Fire Attack of the Type 2 Building and B6 was given Fire Attack of the Type 5 Building. All Second alarm companies were requested to stage on Spear Ave just past Fischer Avenue.

E17 had brought a 200' ready line to the Type 5 to contain and extinguish the fire but due to the lack of a water supply as stated by E25 and E9 they were using a minimal stream.

RS2 was assigned Search and Rescue with assistance from T9 and cleared a Primary and Secondary search within the Type 5 and the Type 2.

The lack of a water source was quickly becoming a concern and two Engine companies from the Second Alarm were called in to supply their initial 500 gallons and then to run them in relay with E9. E4, E37 and E9 then took turns supplying 500 gallons to E17 and then refilling at the nearest hydrant. During this time frame E25 was able to secure a water supply from a hydrant located near the location of the dry hydrant they found earlier.

E25 was able to supply volume at 40 psi which allowed the 150' ready line, along with the preexisting 200' ready line, to be put in use from E17. With an uninterrupted water supply all Second Alarm companies were released at 0913. In addition, once two lines were operational the fire was called Contained at 0918. There was never any extension into the Type 2 warehouse, there were no Roof Operations due to the safety of the roof on the Type 2.

4710 was not required due to the discovery of cooking materials and ignition source at the point of origin, which confirmed cause and origin. It was determined that squatters had been using this area as a place of shelter and had accidentally caused the fire. Security on site had confirmed that individuals had been seen going in and out of this area regularly.

SF Water Department arrived on scene and were anxious to help us identify other water sources.



Security stated they could contact the property owner, and the building was left in their care. D3 went back in service at 1005 and left Command with B10.

At 1030 B10 stated that the fire was Under Control and that no Red Cross was needed.

This could have easily been a fire that got the best of us but due to a coordinated effort by first responding units this was kept from being a much larger and dangerous fire.



Important considerations going forward:

- 1. Dry hydrants in that area need to be identified as such.
- 2. Knowledge of the area was key in identifying wet hydrants to conduct our refilling of Engines as well as finding a continuous water supply. It is important to keep up Area Orientation drills throughout Hunters Point Naval Shipyard.
- 3. Special calling a water truck was a consideration that had not been thought of till after the fire.
- 4. With all the dead ends and closed access roads it is important to have updated maps and routes to access all of Hunters Point Naval Yard for responding units in Battalion 10.

Operations note:

A continuous and redundant water supply is a key to SFFD Operations. Incident Commanders may need to assign multiple companies to water supply in circumstances like the Crisp 2nd Alarm. A water supply officer can coordinate the activities of these resources. Company Officers must ensure their task of water supply is complete through direct supervision and crew management before assisting in fire attack.

November 1 to December 31, 2024 Monthly Recruit Training Report of Activities

November 2024: The 134th SFFD Academy Class graduated 48 members into the department on November 15th, 2024. The ceremony was held at the Scottish Rite Center in San Francisco. The class included 5 veterans from the military, seven from the SFFD Fire Reserves, several personal fitness trainers, professional athletes from football and lacrosse, a scientist, and one acrobat from Cirque du Soleil.





One of the highlights in the academy is a 10-mile jog along the SF Bay, starting at Fort Point, traversing across Aquatic Park and Pier 49, along the Embarcadero and then to SFFD Headquarters. The jog continues to Chase Center and the group finally returns to the SFFD Training Facility.







In the weeks leading up to graduation, the 134th Academy class learned Standard Operating Procedures for working with Master Stream Appliances and the importance of decontaminating procedures after working fires or any incident that puts them in contact with Hazardous Materials.



The 134th Class was able to experience simulated incidents during the night. The Training Academy, with the approval of the Command Staff, put on a Firehouse Night that allowed recruits to put out small fires, respond to building alarms and medicals in the evening hours, as they would at the firehouse once they leave the academy. Projects and Short-Term Plans

- Continue working with Aaron Yen (DEM) to continue NERT/DEM partnership to increase SF Ready preparedness.
- Prepare for Listos! expansion due to interest/demand in Spanish Speaking community, source materials, instructors, etc. Listos class was very well received, anticipate demand for courses to increase, more in depth topics (first aid, CPR training, curriculum delivered in Spanish)

Challenges

- Lots of students sign up for classes, approx. 50% no show rate. Staff & logistics planned out for expected number of signed up participants, but 50% no call, no show rate.
