

#### **OPERATIONS REPORT**

February 2025


#### **GREATER ALARMS**:

There was one Greater Alarm in February.

**2<sup>nd</sup> Alarm** – 1750 Mission Street, 1858 hours (Assistant Chief Nicol Juratovac)

Engine 36 arrived on scene and reported a working fire. Battalion 2 and Division 3 arrived shortly thereafter at 1901 hours.

Battalion 2 put Mission Street Command in Service with the Command Post location in front of the fire building. Division 3 arrived shortly thereafter, and received from Battalion 2 the



Command confirmed that Engine 36 was leading a 150' 1 3/4" Ready Line to the ground floor unit, Apartment 10, that was heavily involved in fire. Command then confirmed that Engine 6 was leading the 200' 1 3/4" Ready Line to the 2nd floor as fire was auto exposing from the 1st to the 2nd floor. Command then ordered Truck 6 to split the crew due to many victims present at windows near the fire escape with smoke present and victims reported to be overcome by smoke in need of immediate rescue. This decision was also coupled by the fact that Truck 7, the second Truck, had not yet arrived on scene. Truck 6 proceeded to ladder the building with its aerial and sent two members to the roof and two members inside. Upon Truck 7's arrival, Command ordered them to secure a second means of egress off the roof and have all members (except the Driver) to assist with search and rescue operations and the



evacuation of victims. Truck 7 also laddered one of the fire escapes while the other had its accordion ladder down with four residents climbing down from.


Upon the arrival of Rescue Squad 2, Command ordered them to perform a primary and secondary search of the fire building. Command directed Battalion 5 to serve the Safety Officer. Command directed Engine 29 Rapid Intervention Crew (RIC) to shut off gas and electricity in Apartment 10 only. While these assignments were being done, Command was becoming increasingly aware of additional residents trapped and or overcome by smoke. In addition, smoke had visibly traveled well into the 2nd and 3rd floor including the hallways.

At this juncture, Command struck a 2nd Alarm. Command assigned Rescue Captain 3 as Medical Group Supervisor to set up Triage, Treatment, and Transport directing and supervising Medic 567, as well as additional Medic Units that were dispatched). Command gave him the authority to order EMS resources as he needed and to secure a Medical and Transportation Channel if needed.

Command performed a quick accountability check and requested the location of Engine 7, the 3rd due Engine. They responded that they were on the 2nd floor checking for extension and assisting with evacuating residents overcome by smoke. Upon the arrival of 2nd Alarm Companies, Command ordered Truck 1 to secure the Charlie side of the building on Woodward Street and deploy its aerial. Command also directed Battalion 3 to serve as the Search and Rescue Group Supervisor directing and supervising Rescue Squad 2 and Engine 3 to ensure that all affected residents were removed from the IDLH environment in this large multi-story building. Command then reiterated to the Fire Attack Group Supervisor that he had Engine 36, Engine 6, Engine 7, half of Truck 6, and Truck 7 working for him to ensure that we had extinguishment of the fire in Apartment 10, and checked for any extension to floors 2, 3, and 4.

Throughout the incident, a total of five adults were evaluated complaining of smoke inhalation with two being transported, one of whom suffered serious burn injuries. Five cats were rescued and removed from at least three different apartments at the request of their owners. Animal Care and Control was dispatched only for cats that had not yet been accounted for by residents. Command then ordered RIC to set up the Decon Station at the bumper line of Engine 36 consistent with the SFFD's new protocol to promote its commitment to the health and safety of its members.

#### **OBSTACLES ENCOUNTERED**

Multiple occupants were in this 27-unit building, including several who were overcome by smoke.

Rapid vertical smoke spread on to floors 2 and 3 including hallways making evacuation challenging for residents attempting to flee on their own. Visibility was next to nil on these floors.

Some doors had to be forced open in order to ascertain whether any residents were in need of rescue due to smoke traveling into some of these units.

#### CONDITION OF BUILDING AFTER FIRE

Apartment 10 was deemed uninhabitable by Fire Attack Group Supervisor due to heavy fire and smoke damage, as well as the presence of Carbon Monoxide. The building was handed over to the Building Manager and he was educated about securing the facility to avoid burglaries and theft. SFPD also notified, per SFFD SOPs.

#### **STRATEGY**

The strategy employed was an offensive interior aggressive attack due to the occupancy type and high life hazard profile of multiple tenants. Strategy also included the rescue of any civilians on the ground floor units, as well as any overcome by smoke or fire on floors 3 and 4.

The goal was for Engine 36 to get to the seat of the fire in order to extinguish it as quickly as possible to allow for safe removal of victims from the fire building. Engine 36 performed this tactical objective very well in the true mission of the SFFD's interior aggressive attack operational culture.

The next goal was to prevent fire from spreading vertically to additional units. Every effort was made to prevent fire from entering additional units, which was accomplished. The goal then became removal of all occupants overcome by smoke.

Horizontal ventilation was achieved to assist in smoke removal and evacuation of occupants. Overhaul was performed during fire suppression and after containment. Salvage involved preserving the personal property of residents, as well as preserving evidence for 4710 Fire Investigators.

The acronym commonly used in today's fire service is SLICERS and was applied at this fire from the first in Engine Company's arrival. For example, Size Up was accurate in that fire was identified in the ground floor unit. Locating the fire was also accurate as fire extended to the 2nd floor and smoke was traveling vertically up to floors 2 and 3. Identifying and controlling flows paths were also achieved by ensuring that the seat of the fire was accurately identified in Apartment 10. Cooling the space was quickly achieved by deploying the 150' 1 3/4" Ready



Line. This allowed for quick and aggressive <u>Extinguishment</u> of the fire, thereby facilitating <u>Rescue</u> and eventually <u>Salvage</u>.

#### OPERATIONS THAT WORKED WELL

Companies performed in a bread and butter SFFD firefighting operation. They did so quickly and aggressively extinguishing the fire, then rescuing and evacuating multiple residents in this multiresidential multi-story occupancy.

#### RECCOMMENDATIONS

- 1. Engine Company members tasked with leading a hose line to upper floors must bring a set of Irons particularly when a Truck Company is not present.
- 2. All members must maintain crew integrity. Get in together, stay together, and get out together. If you deviate, communicate to your Officer so he knows where you are at all times.
- 3. Supply Engine should lead out to a hydrant away from the incident instead of being right next to 1st in Engine particularly if 1st Engine can stretch its own 3" line and secure its own supply.
- 4. Both fire escapes should be laddered.



## **Annual High-Rise Inspection Status for 2025**























## Report

Planning, training and collaborating was conducted on many levels this month. We are forecasting training events 3 months in advance for rope rescue and confined space for Rescue Squads and Truck companies 14 and 19. The training calendar has been filled with our companies cross training in their target rescue areas. Hazmat recertification and Rope Rescue Awareness classes with instruction provided by outside agencies were offered to our members this month. SFFD was able to take part of a multi-agency training with CHP, Golden Gate Bridge Authority and the Southern Marin Fire Department for a coordinated response to the Jumper Prevention Nets on GG Bridge.

Special operations was able to participate in the Transit committee's BART drill and attend the Training Committee's LWLP workshop planning session. Currently, our priority is re-focusing training needed to train a new set of qualified small boat operators for full staffing of Station 16 & 35's rescue boats. We would like to focus on safety, size-up, stabilization, and preparing the vehicle before extrication takes place. There is also a need to give additional training to our rescue squads to prepare for the more advanced rescue scenarios that may arise.




