

OPERATIONS REPORT April 2025

There was one Greater Alarm fire during this reporting period.

Summary

On April 5, 2025, at 1756 hours, Box 1634 was struck for a reported FIB at the intersection of Washington and Larkin Streets. After many phone calls, an updated address of 1664 Larkin Street was given. The corner fire building was a 4 Story Type 5 multi-unit residential building with entrances on both Washington and Larkin. Engine 41 arrived first on-scene and initially had fire showing from a 2nd floor unit on Washington Street. The fire unit was under construction resulting in rapid vertical fire spread in the fire building from the first floor to the attic space. In addition to the advanced fire upon arrival, topography and wind conditions contributed to fire spread with fire ultimately spreading to the Bravo Exposure, a 3 Story Type 5 multi-unit residential building. This incident required multiple alarms, coordinated command, and effective communications to effectively suppress this fire.



Sequence of Events

Engine 41 arrived first on-scene and declared a working fire with a fully involved 2nd floor unit on Washington Street. Fire began to auto expose to the floor above with wind pushing fire uphill towards the Bravo Exposure. A corrected address was given as 1664 Larkin Street, but access to 2nd floor units was from the Washington Street entrance. Engine 41 deployed a 150' ready line to the 2nd floor unit from Washington Street to extinguish the main body of fire. Truck 3 was the first arriving truck and laddered the fire building with their 100' aerial ladder to the roof and their 22' fire escape ladder to the

fire escape on Larkin. Truck 3 split their crew to assist occupants off the 2nd floor fire escape and perform a primary search.

Engine 2 and Engine 38 arrived on-scene at the same time, and both supplied Engine 41 from the low-pressure hydrants on Larkin and Washington Streets. Battalion 4 and Battalion 1 had a face-to-face transfer of command with Battalion 1 being made fire attack and Battalion 4 assuming command. Truck 2 parked in the intersection of Washington and Larkin Streets and was unable to clear the overhead wires for an aerial shot. Due to the advanced fire impinging on the Bravo exposure, Engine 38 and Truck 2 were directed to make a lead into Bravo and check for fire extension. Fire Attack (Battalion 1) made contact with Engine 41 on the 2nd floor and checked on fire conditions. Engine 2 was directed to make a 200' ready line lead to the floor above the fire.

Truck 3 Roof reported fire in the attic and fire spread to Bravo. At this time a Second Alarm was requested and Division 2



assumed command from Battalion 4. Fire Attack went to the top floor to check on conditions and the fire in the attic. Rescue Squad 1and Truck 3 Interior performed primary search of the fire building and assisted two occupants out of the building who were attempting to shelter in place.

Fire Attack requested 2nd alarm companies to bring a large-line wye, ceiling hooks and attic extensions to the top floor to combat the fire in the attic. Division 2 directed Engine 1 to back down from Hyde Street to the fire building positioning themselves as a manifold should the fire grow in Bravo and spread to Bravo 2.

Safety Issues for Review

Company and Chief Officers must communicate significant findings on the interior of a structure. A building under construction must be relayed immediately.

Splitting of Truck Companies should be the exception, not the norm. Additional arriving Truck Companies must consider what tasks are being addressed by the first arriving Truck.

Operations note:

Greater Alarm Engine Companies shall spot High Pressure Hydrants, attach Gleeson valve(s) (Pump Operations Manual Section 3.8), and check in at the Incident Command Post updating the IC. Greater Alarm Truck Companies shall check in with ceiling hooks and attic extensions at incidents with reports of fire in the attic space.

- 4/23: Observed the Golden Gate Bridge Authority participate in training with our In-Service Staff at TITF. This is the beginning of a great partnership and collaboration in which they are

donating and disposing of several vehicles which our members will be using for extrication drills free of cost.

- Additionally on 4/23, I attended a site visit behind De Young Museum for a future Emergency Water Supply drill to show our capabilities.
- 4/24: Met with Captain Watrous to discuss removing Trailers from DOT Folsom and also making room for a storage container for BOE equipment.
- Attended a meeting on 4/24 with CD2 and BC O'Connell at St21 to discuss the upcoming Truck Academy.

Additional Activities and Projects:

- I am continuing to support B4 to complete the open task-book for Station 16 members to complete their Large Vessel Boat Operator course. I am working with BC Styles to get another class in early June to bolster our cadre.
- Captain Novo has been participating in the 135th Academy to prepare himself to take over for Captain Yuen for the 136th Academy that will start July 28, 2025.
- We had 21 members apply to be instructors for the 136th Academy. There will be a projected 12 open spots for instructors. Interviews are scheduled for 5/13 and 5/14.
- I am working with SFPD to use the EVOC course at Pier 96 for the upcoming Driver Training Class for members getting off probation from the 133rd class. This class is projected to start in early July. This EVOC course has several hundred cones in place and will be adjusted to challenge the students in fire department vehicles. The cone course will only be a portion of the class curriculum.
- I am working on several upcoming classes for our members. Our forcible entry doors have been delivered to TITF. We will have three 1-day classes in mid-June with these doors. It will be an all-day class in which we will conduct forcible entry in a "Crawl-Walk-Run" style. There will be obstructions and smoke conditions. This class will be taught by our own members.
- The DOT is working with suppression members to put on an all-day vehicle extrication class in the October time frame. We are hoping this will be three 1-day classes to capture many of our members. This class will be taught by our own members.
- The DOT will be starting a "PodCast" in August-September that will memorialize information from our members in regard to fires, rescues, and just general experiences. This podcast will be put on our online training which will generate CJAC revenue for future training. It will later be put on our training website (sffdtraining.org) to be accessed anytime for future members.
- In-Service staff are currently working on an upcoming RIC (Rapid Intervention Crew) module at TITF. This will be rescuing downed firefighters under some conditions. The module will also have a command component and an EMS component. The EMS component will allow our EMS personnel to "bridge the gap" with suppression personnel in a training setting.
- EMS Training is preparing for the upcoming H3 L-1 academy on 5/5 with a graduation of 7/25. They are also preparing for the H3 L-2 academy on 6/2 with a graduation 7/25.

• Special Operations conducted several drills with the CHP helicopter this month. I am meeting FF/PM Canning on 5/5 to discuss putting on a Tower Rescue Class (see example pic) here in San Francisco to get more of our members certified to work with helicopters for future operations.





- I am collaborating with WAYMO to give our members training on the WAYMO Operations. This will better prepare us for incidents involving these vehicles.
- I am working with City Attorney Sarah Fabian to acquire the old Post Office on Treasure Island that is being demolished to make roofer the Bay FC practice facility. We will conduct truck operation training on this building if it is acquired. This will include laddering, tactics, and vertical ventilations by cutting holes in the Tar and Gravel roof.



CJAC FUNDS:

The CJAC funds continue to increase with the implementation of the new weekly drill schedule and support of the membership inputting their training. Another new SFFD record has been set for the month of March at 9230 hours. These funds are generated for the apprentice firefighter from the time period of 17 months employed to 5 years employed. The state provides approximately \$4.60 per hour of training. The March hours compute to \$42,458 in revenue that is used to continue to train our members. These funds are used for training materials and classes on a vote basis by the 6 members of the CJAC committee. The CJAC committee is made up of 3 members from the administration, and 3 members from labor. The administrative members are ADC Kasper, EMS Section Chief Treff, and EMS Captain Chis Bonn. The labor members are 798 President Kauf, Vice-President Gebler, and Treasurer Riahi. The committee is in alignment to provide "the most training for the most members"

with these funds. The goal is that the things that are purchased provide training, which in turn, provides more CJAC revenue. It is a rolling fund that builds itself. Recent Purchases in April include:

- Rope Rescue equipment for special Operations Training under Captain Tyson Yee
- A class for Rescue 2 members for Thermal Imaging Camera Training in which they will deliver the content to members in the field after the conclusion of the class.
- A request was just submitted to the committee for MMS equipment for the future podcast. It is awaiting a successful vote by the committee.

March 2025 Monthly Report

April was a busy month for training. As Truck companies came to the tower to test their probie's aerial ladder skills, crews were invited to take part in a RIT/EBSS drill at the base of the tower. There were profile changes, victim rescues, critical communication practice, and an Emergency Breathing Supply System review. The drill was challenging for both the new recruit and the seasoned veteran. If a member forgot or had never been shown FF survival skills, we did a ground school to teach the techniques to be successful. The response from the firefighters have been very positive and improvements have been made for the next round of training (metal cutting/forcible entry).

Week 2 was dedicated to both our Rescue Squads to practice large area search techniques and activation of RIT duties at a fire. This involved utilizing a search rope with knots and rings built into the line for orientation and maintaining and anchor while searching. Many lessons were learned and reinforcing that we need to practice regularly to be proficient in all our skills. RS2 was dispatched to a working fire during one of the drills and had a slight delay changing out to fresh bottles for the incident. We will have reserve packs at the ready for in the future.

Week 3 was Helicopter Rescue Training with our outlying companies E14, T14, B07 and RS1. The goal was for technical proficiency with helicopter rope operations. I believe that getting companies together to train and communicate was just as valuable as the technical skills learned. HRT water rescue capabilities were also demonstrated at Pier 30/32 with companies E04, T04, E35, FB3, and B03. CD1, CD2, and Fire Commissioner Nakajo were present.

Special Operations continues to make contacts and collaborating with outside agencies- Golden Gate Bridge Authority, California Highway Patrol, Southern Marin Fire Department, and BATEP. These agencies participated in our Battery Fire Training at the DOT. SFFD hosted the GGBA at TI and put together two live fire training events. We have been working together for safety planning and coming together for larger more elaborate drills. Next month, SFFD will be the host agency for another collaborative joint training on Treasure Island- Disentanglement and Civil Disturbance Tactics.

Although I have been busy with special operations events, I have tried to work collaboratively with the other branches of Training: In-service, EMS, NERT, and Recruit training. I assisted with ladder evaluations for Recruit Boot Camp, Burn Safety Officer for Live Fire Day with the Mayor's Office & City Supervisors, and helping with the cribbing station at the NERT City-wide Drill. I will be on vacation from 4/23 through the end of the month. Special Operations Training will resume as soon as I get back on 5/5/25.
