- Sulforaphane Study Funded by SFFCPF
 - The samples are out at 3 different labs for:
 - Epigenetic Analysis
 - CRP (inflammatory marker)
 - Metal Analysis
 - PFAS Analysis
 - Results expected to be late July
- IGNITE (AKA Nutrition Study) Funded by SFFCPF
 - HSW was able to send another recruitment letter, hoping to keep the recruitment to SFFD but we are experiencing low numbers, Stanford may open it to outside SFFD.
 - In an effort to recruit more SFFD members, HSW was able to put this link on Sharepoint: <u>Christopher_Gardner_IGNITE_Recruitment_Video.mp4</u>
- Fuel Pump Study Funded by MKThink
 - Station 2 & 5
 - Phase 2 of the study is launching next week.
 - As a summary, we are collecting Indoor Environmental data from 3 sensors in each station and received one month of roster activity (1/20 to 2/20). We are now proceeding with installing computer vision sensors to map at the station level 3 types of behaviors, plus benzene sensors, and to have the best possible outcome/value
 - Working with I.T/Facilities. to get:
 - Roster information by day per station

- Avg hourly compensation rate

Health, Safety & Wellness Liaison - Talking Points & Focus Areas in Station Visits:

1. IGNITE Nutrition Study

A firefighter-focused cancer prevention study led by Stanford and supported by SFFCPF and SFFD.

2. Cancer Champions Program

We need at least one Cancer Champion in every firehouse (more are welcome).

- Champions serve as a conduit for health and safety info related to prevention and screening.
- Your role includes helping identify these members and reinforcing their purpose across the station.

3. DetectTogether.org – Early Detection & Education

Educate members about the value of early detection and available resources:

- Promote <u>DetectTogether.org</u> as a trusted tool tailored to firefighter risks.
- Encourage members to be proactive in cancer screenings and symptom follow-up.
- Stress that early detection saves lives—and our exposure risk is higher than the general population.

4. Broc Shot – Firefighter Protection Program

Make members aware of the Broc Shot Firefighter Protection Program:

5. Firefighter Cancer Screening Recommendations

Encourage members to be proactive with their annual physicals by discussing these SFFCPFbacked cancer screenings with their Primary Care Provider (PCP):

- Lab work: SMAC20, CBC w/ diff, CRP, A1c, Vitamin D, Urinalysis
- Skin: Annual head-to-toe by dermatologist
- **Oral**: Dental exam of mouth and throat
- **Thyroid**: Physical exam

- **Lung**: If 55+ with smoking history
- Cervical: Starting at age 21
- **Breast**: Age 40+, or earlier if high-risk
- **Colorectal**: Starting at age 40
- Bladder: Annual exam for blood in urine
- **Prostate**: PSA and digital exam starting at 45
- **Testicular**: Baseline exam starting at 40

6. Annual Wellness Exam Policy

Starting in January 2025, all SFFD members must complete an annual wellness exam through their PCP. <u>Participation directly affects Grant Qualification</u>.

BHU Journal Highlights:

- Calls for service continue to increase, illustrating a growing awareness of the BHU team, greater comfort with accessing BHU services (reduced mental health stigma), and a growing demand for first responder support services.
 - Calls for service increased by 252% compared to June 2024 (6/2024: 70; 6/2025: 177).
- June 2025 Top Stressors:
 - Career Concerns: interpersonal issues with coworkers, change of assignment, promotional exams, leave options, workers' compensation claims.
 - Critical Incident: pediatric trauma/death, traumatic death, suicide.
 - General Stress: referral to therapy, health concerns, and anger management.
 - Family/Marital Problems: therapy for family members, couples counseling, separation/divorce, child custody.

Fireboat/Energetix DOT Testing Program

- The Fireboat / Engineer testing is now under the random testing program and the names are added to the draw pool daily from Datco Services.

Random Alcohol and Drug Testing Program

- The Random Alcohol and Drug Testing Program was compliant for the month of June. No positive tests recorded. Monthly checks of testing equipment / inventory completed for ISB 1&2, AP, D2, D3, and MD office.

Conditional Offer, Promotional and End-of-Probation Alcohol and Drug Testing Program

- Fifty-Six (56) members participated in pre-employment, promotional, and end of probation alcohol and drug testing with the M.D. office. Seven (7) DOJ LiveScan were also completed.

Post Accident Investigations

- Four (4) post-accident investigations were conducted in June. Four (4) members tested in total (One hose tender, three engines).

California Driver Licenses (CDL)

- Cpt Carter continued to monitor all dept. members' driver licenses via CA DMV Pull Notifications.

- ISB continued driver license audits. Added new employees into DMV system and removed employees no longer employed by SFFD.

- ISB office continued to update all members' licenses and DL546 health questionnaire forms in HRMS. Forty-two (42) CDLs updated/renewed in June. CD3 memo (25-03) was released 5/21/25 to assist getting all members current with DMV health questionnaires and completing the Firefighter endorsement on their driver licenses. One-hundred three (103) DL546 forms completed and verified with the DMV between 6/01/25 and 6/30/25.

Background Investigations

- After completing thorough background investigations, twenty (20) candidates began the EMS Academy class 27/13. Eighteen (18) recruits currently enrolled as of 6/30/25.

- ISB began digitizing all records of all past background classes, a monumental task but much needed to adequately store personnel records.

Other Business

- Cpt Carter and Therapy K-9 Clifford met with the Officer of BHU (Scola) of the BHU to discuss the possibility of a psychiatric portion for the background process.

FACILITY MAINTENANCE & PLANNING (June Waechtler, SFFD)

• A total of 87 requests for service were initiated and 84 service orders were completed and closed out in June.

PLUMBING

• 16 service calls were placed to resolve minor plumbing issues (faucet, toilet, urinal repairs; clogged sinks, shower drains) in the month of May. Four sewage backups were reported during this month (FS 34, 23).

HVAC/HEATING/BOILER

FS 13: SO #2154832. ESTIMATE RECEIVED for Furnace/Forced air units in dorm; price also includes replacing exiting ductwork: preliminary estimate is \$80,000. Awaiting formal ESTIMATE from DPW/BBR. DPWs Steamfitters made a temporary repair, however 2/4 zones have bad heat exchangers and gas is locked out. Unit is working with temporary repair in place. Received estimate for \$104,888.00. Quote approved by Support Services. Waiting for labor availability and funding transfer. DPW Steamfitters are reviewing system operations of new units at St 26 then they will replicate system for St 13 as per discussion with Support Service's Assistant Deputy Chief and Stationary Engineer. Still discussing which units to purchase with SFFD Stationary Engineer. Waiting for equipment to be approved by Support Services. Steamfitters also propose surveying the electrical panel as discussed with SFFD. Waiting for labor. Equipment has been ordered from Norman S. Wright. As of 10/8/24, Steamfitters are waiting on a PO for the new equipment. The equipment is due to arrive week of December 2, 2024. After inspection, work will be scheduled to commence. Work has started on the furnace replacement. Gas piping has been capped off for demolition. A new thermostat wire is needed to operate new units; conduits and junction boxes have been traced to pull new wires. New wire has been pulled throughout dorm. Four new furnace units are set in place. Gas will be piped after ductwork is complete. Gas piping is complete. Power and controls to the 2 fan units are complete. Flue piping on furnace is scheduled to be completed 2nd week in March. Start up of new units will take 3rd week in March Sheet metal materials were delayed. The installation will take place 4/9-4/10. Units will start the day after sheet metal is complete. Status Update: Start up was performed on all 4 units and are working as designed. The dorm room unit had obstructions in the ductwork and a separate estimate was submitted for a test and balance which included repairing the fusible links on 2 of the dampers. Scope of work and start up was discussed with SFFD Building Engineer. Thermostats programmed. Job completed. FS 17: Boiler replacement estimate is being revised by DPW Steamfitters for consideration. Status Update: Estimate was submitted to SFFD in March. SO# 2484755. ESER funds have been approved and job is in planning stage.

FS 22: Re-circ pumps need to be replaced. DPW Steamfitters to conduct walk through with Support Services then provide estimate for re-pipe. Moving forward with estimate for re pipe. SO # 2314145 was submitted to SFFD for approval to re-pipe boiler. Waiting on Client approval. SFFD approved scope of work to be performed. Re-piping material estimate has been submitted to DPW's Purchasing Department. ETA for equipment and material week of

2/17/25. Currently making improvements on re-piping the mechanical room to include new pumps and a new caleffi hydraulic separator. Installation is complete. System operation is being observed, and temps are being adjusted to system design. Heating hot water pumps are running quieter than before. The hydronic heating system flow rate was lowered and radiators are working better. Status Update: Work completed.

FS 23: Heater in Officer's Room needs to be replaced including new t-stats, on-off switch. Drying Room needs new heater and exhaust fan. Modifying controls to include timer and on/off switch in or outside the Drying Room. Waiting for a quote from DPW's Steamfitters Shop for two heaters, one exhaust fan and the necessary control work. Quote received from DPW, in for ADC of Support Service's review. ADC of Support Services requested that a quote be provided just for the fan coil replacement. Steamfitters propose to modify the existing estimate and resend mid-July. SO # 2115449 was submitted to SFFD for the Officers Room heater replacement. Waiting on Client approval. Approved by SFFD. A unit heater has been ordered. Status Update: Waiting for unit to arrive.

FS 29: SO #2249790 Heating system is down. Noted that the pumps here on this system are frequently replaced. Steamfitters are recommending re-pipe unit similar to FS 12. Waiting on Client approval. SFFD approved scope of work to be performed. The material estimate has been submitted to DPW's Purchasing Department. Status Update: Waiting for SFFD approval to order additional materials as needed. Work has been approved, awaiting scheduling. FS 37: RADIATORS It was discovered that 17 radiators need new valves to control on/off. Nine units do not work. Waiting for the proposal to change out all valves. The Drying Room Heater needs a 3-way valve and an outdoor air override that needs to be installed. Proposing two men to take nine days, plus \$3500 in parts. The heat is on in the Station and the new program settings are adequate to get through the winter. Work will need to be done when they are permitted to shut boiler down for a few days. Waiting for a formal quote to be sent to ADC Support Services to sign off. Deferred by SFFD, however DPW will be submitting a new estimate for the boiler work. Status Updates: Estimates for the controls work and radiator valves submitted to SFFD for approval. Work approved, awaiting scheduling. FS 38: Drying Room pump has failed. A new drying room pump has been ordered for replacement. Status Update: Job Completed.

FS 41: SO #2155508. Boiler controls proposal. Received revised quote from DPW Steamfitters \$23,559.83. Approved by Support Services. Order of new relays and wire has arrived; DPW will schedule labor to replace contactors and relays in the control panel. Status Update: Work is scheduled to start on the boiler controls mid-October, including new pump contactors and relays. Status Update: System needs new expansion tank and PRV. Boiler is working; new parts will prolong the life of pump and boiler. Anticipate that the new parts will run approximately \$3,000; 32 hours of labor needed for installation. Waiting for client approval. SFFD approved scope of work to be performed. Parts estimate has been submitted to DPW's Purchasing Department. PRV and new expansion tank have been installed. Status Update: Job complete.

New SFFD Division of Training Development

- Swinerton Builders and the DOT project team visited the project site, explored options for the design and installation of the west side retaining wall and settled on a Basis of Design for the deep pile foundations
- Design meetings led to further definition of the wall assemblies, signage and wayfinding, and details of the training district
- Negotiations with the PUC regarding cost sharing for the cleaning and inspection of the box sewer and the sewer prior to the start of construction continued
- A reconciliation of construction cost estimates from the CM/GC Swinerton and two outside cost estimators project the construction costs to be within budgeted amounts

Focused Scope Program (Michael Rossetto, San Francisco Public Works):

Total Funding allocated for the Focused Scope Program is \$21,407,279, approved by SFFD on 8/17/17. Work is complete in 8 of 9 of the Focused Scope categories comprising Roofing, Apparatus Bay Door Replacements, Exterior Envelope Improvements, Windows, Showers, HVAC/Mechanical, Sidewalk/Slabs, and Security Access Control. Work continues to progress through the last scope category, Generator Replacements.

Emergency Generators:

- FS 2 Scope of work: replace existing rooftop generator set, structurally strengthen roof structure to support new fuel tank with capacity for 72-hour run time and provide new fuel fill port and piping to generator.
 This project is complete.
- FS 19 Scope of work: replace existing generator at grade and replace main electrical panel.
 - The generator load bank lead time has increased, causing a generator delivery date into 2026. Deletion of the load bank was considered, which would have eliminated approximately 6 months of delay. SFFD has opted to retain the load bank due to the minimal cost savings that would have been provided.
- FS 14 Scope of work: Redesign of the previous replacement of the existing generator with new rooftop generator, new subgrade fuel fill port at the sidewalk in front of the station, and new fuel piping from sidewalk to generator is underway.
 - BOA is nearing completion of the redesign as of May 2025. Final review meeting will be scheduled with SFFD prior to submitting for permit.

Exterior Envelope:

o **Package 1 (FS 8, 20, 23, 29)** – FS 8, 20, and 29 are complete; On 1/15/21, SFFD requested a hold on FS 23 painting due to other priorities.

o **Package 2 (FS 24, 34)** – This project remains on HOLD initially placed at the request of Capital Planning to provide supplemental funding to the Police TC&FSD project. It is now expected that those funds will be returned to the SFFD for allocation to a priority project, possibly FS24 and/or FS34.

o **FS 17 & 31** Exterior Envelopes were requested as new projects by SFFD in August 2023, both as lower priorities. These were approved by the Capital Planning Committee for use of ESER 2014 interest. A waterproofing consultant is recommended to determine corrective measures and potential costs.

FS35 Security Fence Enhancements, FS17 Boiler Replacement & FS 29 Apparatus Bay Door Replacement were requested as new projects by SFFD in August 2023. These are ranked as the highest priority (most urgent) projects after the Network Modernization project.

Operations:

The office continues to operate at full capacity, handling major events and responding to emergency scene calls.

The PIO team covered the following events with written, radio, social media, and media coverage: Berkeley Way remembrance, EMS state award for a member, 135 H2 graduation, Juneteenth, South Korea FF visit, PGE large drill, EMSA podcast episode, USCG event, and Pride safety and parade.

PIO Curti-Contreras has been instrumental in completing administrative tasks that enhance public safety and the PIO office's efficiency. Some of these tasks include completing the PIO task book, updating the citywide crisis communication shared document, updating the 2025 PIO handbook, establishing the agency profile CSFA document (spotlight) for media use, and responding to media inquiries as needed. She has also made multiple on-camera statements to media outlets.

The PIO team has drafted an SFO response pattern for approval to support airport operations. This was done after gathering information from FEMA, as well as the Orange County Fire PIO, Miami-Dade Fire PIO, and FDNY Fire PIO.

An announcement for Back-up PIO members has been sent to the field, with many members inquiring. This will help cover multiple events.

All PIO cell phones were downloaded to the MMS main computer (this process will be performed monthly), and nearly 10,000 digital images were downloaded.
