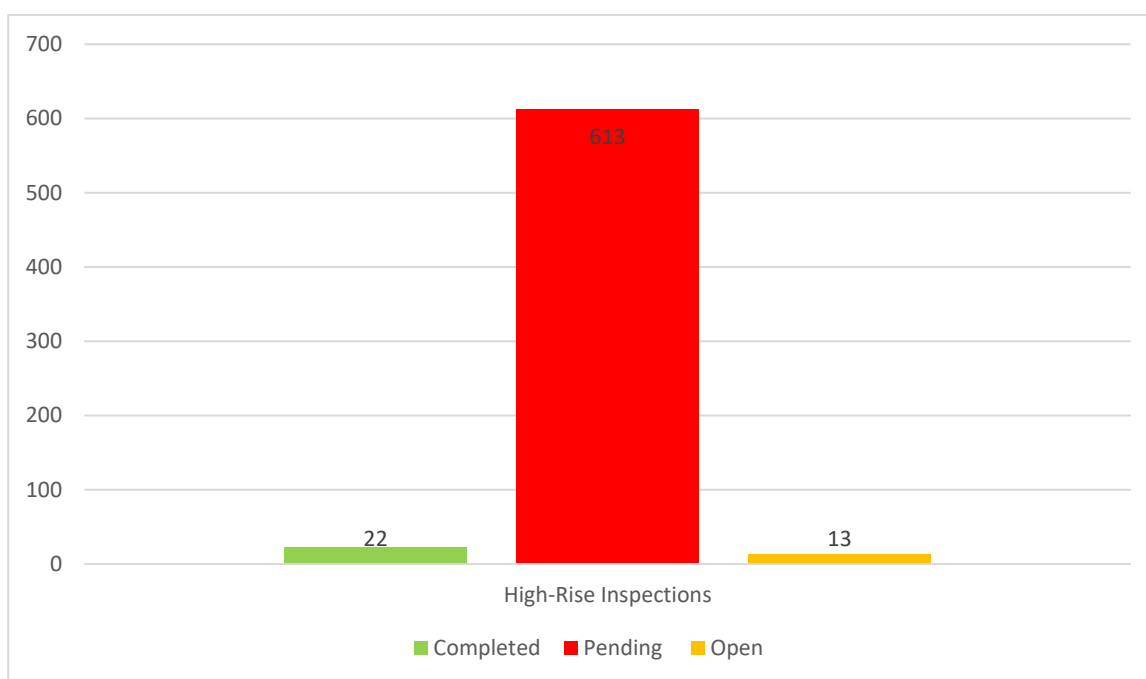

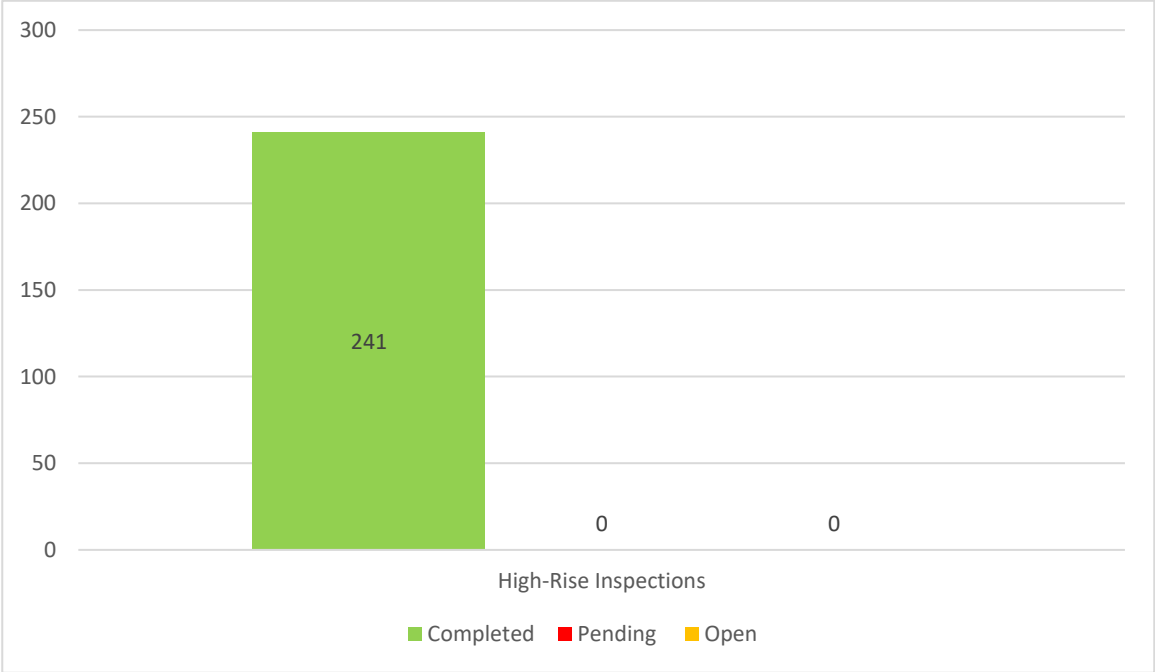

Annual School Inspections 100% Completed for the year 2025

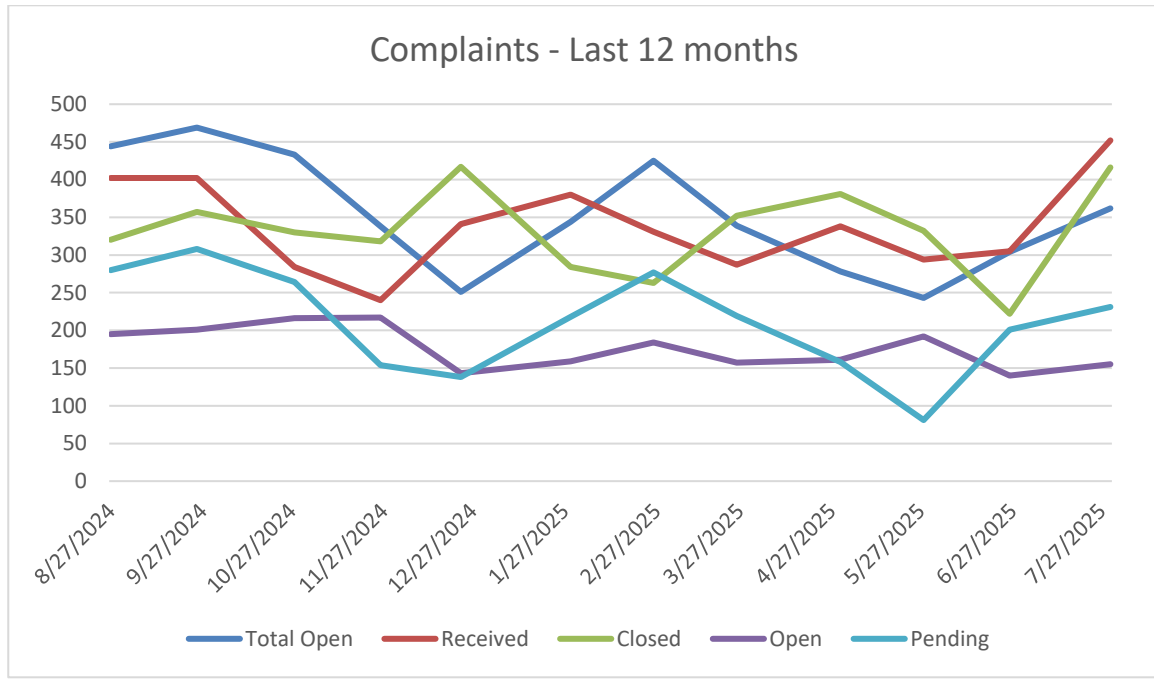

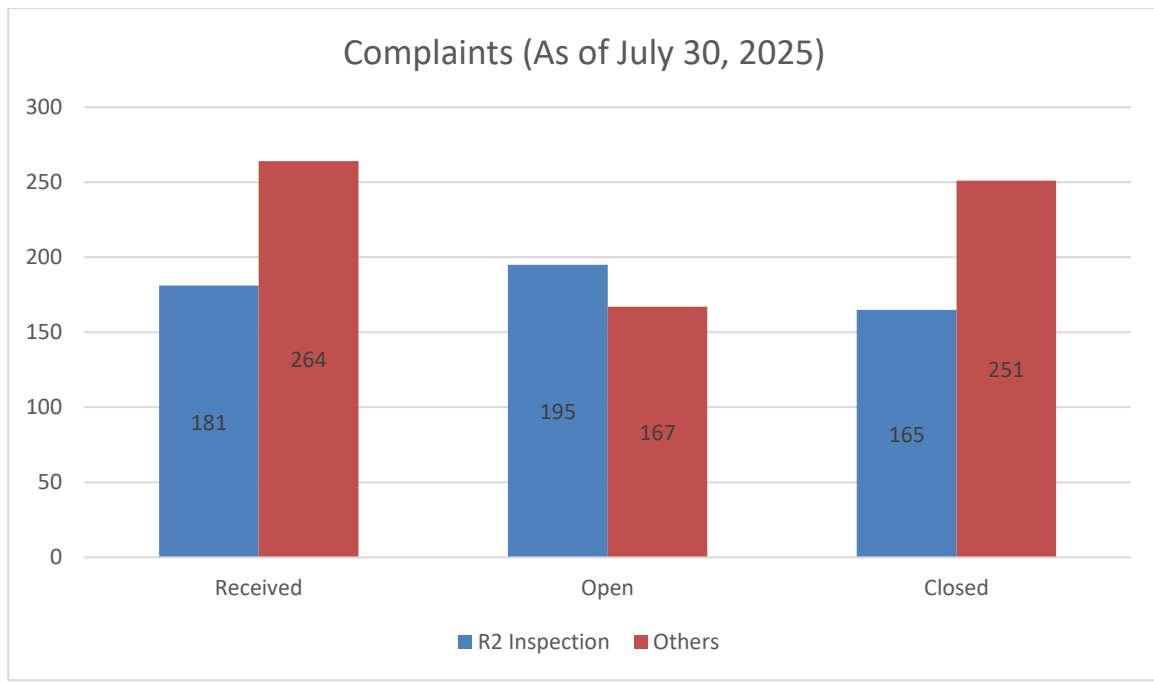

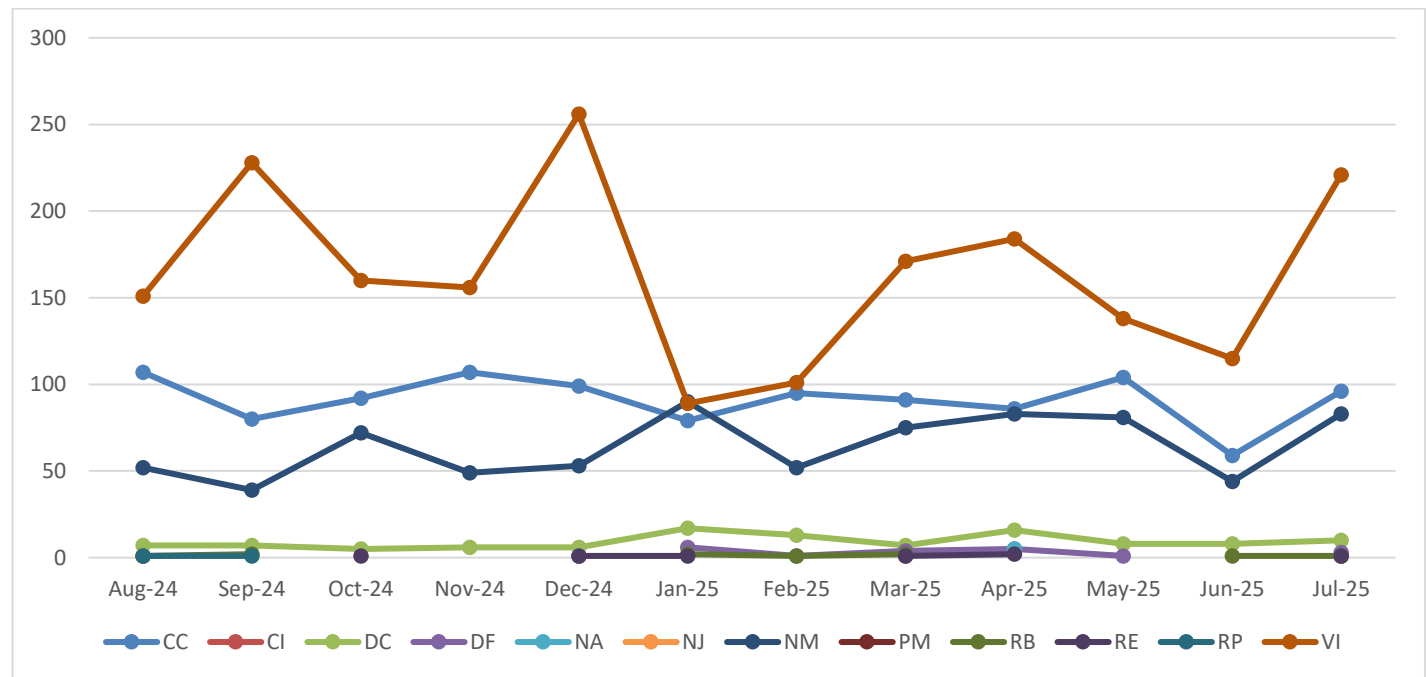

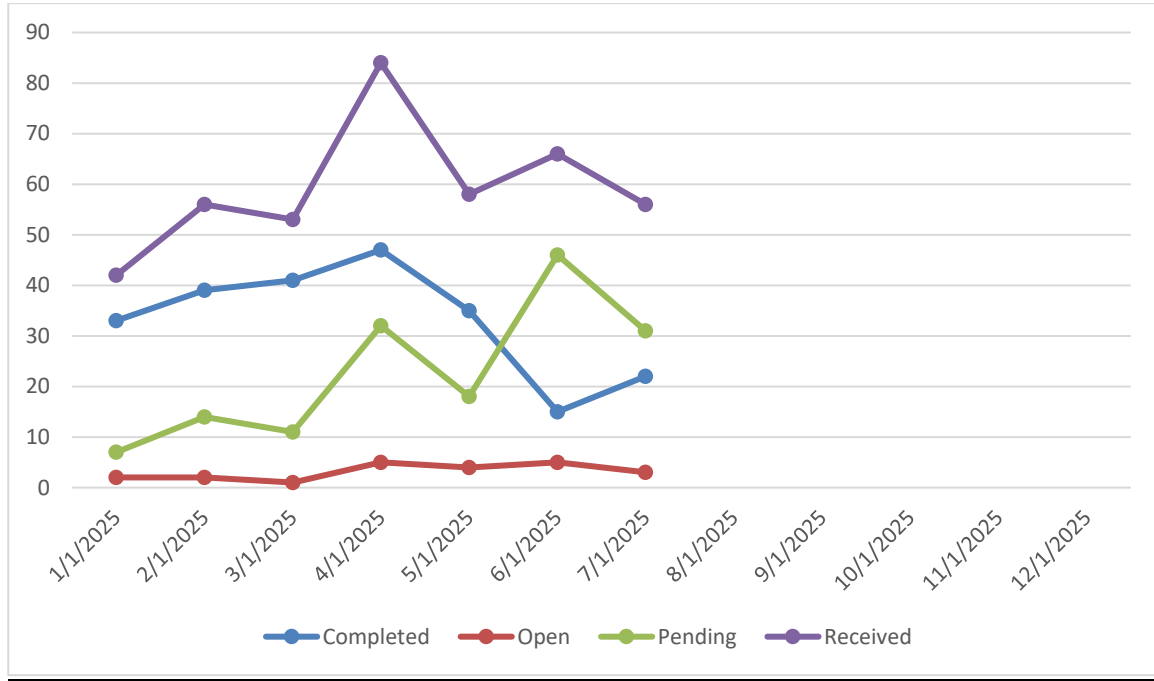

Residential Buildings w/ 9+ units for last 12 months



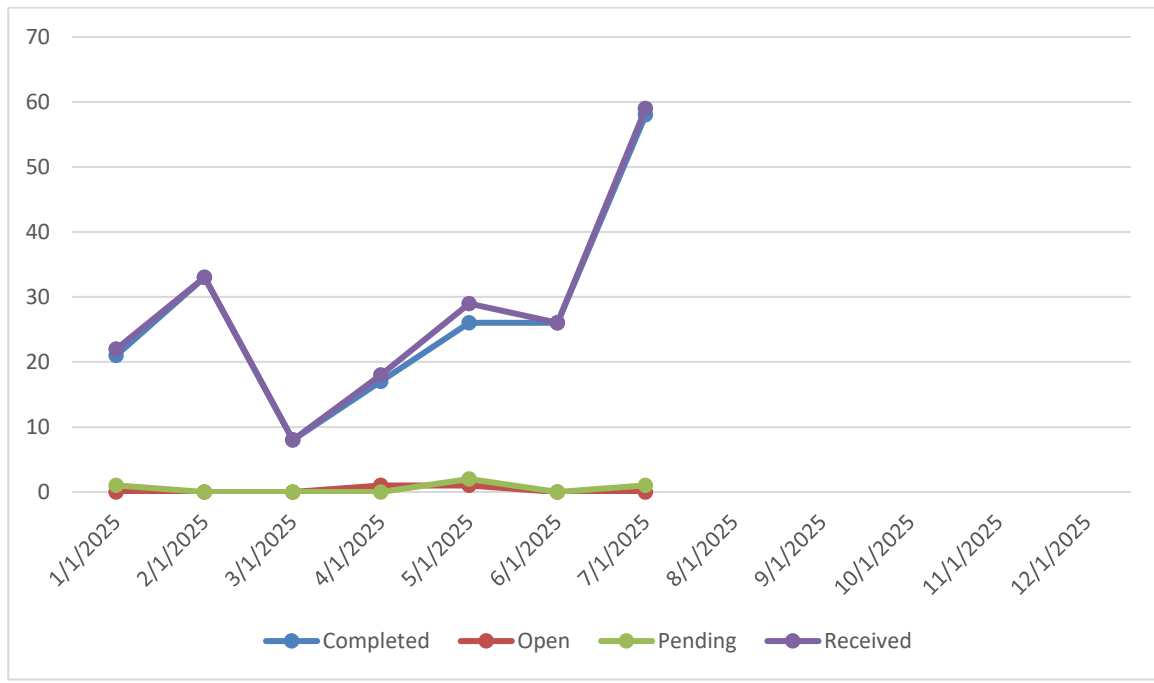

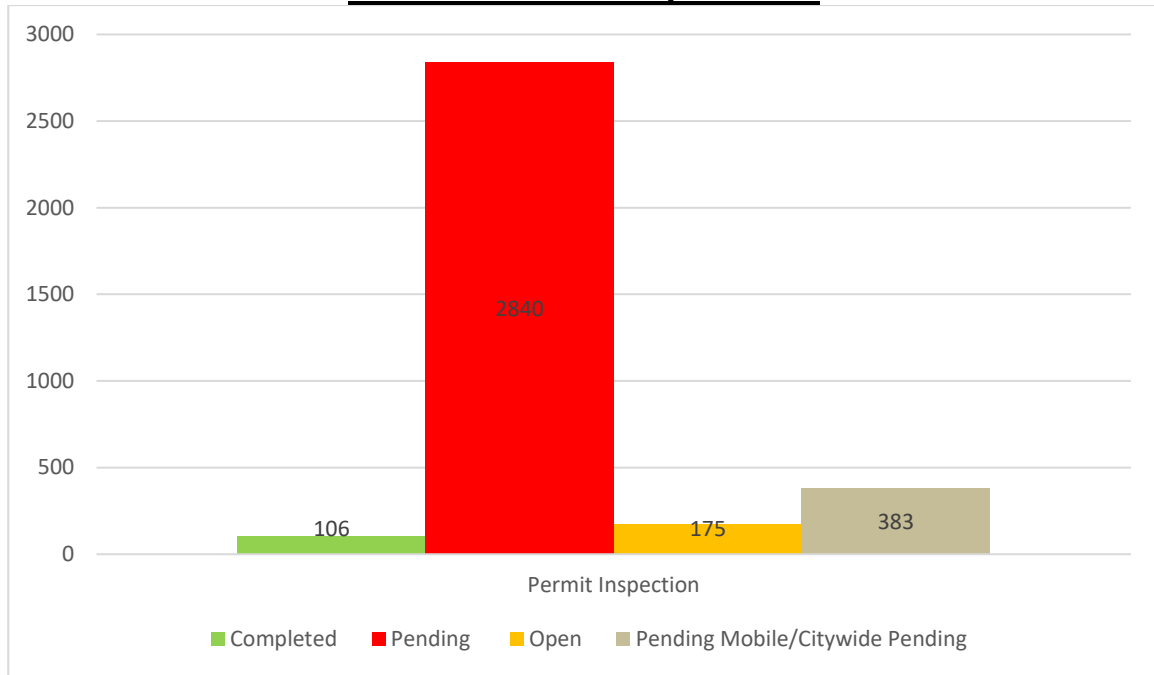

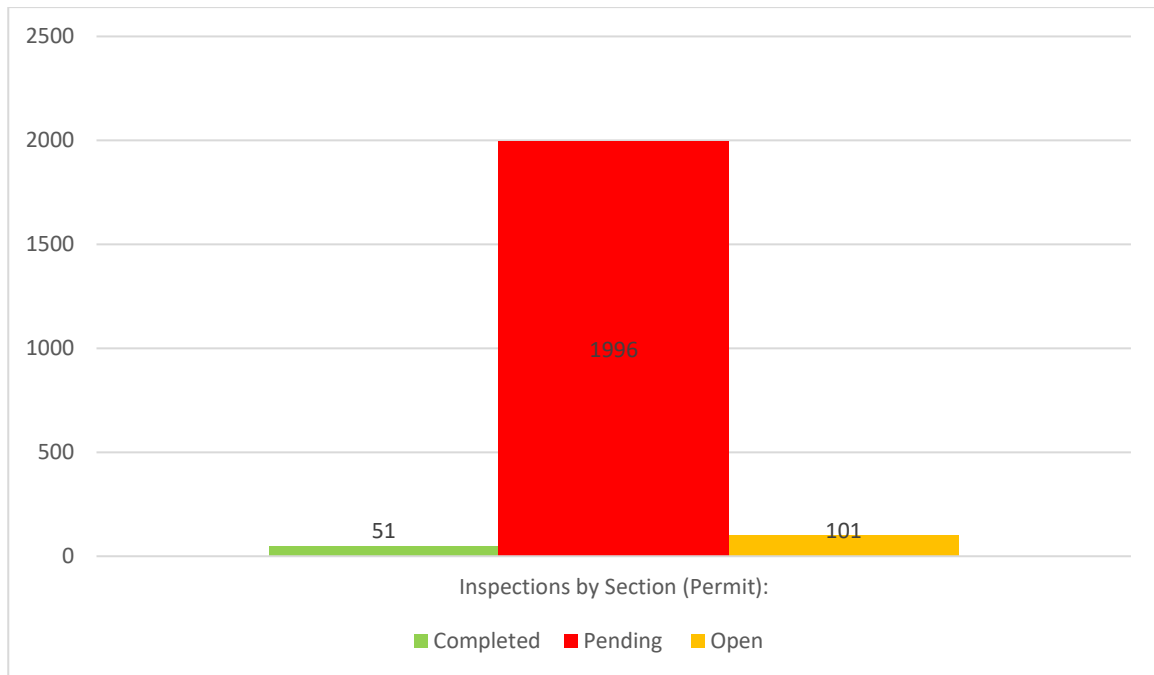

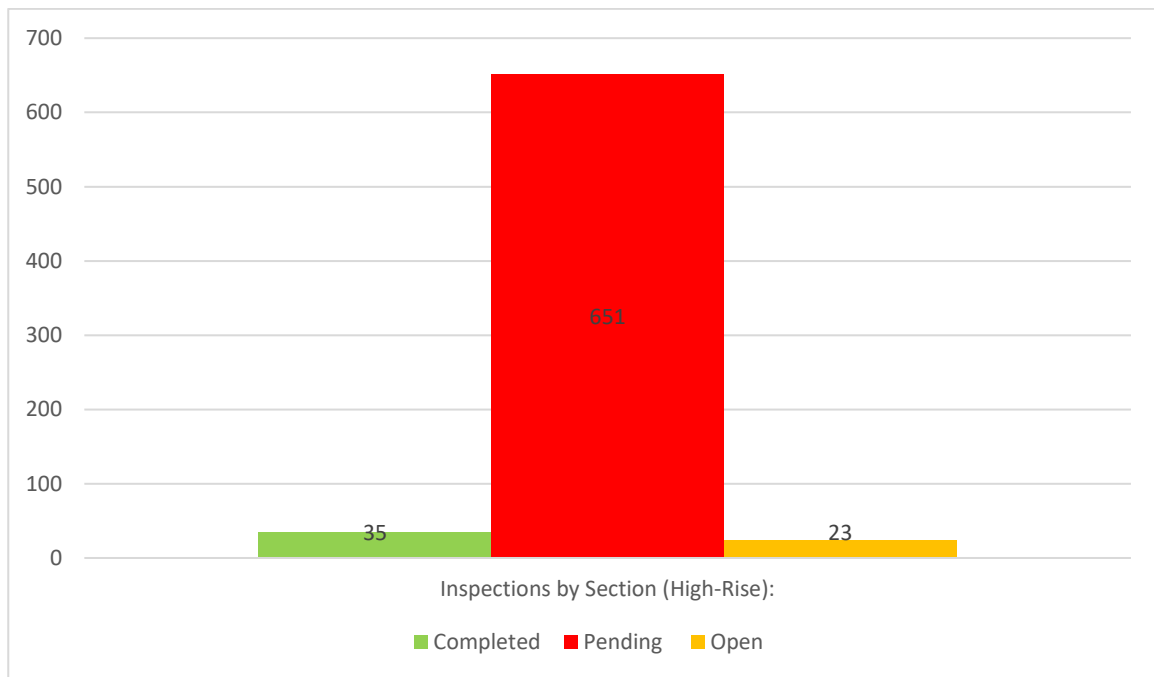

Permit Annual Inspections by Section (Permits Section)



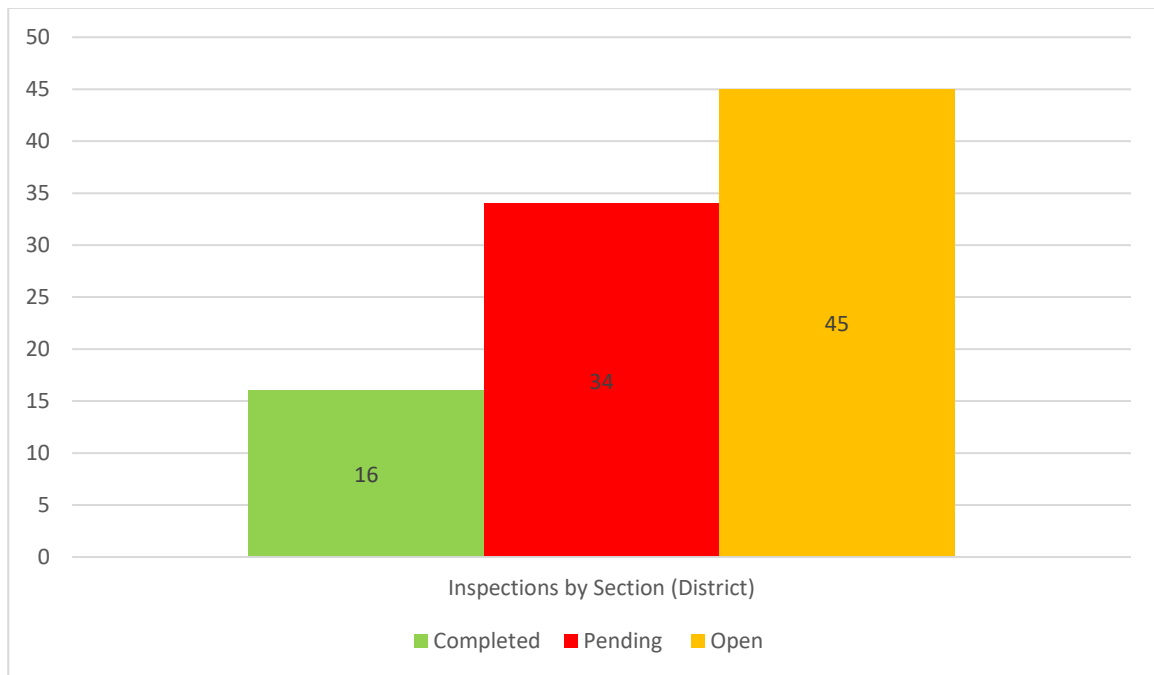

Permit Annual Inspections by Section (High-Rise)



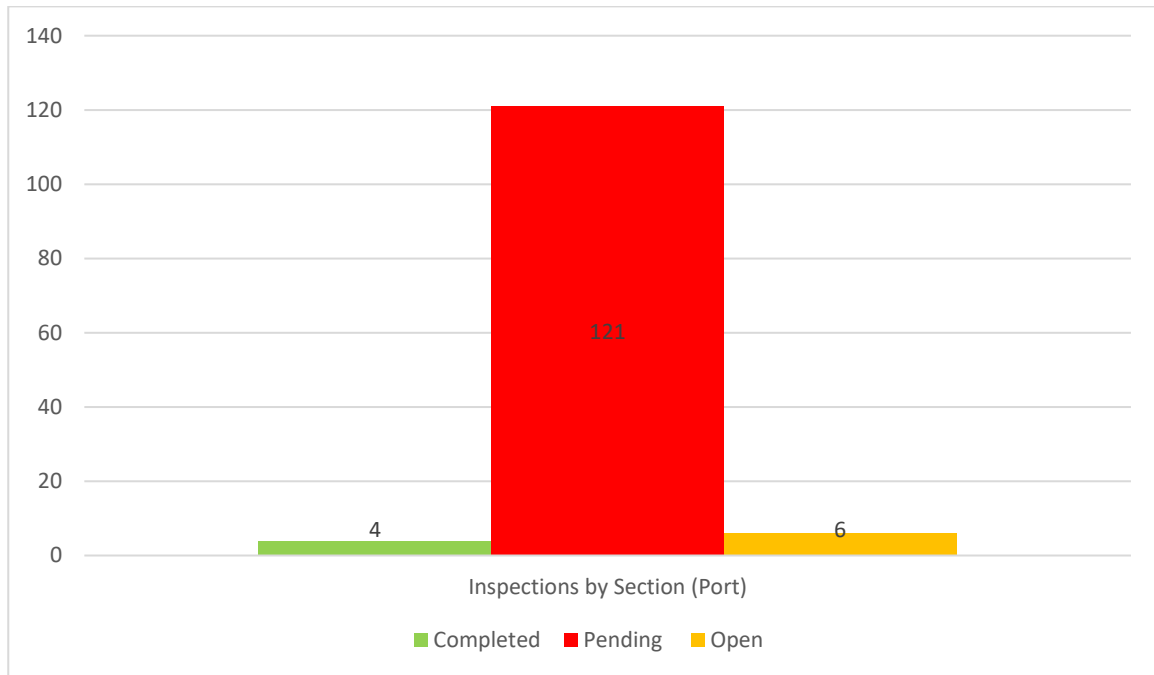

Permit Annual Inspections by Section (Districts Section)



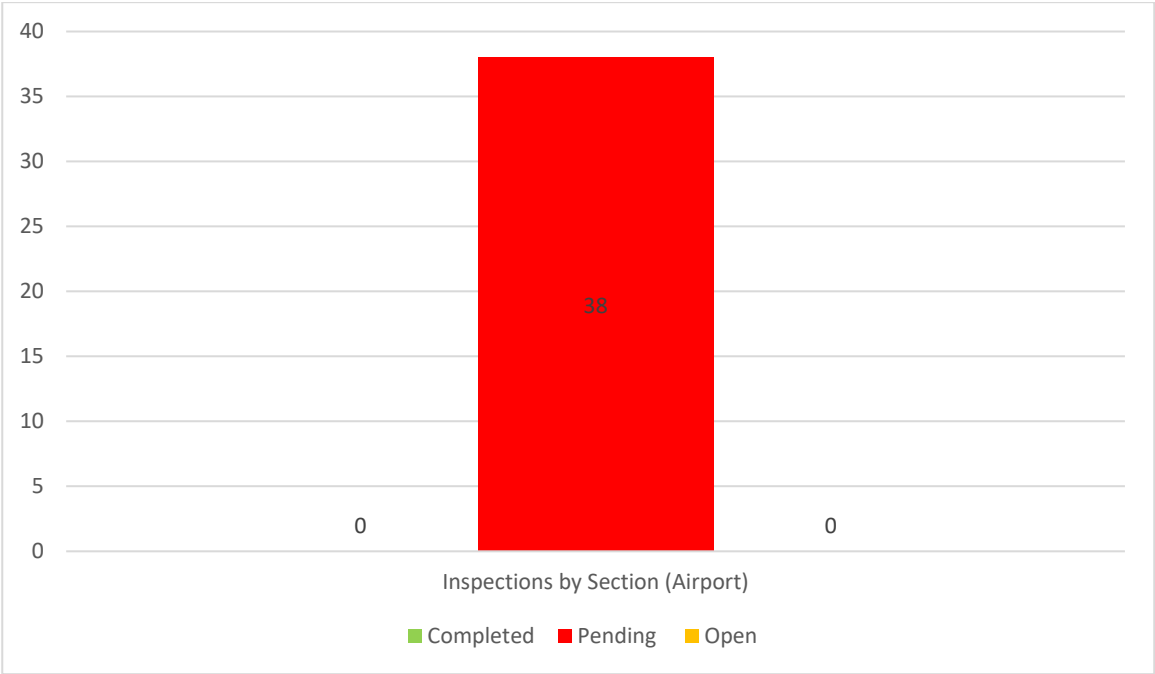

Division Update July 2025

The following lists the activities for the month of July:

- Attended Fire Commission meetings
- Weekly meetings with Division of Training staff
- Weekly meetings with CD2
- 7/7: Met with retired member Brook Mancinelli regarding RRAO classes for our members.
- Met with FF/PM Canning on several occasions for HRT and developing instructors within the SFFD for RTF classes.
- Participated in coordination and instruction for the last 2 sessions of the Driver/Tiller Academy on 7/7-7/9 and 7/23-7/25 for the 133rd class. This concludes the training for this class.
- 7/11: Coordinated a meeting between BC Sean Lowry from Orange County and Spec Ops Training Liaison Jason Harrell. This was to organize a Task Force 5 MOBEX drill at TITF to further prepare the SFFD for a future RTF.
- 7/15: Greeted and addressed Chief Caryn Petty at TITF. She came out to teach RIO and CEET to the recruit staff. This class puts the instructors in compliance with State Fire Training regulations as an accredited academy.
- 7/15: Met with representatives from College of San Mateo and Las Positas College regarding their fire service training programs.
- 7/16: Met with Chief of Staff Sims and CMC Co. to discuss the use of TITF for a rescue competition to be held at TITF to highlight our facility.
- Capt. Buren and I met with representatives from the SF Main Library to tour the Koret Auditorium for use of the faculty for the Reading Smoke Class.
- 7/17: Hosted City College of SF at TITF for a bootcamp to assist students with future SFFD opportunities.
- 7/19: Held the 136th academy orientation at TITF. It was attended by the recruit training staff and myself. Each recruit brought one family member or guest.
- 7/22: Attended a TEAMS meeting with CD3, ADC Mullin, EMS Sec Chief Treff and Anthony Boone to discuss OSHA violations at TITF.
- 7/25: Attended the H3 L1 and L2 recruit graduation.

Activities and Projects:

- Continuing to support B4 to complete open task-book for Station 16 members for Large Vessel Boat Operations. We have been fully operational daily with the completion of task books and engagement from the personnel at Station 16.
- The 136th Academy is underway with the start date of 7/28. The DOT Staff have done an excellent job preparing the instructors and facilities for the new class. The facility at TI has been thoroughly cleaned and unused vehicles and building materials have been removed and discarded. New books were ordered to keep our program current with state guidelines. New

classroom seats were also ordered as the current ones were following apart. These were purchased with the CCSF ISA fund.

- Special Ops continued the drills at the Golden Gate Bridge props at So Marin FD. We have been invited to conduct these drills at the facility if desired. Jason Harrell and Capt. Yee have secured the tower of the Golden Gate Bridge for drills in next coming weeks. This was done by establishing a great relationship with the Golden Gate Bridge Authority.
- The DOT is moving forward with developing a Rope Rescue Awareness and Operations Cadre. We are hosting a class on 8/11 with CJAC funds. This class will also task book our internal instructors so we can continue this class internally free to our members. This class is the gateway to several other certifications that staff our specialty units.
- The DOT is hosting a “Reading Smoke” class at the SF Main Library on 8/25, 8/26, and 8/28. This is the same class offered 3 times by the leading international instructor. This is an excellent class to prepare our members to anticipate the location and intensity of a fire before making entry. This class was paid for with CJAC funds and is free to our members. The venue has the capacity of 217 members per day.
- I am currently in contact with WAYMO to put together a Full Box response at a vacant location on Treasure Island. A WAYMO engineer and representative will be present and will program the WAYMO system to react to the situation to help with future scenarios throughout the city.
- The DOT is hosting a “Dry Decon” class for HazMat response on 8/11. This class is free to our members and was paid for using CJAC funds.
- The DOT will be staffing an open H16 position which will provide video training to utilize our vector solutions application and develop our training website. This position will create CJAC revenue through video training from our apprentice members (<5 years).
- In-Service staff are currently taking training to the field and visiting stations to conduct training. This will continue to happen between large modules and will utilize fire houses and other locations in the city.
- EMS Training has wrapped up recruit training and preparing for the next group. They are continuing to address licensure and continuing education
- Special Operations conducted several drills including Dive Operations, Rope Rescue, and RIC/Firefighter Survival. Jason Harrell and Capt. Tyson Yee have secured spots for our members in Dive Operation Drills in the near future with other agencies free of cost.
- Some of our Rescue Squad members have completed the process to be able to teach “Public Safety Diver” to our membership at zero cost. Registration for these instructors was purchased with CJAC funds and will be coordinated through the DOT.
- The DOT is coordinating a large-scale rescue operations drill with Task Force 5 called MOBEX. This task force is from So. California. We anticipate it to be in early January between academy classes at TITF. This will be an educational experience for our officers and chiefs in which we can be involved. This will also prepare us for the development of a future Rescue Task Force with SFFD. Task Force 5 representatives were very complimentary and excited about the use of our Treasure Island Training Facility.
- The DOT is working with BC Jim O’Connell on an upcoming Truck Academy which will be free to our members. We anticipate this to take place in September.
- The DOT will be hosting state fire marshal fire prevention series that will be taught by Lt. Jason Woo by BFP. These classes will be funded by CJAC. This will provide our members with the foundation for future opportunities within the BFP. These classes will be free to our members.

- The DOT is working on purchasing state fire marshal fire investigation classes with CJAC funds. These classes will be free to our members.
- Completion of registration with the federal excess program is almost complete. It is being wrapped up by the Board of Supervisors and the city attorney. This program will allow us to obtain training materials, industrial vehicles such as forklifts, and other resources free of charge.
- In Service Training is completing the fabrication of a steel forcible entry gate prop for the 2nd floor landing of the Folsom Training tower. This will simulate a tunnel entrance gate to further enhance learning opportunities at our Folsom location. It will have the obstruction of the interior stairwell wall to navigate.

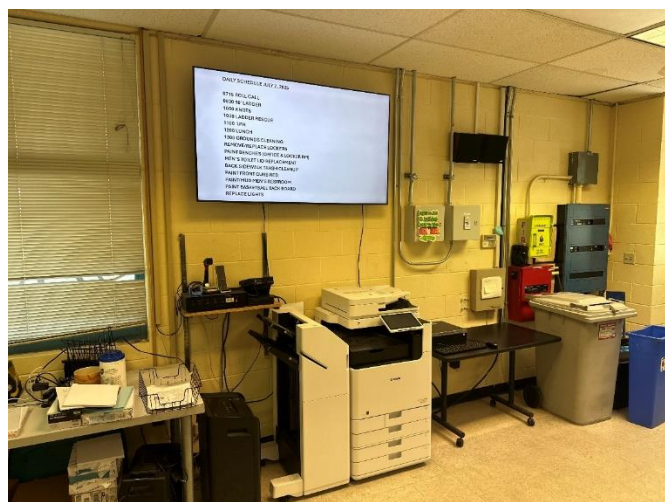
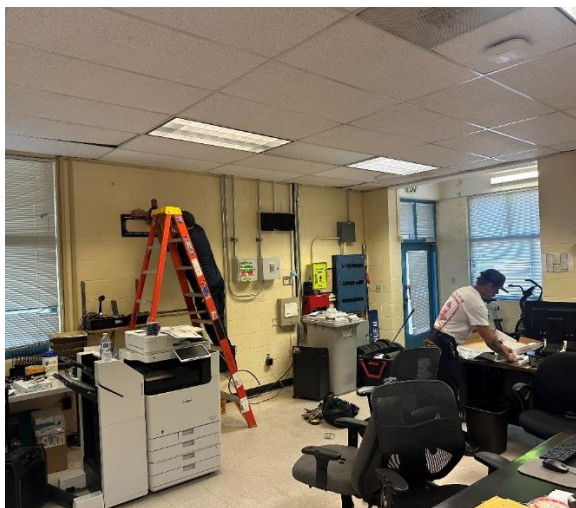

July 2025 Monthly Report

July can only be described as a little bit of everything and all at once. Our drills reviewed topics such as FF Survival, RIC operations, ladder drills, auto extrication, introduction to new equipment (CMC Clutch and Capto), rope rescue over the Golden Gate Bridge Suicide net (prop), and black mask public safety dive evolutions.

July started with training companies in Firefighter Survival and RIT training skills at the DOT. Utilizing the IAFF Rescue Trailer, detailed companies performed SCBA profile changes, victim rescues and carries, critical communication practice (MAYDAY & emergency traffic), and an Emergency Breathing Supply System review. We started with ground school teaching techniques to bailing out to a ladder and/or using a rope to assist with escaping from upper floors. The response from our firefighters in the field have been very positive and the demand for more training is there.

The SFFD has purchased new and updated rope rescue hardware to make rope responses more efficient and hopefully safer. Special Operations did ground school introductory training with CMC Clutch and Capto. All parts of the system were tested and rescue squad members got to lower on belay, change over to a 3/1 haul system, and get hands on experience with our new equipment. Approximately 70% of our rescue squad members have completed this updated training module and are ready to incorporate the new equipment immediately.

Special Operations continues to make contacts and collaborating with outside agencies. On July 16th, we hosted an auto extrication drill at our TITF with representatives from California Highway Patrol, Golden Gate Bridge Authority, the 95th Civil Support Team, FBI, Coast Guard, Southern Marin Fire, and CMC Rope Rescue. Chief Kasper and B02 Hickey were there to meet and exchange contacts for collaborating on a bigger event in future.

The week after continued with 3 special trainings focusing on the Golden Gate Bridge Suicide Nets (prop) at Southern Marin Fire's Station 9 in Mill Valley. SFFD sent E14, T14, B02, B07, and our Rescue Squads to participate in a joint training evolution with Tiburon Fire, SMF Rescue Team, and Golden Gate Bridge Iron Workers. This session allowed each agency show what to expect if dispatch to a jumper call on the GG Bridge and the specialized equipment currently being used. This session was invaluable for development of our SOPs in the future.

The last week of July brought our rescue squads back to dive training at Twin Peaks Reservoir. This drill was specifically a "search, extricate, and recovery" drill. A metal box was fabricated by in-service training specifically for this purpose. The box was set in the middle of the reservoir and both rescue squads work together to locate the "victim" and plan for the recovery of the box. Each side of the box had a puzzle such as a lock to cut, a chain to break free, a victim to extricate, etc. Our rescue divers had to perform tasks using hand tools in murky low visibility water. We also got a chance to practice our search patterns and hard-wired communication gear.

For the month of August, I will be involved with HRT interviews for new members. I am also scheduled to teach (taskbook) RRAO for 12 of our SFFD members the week beginning 8/11. We will begin to incorporate the new CMC Clutch into more advance rope rescue scenarios after we complete a comprehensive ground school for all rescue squad members. I plan to expand CMC Clutch and Capto training to Station 14 and 19 due to their rope operations response areas. We will continue to collaborate rope training with GGBA and SMF on 8/17 and 8/30 for Suicide Net Operations on the Golden Gate Bridge.

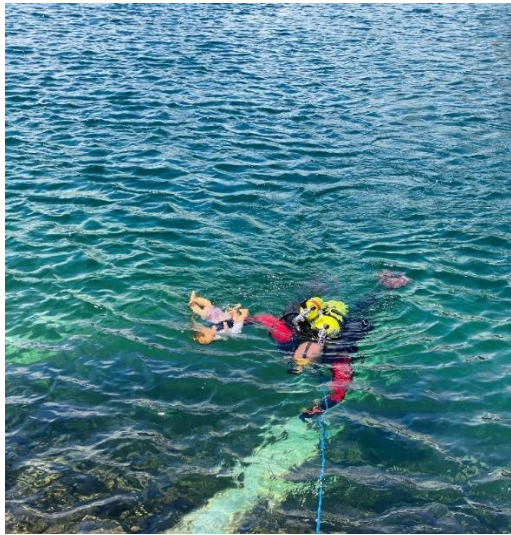

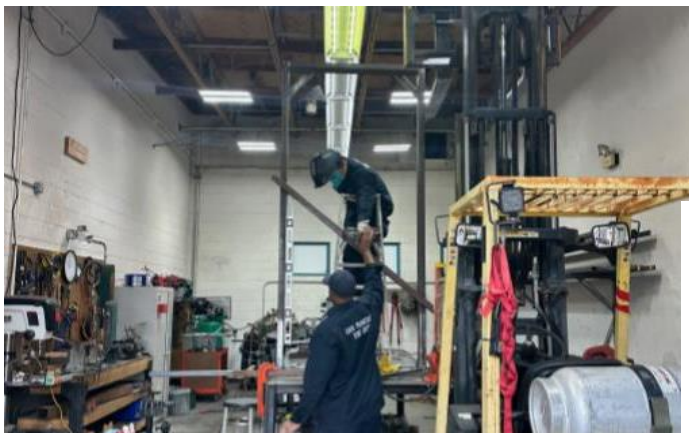
