



Vaccination:

CDC has announced that 1 dose of bivalent booster is good for lifetime, or until >65 years old or immunocompromised.

We do not have good data on Dept booster rate due to confusion and lack of authority to enforce mandate.

N-95 mask rules still apply to medical calls until exiting the hospital.

TB & Hearing

- > 1, 381 employees screened from November 2022 to present
- ➤ Of those screened for TB, 6 were confirmed positive and diagnosed with latent TB. Meaning the members were exposed to TB at some point in time. They do not have active TB, they are NOT contagious.
- ➤ Our office is in the process of procuring hearing testing devices and working with DPH to process TB blood test (Quantiferon) so these services can be offered in house.

- 117 promotional exams
- 146 end of probation exams
