

#### **City-Approved Cancer Screening: Process Update**

  - Clinical performance and accuracy for firefighters
    - Member experience and invasiveness (prioritizing non-invasive options; avoiding endoscopy when possible)
  - Cost and overall value to members and the City
- Evaluating strategies that detect a broad spectrum of cancers at earlier, more treatable stages.
- Modalities under review:
  - Blood-based multi-cancer early detection (MCED) tests
  - Imaging options (e.g., full-body scans where appropriate)
  - Targeted, cancer-specific screening tools aligned to age and risk


#### **August 2025 BHU Journal Highlights:**

- <u>Calls for service continue to increase</u>, illustrating a growing awareness of the BHU team, greater comfort with accessing BHU services (reduced mental health stigma), and a growing demand for first responder support services.
  - o Calls for service in August 2025 increased by <u>290%</u> compared to August 2024 (8/2024: 63; 8/2025: 183).

#### August 2025 Top Stressors:

- o General Stress: referrals to EAP therapy, family therapy, and anger management.
- o Critical Incident Response: pediatric traumas were the most frequent type of critical call.
- o Family/Marital Problems: therapy for family members, couples counseling, separation/divorce, child custody.
- o Alcohol and Substance Abuse: members seeking treatment/recovery support.







# Investigative Services Bureau Captain Colin Carter August 2025

### **Random Alcohol and Drug Testing Program**

- The Random Alcohol and Drug Testing Program was compliant for the month of August. No positive tests recorded. Monthly checks of testing equipment / inventory completed for ISB 1&2, AP, D2, D3, and MD office.
- ISB equipment & supplies at sufficient levels.
- Continued to monitor last chance agreements and testing as outlined in agreements.
- The Fireboat / Engineer testing is under the ISB random testing program and the names are added to the draw pool daily from Datco Services.

## Conditional Offer, Promotional and End-of-Probation Alcohol and Drug Testing Program

• Forty-eight (48) members participated in pre-employment, promotional, and end of probation alcohol and drug testing with the M.D. office. One (1) DOJ LiveScan was also completed.

## **Post Accident Investigations**

• Two (2) post-accident investigations were conducted in August. Three (3) members tested in total (One truck, one ambulance).

#### California Driver Licenses (CDL)

- Cpt Carter continued to monitor all dept. members' driver's licenses via CA DMV Pull Notifications.
- ISB continued driver license audits. Added new employees into DMV system and removed employees no longer employed by SFFD.
- ISB office continued to update all members' licenses and DL546 health questionnaire forms in HRMS. Forty-seven (47) CDLs updated/renewed in August. CD3 memo (25-03) was released 5/21/25 to assist getting all members current with DMV health questionnaires and completing the Firefighter endorsement on their driver licenses. Fifty (50) DL546 forms completed and verified with the DMV between 8/01/25 and 8/31/25.

# **Background Investigations**

• Investigations were completed for the next H3 Academy (28/14) to start in September 2025. 45 candidates sent to ISB for backgrounds. Investigations commenced on 7/30/25 for 43 candidates and finished on 8/8/25 with a presentation to CD1 and CD4. 20 members were selected for the academy.

• ISB continued digitizing records (H3 28/14) of background classes to adequately store personnel records. Continued thanks to FF Youngblood for her assistance in a modified duty position.

#### **Other Business**

- ISB Office welcomed Captain Mike Pendergast to the office in July. Cpt Pendergast updated the entire SFFD HIPAA policy during the month of August. Cpt Pendergast was also a big contributor to the 28/14 background process.
- Cpt Carter attended the Art of Reading Smoke class hosted by the SFFD at the Library on 8/25 and also participated in the Surf Rescue ICS class on 8/26.
- Cpt Carter was selected to serve as a member of the Backup SFFD PIO team and attended the introductory meeting on 8/22/25.

Modifying controls to include timer and on/off switch in or outside the Drying Room. Waiting for a quote from DPW's Steamfitters Shop for two heaters, one exhaust fan and the necessary control work. Quote received from DPW, in for ADC of Support Service's review. ADC of Support Services requested that a quote be provided just for the fan coil replacement. Steamfitters propose to modify the existing estimate and resend mid-July. SO # 2115449 was submitted to SFFD for the Officers Room heater replacement. Waiting on Client approval. Approved by SFFD. A unit heater has been ordered. Status Update: Waiting for unit to arrive.

**FS 29**: SO #2249790 Heating system is down. Noted that the pumps here on this system are frequently replaced. Steamfitters are recommending re-pipe unit similar to FS 12. Waiting on Client approval. SFFD approved scope of work to be performed. The material estimate has been submitted to DPW's Purchasing Department. Status Update: Waiting for SFFD approval to order additional materials as needed. Work has been approved, awaiting labor availability.

FS 37: RADIATORS It was discovered that 17 radiators need new valves to control on/off. Nine units do not work. Waiting for the proposal to change out all valves. The Drying Room Heater needs a 3-way valve and an outdoor air override that needs to be installed. Proposing two men to take nine days, plus \$3500 in parts. The heat is on in the Station and the new program settings are adequate to get through the winter. Work will need to be done when they are permitted to shut boiler down for a few days. Waiting for a formal quote to be sent to ADC Support Services to sign off. Deferred by SFFD, however DPW will be

submitting a new estimate for the boiler work. Status Updates: Estimates for the controls work and radiator valves submitted to SFFD for approval. Work approved, awaiting materials.

**FS 38:** Drying Room pump has failed. A new drying room pump has been ordered for replacement. Status Update: Job Completed.

# Focused Scope Program (Michael Rossetto, San Francisco Public Works):

Total Funding allocated for the Focused Scope Program is \$21,407,279, approved by SFFD on 8/17/17. Work is complete in 8 of 9 of the Focused Scope categories comprising Roofing, Apparatus Bay Door Replacements, Exterior Envelope Improvements, Windows, Showers, HVAC/Mechanical, Sidewalk/Slabs, and Security Access Control. Work continues to progress through the last scope category, Generator Replacements.

#### **Emergency Generators:**

- FS 2 Scope of work: replace existing rooftop generator set, structurally strengthen roof structure to support new fuel tank with capacity for 72-hour run time and provide new fuel fill port and piping to generator.
   This project is complete.
- o FS 19 Scope of work: replace existing generator at grade and replace main electrical panel.
  - The generator load bank lead time has increased, causing a generator delivery date into 2026. Deletion of the load bank was considered, which would have eliminated approximately 6 months of delay. SFFD has opted to retain the load bank due to the minimal cost savings that would have been provided. The Load bank lead time pushed the anticipated generator ship date to from November 2025 to May 2026.
- o FS 14 − Scope of work: Redesign of the previous replacement of the existing generator with new rooftop generator, new subgrade fuel fill port at the sidewalk in front of the station, and new fuel piping from sidewalk to generator is underway.
  - BOA has submitted AB-005 for delivering the fuel via hose or hand-carried containers to the rear yard to SFFD Fire Prevention. Pending SFFD approval, the project will be submitted to DBI for permit.

### **Exterior Envelope:**

- o **Package 1 (FS 8, 20, 23, 29)** FS 8, 20, and 29 are complete; On 1/15/21, SFFD requested a hold on FS 23 painting due to other priorities.
- o **Package 2 (FS 24, 34)** This project remains on HOLD initially placed at the request of Capital Planning to provide supplemental funding to the Police TC&FSD project. It is now expected that those funds will be returned to the SFFD for allocation to a priority project, possibly FS24 and/or FS34.

#### **Operations**

The office remains fully operational, handling major events and emergency calls. The office covered the following events with written, radio, social media, and media coverage: 136 H2 Academy start, Truck 1 AFN post, Outside Lands, Luke Bryant, Grateful Dead, Stern Grove concert series. We encourage you to view our social accounts for an overview of our work.

The office continues engaging with external agencies and the public, such as attending community meetings. We have been added to the SFPD district captain's community meetings to have full community engagement. Community meetings help keep our office informed about events, perceptions, and issues.

The new relief PIOs have been selected. Command staff hosted a virtual welcoming meeting with expectations clearly outlined. OIC Baxter went over in a post meeting training expectations, team goals, expectations, and projects for the new relief officers to start working on.





The office completed numerous long-term tasks this month, including the 2026-2028 strategic plan, the PIO trainee task book, the SFO PIO response plan, the vehicle replacement plan, updates to the city's crisis communications plan, a PIO recall plan, and additional initiatives.

The office has submitted a Mission and Vision statement, both of which are included in the 2026-2028 Strategic Plan.

Due to civil unrest, First Amendment activities, and planned major events, the city has activated the Joint Information Center at Level 4, with the option to move to Level 3 as needed. This has led the office to shift its focus to cover JIC positions in addition to its regular duties. We can adapt thanks to a revised roster and ongoing collaborative training with our city partners.

The office has developed a monthly checklist and charging list for all our digital equipment to ensure it is ready for our community and department if needed. Currently, each member is responsible for handling this task. The document will provide a more structured approach to this process.

MMS-O has officially moved into FS04 and has been a great partner to start a working relationship with. They have already been able to assist with field media capture on a 1-alarm and 2-alarm with whom to start a working relationship fires. Teams' channel is running great and has been helping all members of the Department and allied agencies.

#### **Training and Education**

Members of the PIO team continue to pursue training opportunities to advance our ability to serve our community. All members receive regular webinars, articles, or digital content related to our job. This helps with ongoing education and improves situational awareness of current events and PIO tactics.

CAL-OES Specialists: Why does SFFD need this credential for information officers? The consequences of failure are high. The stakes of the job also contribute to its difficulty. Emergency specialists are tasked with safeguarding lives, property, and the environment





during disasters, meaning there is little room for error. This adds a significant layer of responsibility and pressure to an already challenging role The Cal OES Specialist Program is important because it formally recognizes and enhances the skills of emergency management professionals in specialized areas like public information and emergency management, leading to more effective, coordinated, and inclusive responses to disasters in California.

The current information officers which are OES specialist: Baxter, Menchaca, Schorr, and Elias.

Officer in charge Baxter held several virtual meetings with PIO leads from around the nation to improve our knowledge and skills, ensuring we provide the right information to the right people at the right time. This information is shared with members during shift change and has helped us complete the strategic plan, especially the SFO PIO plan.



This month, members took part in numerous drills and an off-site class focused on Media Relations. All PIO members also completed weekly drills and target solutions. Below is a synopsis of the training the office completed:

Starlink has been ordered for the PIO office which we had recommended. Thank you, Chief Brannan. Captain Jack Ayers recently utilized his own Starlink during a wildfire deployment, and

according to him, it was invaluable to the mission's success. Communication is a significant issue, and it is also instrumental in ensuring safety, as seen with internet outages, with the most recent Southern California fires.

The iPhone 16 upgrade has resulted in improved picture quality and fewer dropped calls. On 08/30 Verizon had a large cellular outage, the back up sim kept it in service without any issue. The office outfitted the phone with screen protectors and a case. Faster upload and sharing speeds have helped with daily operations.

The PA system is currently being tried for use and service and will be ready for the 9/11 post event at FS04.


