





















Permit Annual Inspections by Section (Permits Section)





Permit Annual Inspections by Section (High-Rise)





Permit Annual Inspections by Section (Districts Section)





Current upcoming classes are Public Safety Diver, Rope Rescue Awareness and Operations, Fire Inspector 1A, 1B, 1C, and 1D, and the Truck Academy. These classes are for SFFD members only and are free of charge to the members. I am pleased to say they are all "FULL" with several on standby if a spot opens up.
- In-Service staff are currently taking training to the field and visiting stations to conduct training. This will continue to happen between large modules and will utilize fire houses and other locations in the city.
- In Service Training has had multiple live burns. The props have been re-imagined making it more realistic with bedrooms, kitchen, closets, furniture, cabinets, and hoarder conditions. Wet hay has been used to produce smokey conditions, but the fire is kept small for safety. We are very aware of using organic materials for our members' safety. This, along with safety lines, escape doors and training staff monitoring with TIC's, make a very realistic and safe training evolution.
- NERT is preparing for a City-Wide Drill in October and is exploring use of our Hose Tenders and Fireboat to create water supply scenarios.
- We are close to completion of a new Performance Improvement Plan to be implemented into the MEP manual.
- The DOT will host Fire Investigation classes in the coming months. It will be taught by retired member Steve Engler who has a tremendous amount of experience and is passionate about our department and investigations.
- The DOT is working on a Virtual Command and Control exercise for our Chief Officers which will consist of radio traffic, a fire scenario, and assigning companies. Additionally, it will have a Tablet Command component for tracking companies. BC Cannon is assisting with IPAD and Tablet Command.
- I am assisting Chief of Staff Sims with Media Training for Chief Officers which will be conducted on 11/15 by an outside vendor. It will be held at St Francis Yacht club in which Adrienne secured free of charge and will provide a beautiful venue. This will be CJAC funded.
- Completion on registration with the Federal Excess Program is almost complete. It is being wrapped up by the Board of Supervisors and the City Attorney. This program will allow us to obtain training materials, industrial vehicles such as forklifts, and other resources free of charge.
- In Service staff are fabricating simulated power lines for the Folsom tower that can be moved and adjusted as needed. These will be used for alternate ladder raises.

- The CCSF intern program has started, and we have volunteers at several stations throughout the city. There are also interns at DOT to learn as well. The interns at DOT do not have their EMT certifications yet so they cannot work in the field.
- I am working with the Training Committee on a Training Bulletin to update our suggested pump pressure as the efficiency of pumps and hoses has increased since our standards were written. Several tests with flow meters have been conducted to obtain this information.





Special Operations Training, Tyson Yee, Captain

September 2025 Monthly Report

September was another busy month for special operations. I believe we had contact will all specialized sections involved with technical/specialized training. There was an EV auto fire blanket demonstration, forcible entry training with outside organizations, a downed plane in the water scenario with SFO (FB3), Hazmat planning with B02, heavy lifting operations with Stations 1 & 7, and rope rescue planning with Chase Center and Sutro Towers.

Special Operations continues to make contacts and collaborating with outside agencies. FF Jason Harrell (retired) has been instrumental for fostering and re-vitalizing collaborative relationships with Bay Area agencies. We continue to meet and train collaboratively with the California Highway Patrol, Golden Gate Bridge Authority, and Southern Marin Fire. This month we were able to drill with Oakland Police Department's Tactical Unit as well as visit San Francisco's Police Department's Dive Team on Hyde Street Pier.

Sunday September 7th was the last Golden Gate Bridge Suicide Net training scheduled for this year. The first 2 drills were very productive and helpful in forming our SOPs. Engine 14, Truck 14, Rescue 1 and B07 were able to conduct suicide net rescue training on the actual Northern span of the Golden Gate Bridge. SFFD crews worked alongside GGB Iron workers and Southern Marin Fire Rescue to rescue victims (training dummies) in the suicide nets. This is the first time in recent memory (10 plus years plus) of being able to train on the bridge and the first time since the suicide nets were erected. We will continue to train and plan for mid-span rescue drills in the early months of 2026.

We continue to incorporate the new equipment (CMC Clutch, Capto, and Petzl ID) into more advanced rope rescue scenarios. On 9/11, RS1 and RS2 demonstrated the capabilities of the new rope rescue gear to ADC Cercos and BC McKinney. Both were impressed and have authorized the gear be given to both Rescue Squads to drill and increase proficiency. I will schedule 2 test scenarios for both companies to complete next month.

I have completed CMC Clutch and Capto ground school training with 90% of the members of Stations 14 and 19. Due to their rope operations response areas, it makes sense to streamline rescue operations with more efficient gear as we have done with the Rescue Squads. It is my hope to continue to update the rope equipment at Stations 14 and 19 as soon as next month.

There was a request to assist with stokes basket victim packaging and aerial ladder rescue by BC Kircher and BC Hoo for Truck 15 and Truck 19. This is in preparation for the BART rescue drill from elevated tracks scheduled for the first weekend of October. I contacted both A/Captain Leonardo and Captain Sankey and have gone out to the stations twice for practice runs. I believe they will be ready.

Lastly, we have on-boarded FF/PN Steve Marcot (retired) as an additional resource for both the NERT program and special operations. He will be mainly focused on the needs of B02 and the Hazmat unit. Special Operations will continue to be a resource for companies and chiefs in the field and help with all training where there is a need.


