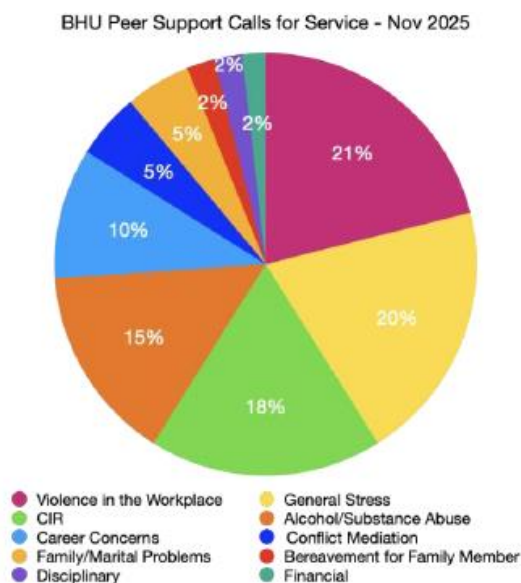

NOVEMBER 2025 BHU Calls for Service Highlights:

Calls for service continue to increase, illustrating a growing awareness of the BHU team, greater comfort with accessing BHU services (reduced mental health stigma), and a growing demand for first responder support services. Calls for service in November 2025: 280 compared to November 2024: 153. This is an 83% increase in calls for support and behavioral health resources provided.

- November 2025 Top Reported Stressors: Violence in the Workplace: Reports of assaults against EMS and CP members on the rise; members affected are also engaging with support resources more frequently.
- General Stress: referrals to EAP therapy, time management, emotional regulation.
- Critical Incident Response: pediatric traumas, suicide, and homicide were the most frequent type of critical call response.
- Alcohol and Substance Use: members seeking treatment/recovery support.
- Career Concerns: leave due to workplace injuries, interpersonal concerns at station, cumulative stress, burnout, moral injury.
- Family/Marital Problems: therapy for children, couples counseling, separation/divorce, child custody.

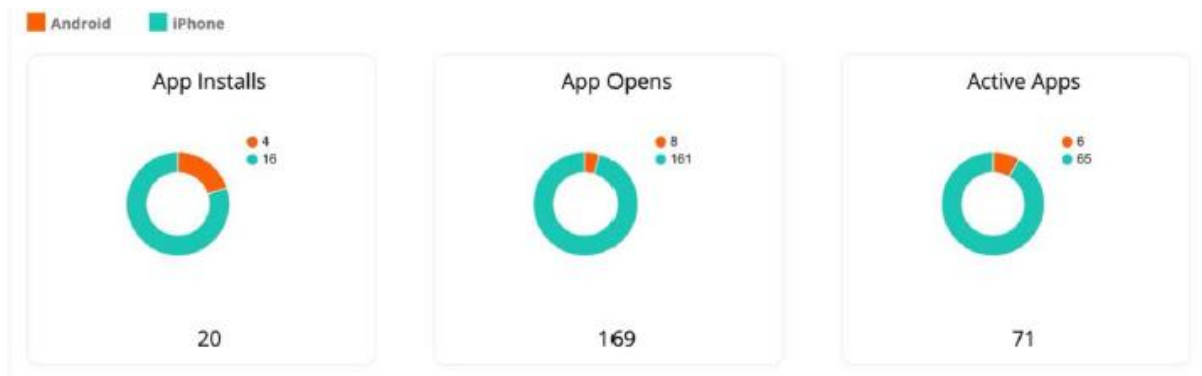

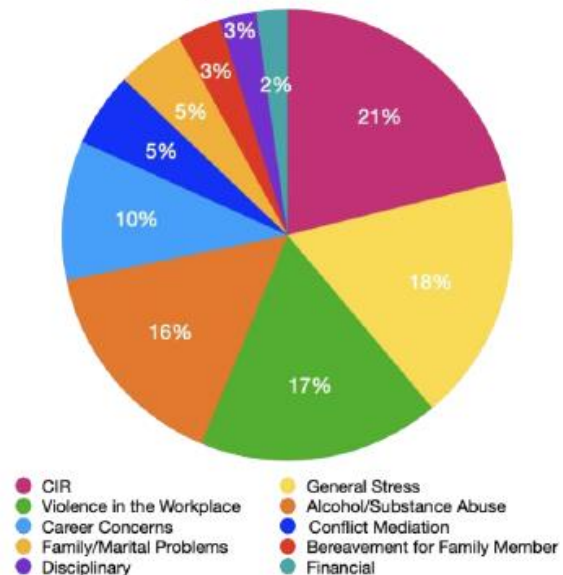

Calls for service continue to increase, illustrating a growing awareness of the BHU team, greater comfort with accessing BHU services (reduced mental health stigma), and a growing demand for first responder support services. Calls for service in DECEMBER 2025: 450 compared to DECEMBER 2024: 137. **This is a 228% increase in calls for support and behavioral health resources provided in 2025 vs 2024.**

DECEMBER 2025 Top Reported Stressors:

Critical Incident Response: multiple pediatric traumas and fatalities with significant public and media attention.

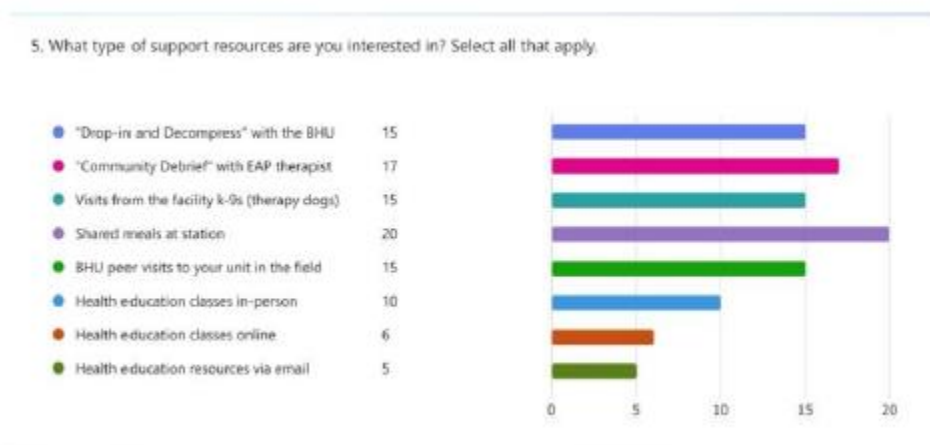
General Stress: referrals to EAP therapy, support with time management, emotional regulation, coping skills.

Members would like to have both separate groups and a shared CP/49 option.
In addition to groups, shared meals, therapy dog visits, and BHU field visits are preferred support resources.

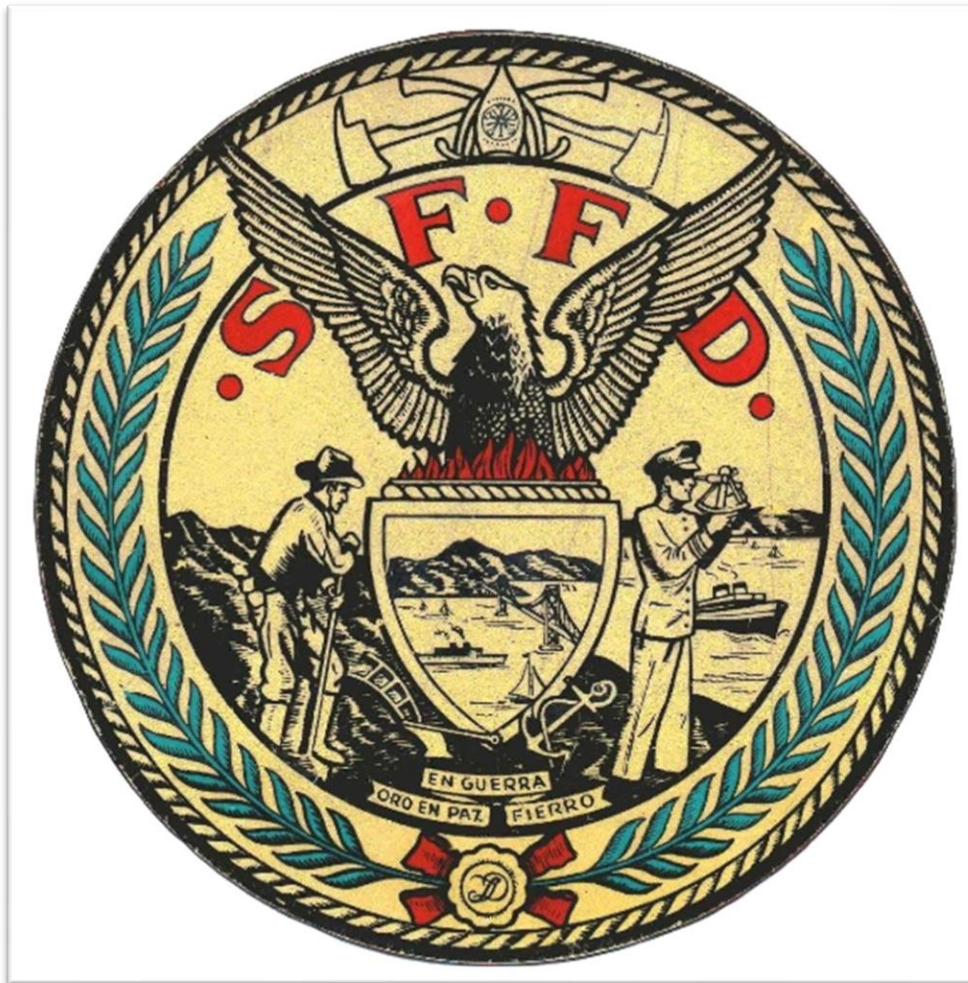

Random Alcohol and Drug Testing Program

- The Random Alcohol and Drug Testing Program was compliant for the months of November & December. No positive tests were recorded. Monthly checks of testing equipment & inventory completed for ISB 1&2, AP, D2, D3, and MD office.
- ISB equipment & supplies at sufficient levels. Ordered and received 1,000 breathalyzer mouthpieces and 400 Oral test kits for both ISB and MD office.
- Continued to monitor last chance agreements and testing as outlined in agreements. All in compliance.
- The Fireboat / Engineer testing is under the ISB random testing program, and the names are added to the draw pool daily from Datco Services.

Conditional Offer, Promotional and End-of-Probation Alcohol and Drug Testing Program

- Ninety-eight (98) members participated in pre-employment, promotional, and end of probation alcohol and drug testing with the M.D. office. Eleven (11) DOJ LiveScan were also completed (for the EMS recertification division).

Post Accident Investigations

- Four (4) post-accident investigations were conducted in November & December. Eight members tested (four truck accidents).

California Driver Licenses (CDL)

- Cpt Carter continued to monitor all dept. members' driver licenses via CA DMV Pull Notifications.
- ISB continued driver license audits. Added new employees into DMV system and removed employees no longer employed by SFFD.
- ISB office continued to update all members' licenses and DMV DL546 health questionnaire forms in HRMS. Eighty-four (84) CDLs updated/renewed in November & December. CD3 memo (25-03) was released 5/21/25 to assist getting all members current with DMV health questionnaires and completing the Firefighter endorsement on their driver licenses. One-hundred-four (104) DL546 forms completed and verified with the DMV between 11/01/25 and 12/31/25.

Background Investigations

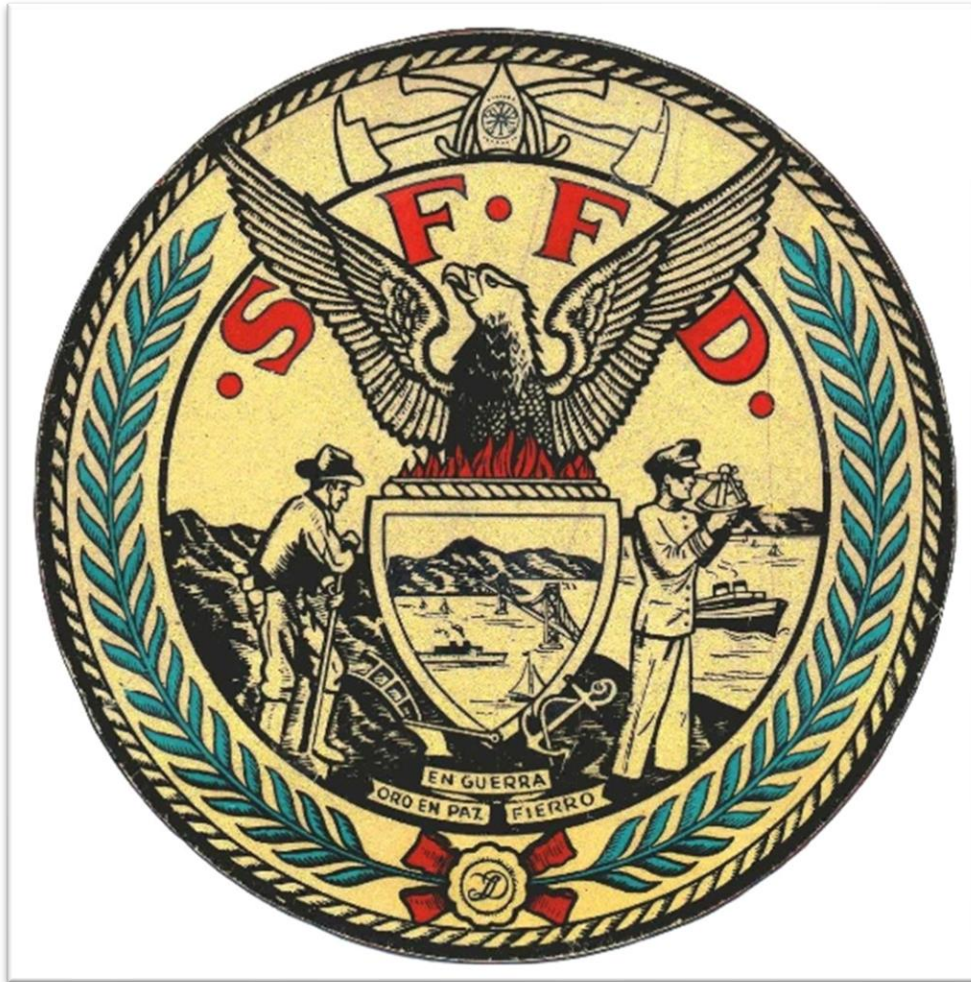
- ISB began and completed the next H2 academy (137th) background process (for academy start date 1/26/2026). DMV records and Investigative reports were acquired by ISB on these candidates, as well as in-depth investigations. Fifty-Four H2 candidates completed backgrounds.

- ISB began the background process for the next H3 L1 & L2 class (class 29/15). Thirty-six candidates were sent to ISB for investigations, to be completed January 2026.
- ISB continued digitizing records of completed background classes to adequately store personnel records in a safe place.

Other Business

- Cpt Carter attended MGT-461 Evacuation Planning, Access Granted, and G-191 ICS/EOC training during November & December.
- Cpt Pendergast continued to develop a HIPAA policy for the SFFD.

FACILITY MAINTENANCE & PLANNING

- A total of 244 requests for service were initiated, and 220 service orders were completed and closed out in November and December 2026.

PLUMBING

- 53 service calls were placed to resolve minor plumbing issues (faucet, toilet, urinal repairs; clogged sinks, shower drains) in the months of November and December. Fifteen sewage backups were reported and resolved during this month (FS 10,11,14,18, 24, 25, 26, 33, 38,43). Fourteen of those fifteen sewage backups were handled in-house by our Department plumber Vic Dollosso.

HVAC/HEATING/BOILER

FS15: Boiler replacement approved due to boiler failure. Work has begun and is expected to be completed in mid-November. Portable heaters delivered to Station in the interim. **Work Complete**

FS 17: Boiler replacement estimate is being revised by DPW Steamfitters for consideration. Status Update: Estimate was submitted to SFFD in March. SO# 2484755. ESER funds have been approved, and job is in planning stage. **Work has commenced**

FS 19: ROOF REPLACEMENT: Job walk has been conducted. Waiting on estimate from DPW. Work should commence late spring/early summer 2026.

FS 35 (Old): ROOF REFURBISHMENT: New elastomeric coating to be applied due to several leaks. Job walk conducted. Work to begin in January 2026.

FS 37: RADIATORS It was discovered that 17 radiators need new valves to control on/off. Nine units do not work. Waiting for the proposal to change out all valves. The Drying Room Heater needs a 3-way valve and an outdoor air override that needs to be installed. Proposing two men to take nine days, plus \$3500 in parts. The heat is on in the Station and the new program settings are adequate to get through the winter. Work will need to be done when they are permitted to shut boiler down for a few days. Waiting for a formal quote to be sent to ADC Support Services to sign off. Deferred by SFFD, however DPW will be submitting a new estimate for the boiler work. Status Updates: Estimates for the controls work and radiator valves submitted to SFFD for approval. Work approved, awaiting materials.

ROOFING

FS 9: Roof replacement NTP 8/11/25. *Work is in progress. 90% complete. Punch-list items still being worked on.*

CEMENT/ASPHALT

FS15: SIDEWALK REPAIR: Sidewalk in front of apparatus doors to be repaired due to extensive cracking and uneven concrete. Estimate received and work approved. **Work to commence in January 2026.**

FS42: SIDEWALK REPAIR: Sidewalk in front of apparatus doors to be repaired due to extensive cracking and uneven concrete. Estimate received and approved. **Work to commence in January 2026.**

EXHAUST EXTRACTORS

For November/December 2026, there were eleven stations that reported issues with their equipment. FS's 2 (E&T bays), 5, 14, 17, 22, 28, 40, 41, 48, and 51. Nine have been repaired. Two received temporary repairs and are awaiting materials.

GLASS/WINDOWS/SCREENS

No major glass/window/screens issues were reported.

No major electrical issues were reported.

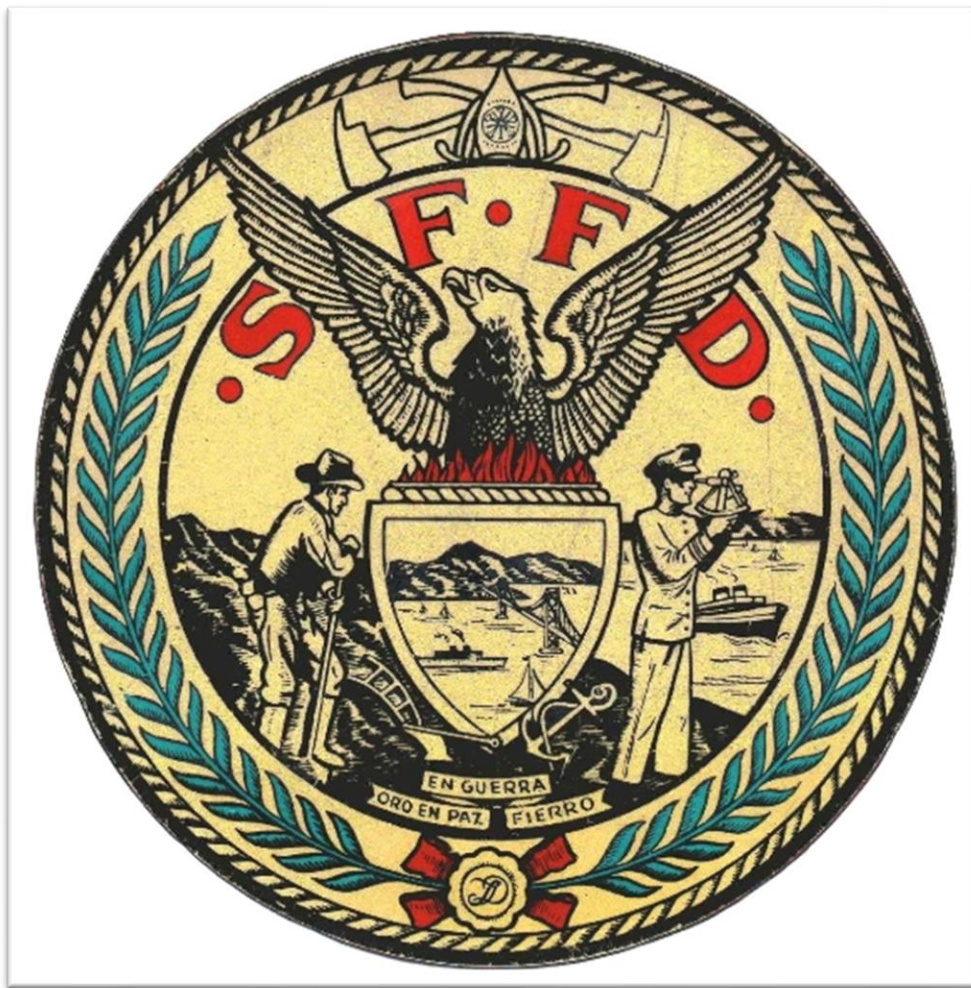

ESER Bond Planning

- The Capital Planning Committee approved the resolution authorizing the proposed 2026 Earthquake Safety and Emergency Response General Obligation Bond in the amount of \$535,000,000 and amended the Capital Plan with no other ESER GO Bonds proposed through March of 2034.

New SFFD Division of Training Development

- Legislation to provide for the vacation of streets, change of zoning and amendment of the bulk height limits was heard at the Land Use and Transportation Committee
- SFFD received the 95% Design Package for the Division of Training.
- A Memorandum of Understanding regarding the SFPUC assets at the site of the new Division of Training was completed.
- SFFD received construction estimates based on the 95% Design Package that exceeds the "Design to Budget." Budget Reconciliation, value engineering and program cuts to follow.
- Public Works reported that as of December 5, 2025 actual spending on the project increased from \$20,708,514 to \$21,537,134

Fire Station 7

- SFFD approved the Public Works assignment of project manager Kathleen O'Day to the Fire Station 7 project.

Water Supply

- Met with representatives of the San Francisco Port to plan for mitigation of hazards present at the fireboat manifolds.
- Attended a presentation by the Coalition for San Francisco Neighborhoods on desalination technologies.
- SFFD attended a workshop hosted by SFPUC on statistical modeling to estimate the demand for firefighting water needs after a significant seismic event.
- SFPUC hosted the quarterly Technical Advisory Committee Meeting and reviewed design information for the Potable Emergency Firefighting Water System (PEFWS).



Station 49

- Cord Reels - City Attorney has not received a response from the contractor.

Network Modernization Project

- Installation of outside fiber optic cable and installation of internal wiring progressed
- Stations 1, 4, 8, 13, 30, 35 (Land and Floating) were migrated to the new network
- Five of nine fiber optic rings are complete
- Project completion is planned for February of 2026
- Migration of the Galaxy card readers is in progress

Neighborhood Fire Stations

- FS 18 Generator Replacement – A site walk was completed, the contractor will be mobilizing in January
- FS 19 Generator Replacement - Procurement delayed until at least Spring of 2026
- FS 19 Window Replacement – Asbestos remediation plan in development

- Station 15 Hose Tower Removal/Replacement
 - The project is on hold. The Planning Commission is consulting on the elimination of the requirement to construct a hose tower façade after demolishing the existing hose tower.
 - Public Works Bureau of Architecture has developed a plan to remove the existing tower above the station roofline.
- Water Intrusion of Fire Stations 2, 17, 24 and 31 – Assessments of the stations have been completed and the consultant is developing reports on the conditions and proposed mitigations.

Fireboat Station 35 (\$50.5M) – Certificate of Final Completion was issued on November 11, 2022.

[M. Rossetto] FS35 Security Gate Enhancement:

- The project is complete and is in financial close-out.



Focused Scope Program (Michael Rossetto, San Francisco Public Works):

Total Funding allocated for the Focused Scope Program is \$21,407,279, approved by SFFD on 8/17/17. Work is complete in 8 out of 9 of the Focused Scope categories comprising Roofing, Apparatus Bay Door Replacements, Exterior Envelope Improvements, Windows, Showers, HVAC/Mechanical, Sidewalk/Slabs, and Security Access Control. Work continues to progress through the last scope category, Generator Replacements.

Emergency Generators:

- **FS 2** – Scope of work: replace existing rooftop generator set, structurally strengthen roof structure to support new fuel tank with capacity for 72-hour run time and provide new fuel fill port and piping to generator.
This project is complete.
- **FS 19** – Scope of work: replace existing generator at grade and replace main electrical panel.
 - The generator load bank lead time has increased, causing a generator delivery date into 2026. The Load bank lead time pushed the anticipated generator ship date to from November 2025 to May 2026, but recent input from the contractor indicates improvement in lead time. The PG&E service agreement is set to expire in February 2026, which will not work with the project schedule due to the generator lead time. The PM submitted a new service agreement application to SFPUC/PG&E. The new service agreement is expected to take approximately 6-8 months to be issued by PG&E, pushing PG&E's involvement to March-May 2026, needed near the onset of on-site construction activities.
- **FS 14** – Scope of work: Redesign of the previous replacement of the existing generator with new rooftop generator, new subgrade fuel fill port at the sidewalk in front of the station, and new fuel piping from sidewalk to generator is underway.
 - SFFD Fire Prevention has approved BOA's AB-005 request to deliver the fuel via hose or hand-carried containers to the rear yard. The project was submitted to DBI for permit in December 2025.

Exterior Envelope:

- **Package 1 (FS 8, 20, 23, 29)** – FS 8, 20, and 29 are complete; On 1/15/21, SFFD requested a hold on FS 23 painting due to other priorities.
- **Package 2 (FS 24, 34)** – This project remains on HOLD initially placed at the request of Capital Planning to provide supplemental funding to the Police TC&FSD project. It is now expected that those funds will be returned to the SFFD for allocation to a priority project, possibly FS24 and/or FS34.
- **FS 2, 17, 24 & 31** Water Intrusion Assessment (Lisa Zhuo, San Francisco Public Works) – The consultant contract was executed in October 2025. Water testing at Fire Stations 17 and 31 are completed, reports are received. Water testing at Fire Station 24 is approximately 80% completed, the consultant requested access above the garage ceiling, this requires BBSR's assistance. BBSR price proposing is approved, we will coordinate scheduling of BBSR's work and proceed to complete water testing and investigative work by the consultant in February 2026.

Fire Station 2 will not be assessed per the direction of SFFD, Fire Station 37 will be assessed instead. Site visits and water testing dates at Fire Station 37 is TBD.

Miscellaneous:

FS35 Security Fence Enhancements, FS17 Boiler Replacement & FS 29 Apparatus Bay Door Replacement were requested as new projects by SFFD in August 2023. These are ranked as the highest priority (most urgent) projects after the Network Modernization project.

- **FS 35** – See Fireboat Station 35 description.
- **FS 17** – Boiler Replacement. Requested to reinstate previously on hold, per SFFD 5/5/25 email. Demolition began in November 2025.
- **FS 29** – Apparatus Bay Door Replacement: completed and is in close-out
- **DOT/FS 7 Railings**: completed and is financially closed.
- **FS 19 Window Replacement** budget was requested by SFFD, per email from 5/5/25. The Planning Department has agreed to allow replacement of the existing wood windows frames with aluminum on the condition that the aluminum profiles are like the existing wood profiles. This will be reviewed as part of the building permit application. An on-site scoping meeting was held in August between BOA, BPM & the BBSR glaziers. A subsequent window and hazardous materials investigation was carried out on 10/15/25. Asbestos was found in caulking samples. Bids are underway for asbestos abatement and lead paint stabilization. The bids will inform the project budget for SFFD approval.

Network Modernization Project (Michael Rossetto, San Francisco Public Works):

As of June 2025, all fire stations have been completed and inspected, excluding station 51 which is under the Jurisdiction of The Presidio Trust who is requiring agreement modification with SFFD to allow the work to proceed. SFFD has been communicating with CAT for the Agreement modification. 9/18/25 SFFD advised DPW that the Presidio Trust will consider the building permit, submitted by DPW in January 2025, was issued by the trust on 12/3/25.

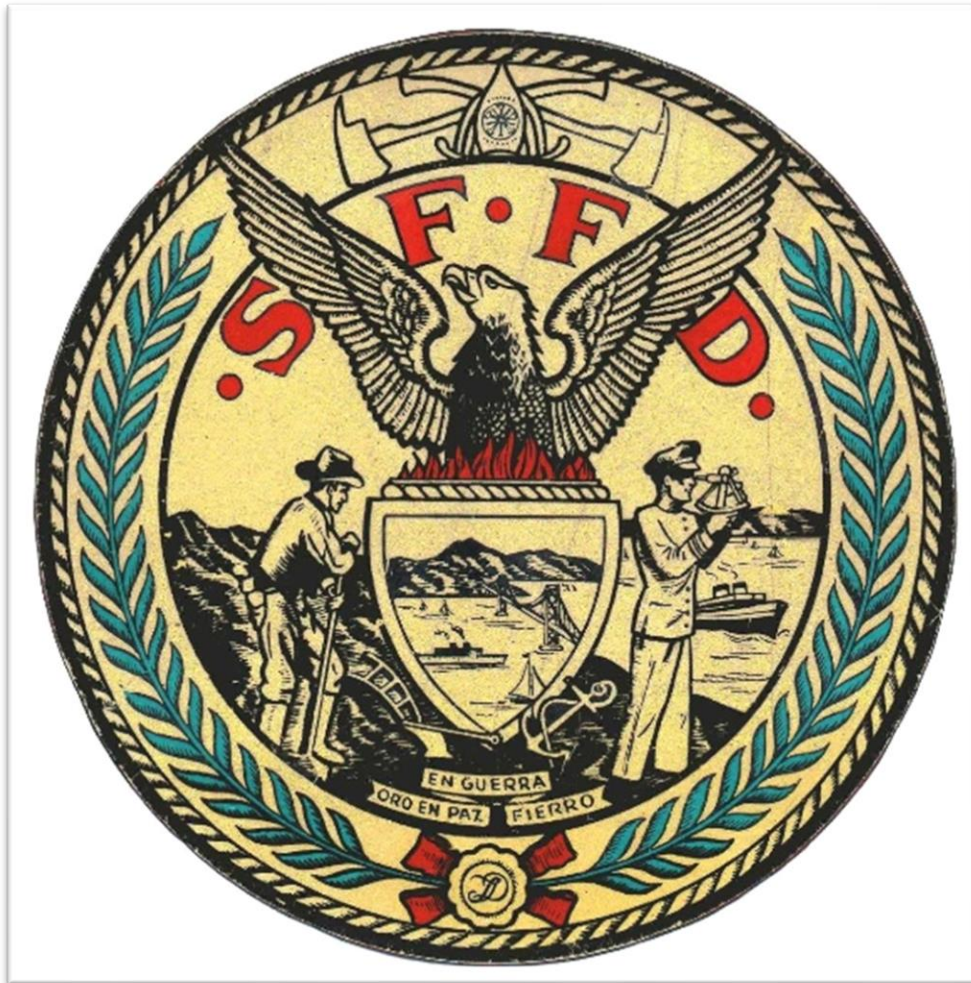

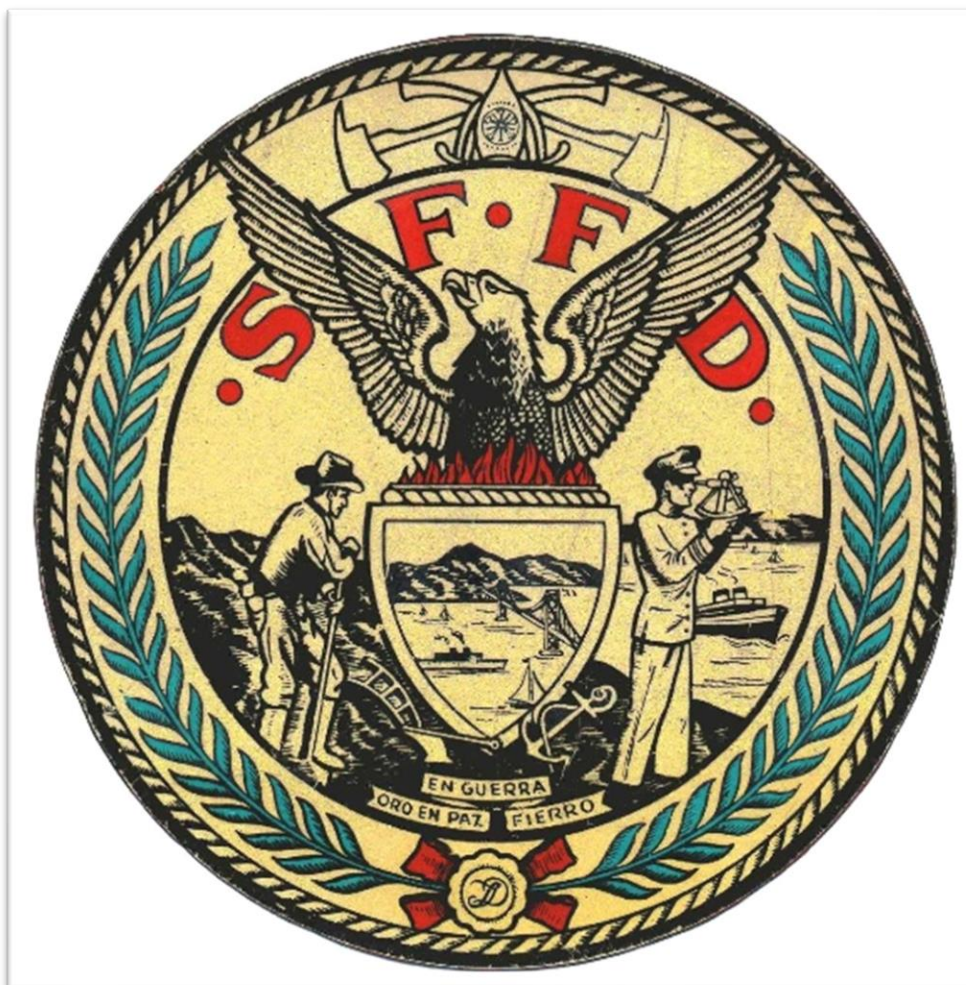

Operations

San Francisco Fire Department's (SFFD) real-time, multi-platform incident transparency approach led by the Public Information Officer Unit. SFFD consistently delivers quick, verified updates during active incidents—fires, rescues, and large emergencies—using concise posts, geo-tagged info, safety messages, and follow-up explanations once the scene is stabilized. This approach illustrates several best practices:

- **Timeliness and accuracy:** Communities increasingly depend on platforms like Citizen and X/Twitter for instant news updates (social media today, 2025). SFFD's quick posts fulfill this need while keeping accuracy and professionalism.
- **Community engagement:** SFFD combines operational details with preparedness content and human stories, following TOC Public Relations' advice to boost public trust through value-driven communication (TOC Public Relations, 2025).
- **Crisis professionalism:** PIO communications consistently demonstrate emotional control in digital spaces, reflecting the emotional management strategies Fitch (2016) identifies as essential to credibility.
- **Effective comment moderation:** SFFD maintains a professional tone even when confronted with criticism or misinformation, demonstrating best practices in online conflict management (How Cops Can Maintain Professionalism on social media, 2025).

TRANSPARENCY IS KEY:

One of the biggest challenges SFFD faces in sustaining real-time transparency is balancing speed with accuracy during rapidly evolving incidents. In the age of instant information, the public expects updates within minutes, yet emergency scenes are dynamic, fluid, and often chaotic. Verifying details before posting requires coordination with incident commanders, field units, dispatch, and partner agencies, and even minor delays can feel long to the public watching an unfolding event online. Additionally, to maintain real-time transparency, the PIO must monitor multiple platforms, respond to media inquiries, gather verified information, and push out timely messaging—all

simultaneously. There is also the challenge of preventing misinformation, which can spread faster than official posts, requiring the PIO team to constantly monitor social media and correct inaccuracies without escalating tensions.

Equipment:

A new vehicle is hopefully in the works for duty response; the older vehicle is maintained daily. A phone rig experienced an equipment break on a personal rig. Standard PIO media rigs and new microphones are needed. The new charging board is helping with equipment checkoffs and location Starlink is fully operational and assists with times of downed internet.

Technology:

Axon Body cam has intermittent upload delays, seeing a possible new alternative. Personal assigned cell phones are being updated by MIS. Co-pilot is being used as an assistant tool with positive results.

Training and Education

Members of the PIO team continue to pursue training opportunities to advance our ability to serve our community. This month, members participated in numerous drills, classes, and continuing education.

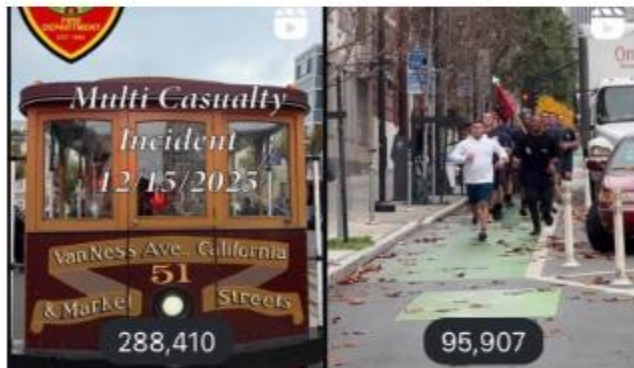
