OPERATIONS REPORT

November 1, 2018 – November 30, 2018

GREATER ALARMS:

There was 1 greater alarm fires during this reporting period at the following location:

2nd Alarm – (11/9/18) 1727 hours, Golden Gate Park Polo Fields, cross street Middle Drive. On 11/9/18 at 1727 hours, E18, T18 and B07 were dispatched to B7565, IC#18131581, to a reported large grass fire near Polo Fields in Golden Gate Park. Upon arrival, the fire had extended into brush and surrounding eucalyptus trees. B07 Kircher struck a full box.

During the initial suppression effort, it was discovered that there was another large grass fire west of their location. B07 struck a 2nd alarm to utilize those units for that fire that was also extending into eucalyptus trees.

Division 2 called two Mini Pumpers en route. Upon Division 2's arrival, the first fire was addressed while the second fire was starting to be addressed by the second alarm companies. Division 2 took command and designated B07 as "East Division" for the first fire, and designated B05 as "West division" for the second fire. Once good water supplies were established good knockdown was achieved, the fire was contained to approximately one acre of vegetation between the two fires. The cause of fire was determined to be suspicious and 4710 was notified. Division 2 believes there were a total of 6 suspicious fires in the park over that 36-hour period. Confirmation of that should be referred to 4710.

Unique obstacles were as follows.

- Water supply in the park was difficult to establish because of hydrant locations and distance to fire. Ultimately, long supply leads were made and shuttling water was also established to prevent further long leads and crossing Lincoln Boulevard with supply lines.
- Companies on this side of town were not equipped with sufficient wildland equipment and hose. Thus managing 3" and 1 3/4" lines and not having wildland hand tools made for an inefficient firefight.

Between the Presidio, Lands End and Golden Gate Park, there was significant vegetation that had been catching fire annually in hard to access areas. Also, with consistent activities and homelessness becoming prevalent in Golden Gate Park, additional wildland equipment would be very helpful. Division 2 strongly recommends that a Mini Pumper be assigned to B07 and stationed at Station 31, and the surrounding companies be equipped with a wildland hose, tools, and PPE. There were no injuries or fatalities. The fire was determined to be incendiary. (Assistant Chief Rex Hale)

After Brisbane Fire was on scene for over 12 hours, the Department took over operations and were able to resolve the incident after a few hours. SFFD was actively present during the entire incident on social media, traditional media with PSA, on air safety and incident updates, as well as working with multi-departments.

EMS-6 represents EMS-6's activities and client contacts. These numbers are representative of the number of client contacts that EMS-6 makes in the course of their shift and activities. These numbers do include repeat callers, so a single client may account for several contacts.

Fire Incidents represents suppression calls to tent encampments. These are not duplicates of Medical Incidents, and these are taken directly from the NFIRS database. The NFIRS includes Codes 1600 and 4000, which designate SPECIAL OUTSIDE FIRE or HAZARDOUS NON-FIRE. These Special Codes contain sub-sets of qualification, which include TENT Call or ENCAMPMENT.

Medical Incidents represents the EMS responses in which the ambulance or ALS Engine crews checked NO IDENTIFIABLE HOME ADDRESS on their charts. This query extracts CAD Incident Numbers, so it eliminates duplicate counts that would result if each response apparatus were considered a unique call. These numbers do include repeat callers, as the query does not key on patient names, so a single client may account for several responses.

Bureau of Fire Investigation Update, Captain Attica Bowden

The number of Open/Active Fire Investigation Reports for November 2018 is 58. The reports include the following types of fires:

- 24 Structure Fires

STATS: During the month of November 2018 BFI responded to 20 incidents. They are as follows: 3 special outside/trash fires, 3 grass fires, 9 structure fires, 3 vehicle fires, 1 homeless tent and 1 portable toilet fire. Though BFI did not respond there were an additional 13 consults with chiefs and officers at active scenes regarding origin and cause.

There was a second alarm fire in Golden Gate park on November 9th and an additional fire just a few hours later. This series of fires was determined to be incendiary and resulted in a person of interest being arrested. The cause of the fire remains under investigation, but at present it does not appear to be suspicious in nature.

On Sunday November 11, 2018, a suspect was arrested for intentionally starting a fire inside of the Target store located at 1830 Ocean Avenue.

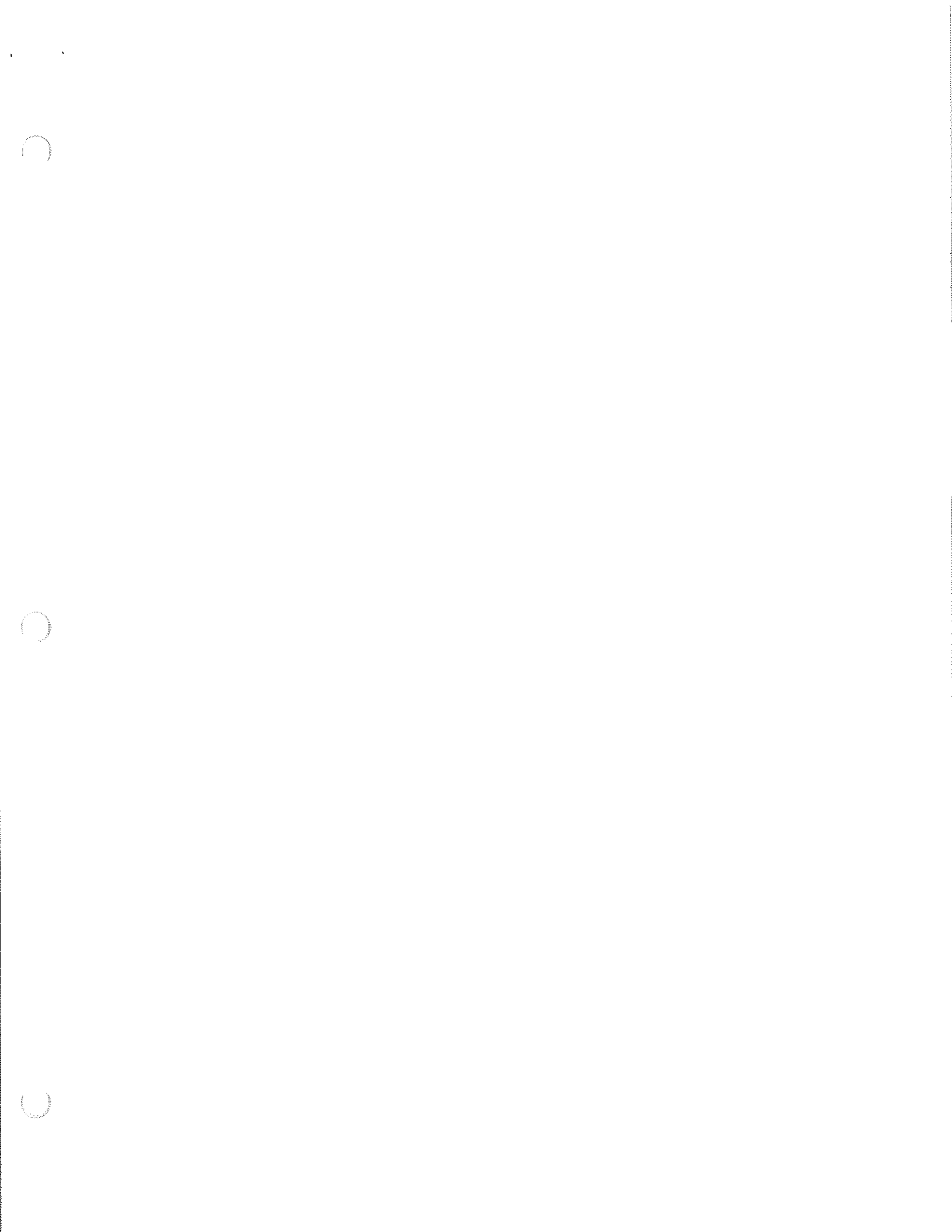
