2. CASE NO. 2015-01: COMMISSION DELIBERATIONS ON PROPOSED FINDINGS OF FACT, AND POSSIBLE APPROVAL OF FINDINGS OF FACT REGARDING COMMISSION'S DECISION ON EMPLOYEE SUSPENSION APPEAL [Action item]

At a Special Meeting of the Fire Commission on July 23, 2015, regarding the above-noted matter, following the evidentiary hearing, the Commission deliberated and decided the member's appeal of a four-day suspension previously imposed by the Chief of Department in the above-noted matter.

The Commission voted to uphold the Chief's recommendation of a 4-day suspension by a unanimous vote of Commissioners present. (4-0; Evans, Covington, Nakajo, Hardeman).

The Commission is now considering proposed Findings of Fact in relation to that decision.

This case may be heard in Closed Session pursuant to Government Code Section 54957(b) and San Francisco Administrative Code Section 67.10(b).
