At a Special Meeting of the Fire Commission on August 27, 2015, regarding the above-noted matter, following the hearing, the Commission upheld the charges of violating San Francisco Fire Department Rules and Regulations Section 3909 – False Reports; Section 3919 – Proper Behavior; Section 3921 – Inattention to Duty; and Section 3923 – Acts Detrimental to the Welfare of the Department; by unanimous vote (Ayes: Evans, Covington, Nakajo, Hardeman, Cleaveland)

Accordingly, the Commission voted to reduce the Chief's recommendation to a 15 day suspension, by a vote of 4-1 (Ayes: Evans, Covington, Nakajo, Cleaveland, Nays: Hardeman).

The Commission also recommended the Chief of Department instruct the member to attend 16 hours of community service and 8 hours of retraining, to include EMS ethics, patient assessment and customer service and non-transport policy documentation.

The Commission is now considering proposed Findings of Fact in relation to that decision.
